COMMITTEE SUBSTITUTE

HOUSE BILL NO. 797

1 AN ACT TO AUTHORIZE THE BOARD OF SUPERVISORS OF UNION COUNTY  
2 TO ADOPT ORDINANCES REGULATING THE RUNNING AT LARGE OF DOGS AND  
3 OTHER DOMESTIC ANIMALS THAT CREATE A NUISANCE OR POSE A THREAT TO  
4 THE HEALTH, SAFETY OR WELFARE OF PERSONS OR OTHER ANIMALS IN THE  
5 COUNTY; TO PRESCRIBE CERTAIN PROVISIONS THAT MUST BE INCLUDED AND  
6 CERTAIN PROVISIONS THAT MAY BE INCLUDED WITHIN ANY SUCH  
7 ORDINANCES; TO PROVIDE THAT NEITHER THE BOARD OF SUPERVISORS OF  
8 UNION COUNTY NOR AN AGENT OR EMPLOYEE OF UNION COUNTY SHALL BE  
9 LIABLE FOR THE INJURY OR DEATH OF ANY DOG OR ANIMAL IF REASONABLE  
10 CARE IS EXERCISED IN CARRYING OUT THE POWERS AUTHORIZED AND DUTIES  
11 REQUIRED UNDER THIS ACT; AND FOR RELATED PURPOSES.

12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

13 **SECTION 1.** (1) The Board of Supervisors of Union County, in  
14 its discretion, by ordinance or ordinances duly adopted and  
15 entered upon its minutes, may regulate the running at large of  
16 dogs and other domestic animals that create a nuisance or pose a  
17 threat to the health, safety or welfare of persons or other  
18 animals in the county.

19 (2) If the board of supervisors adopts an ordinance under  
20 subsection (1) of this section, the ordinance:

21 (a) May authorize the county to employ some person or  
22 persons or to contract with some person, persons or entity as an  
23 agent of the county to capture and impound such animals;

24 (b) Shall require such animals as are captured and  
25 impounded to be provided reasonable, necessary and humane care and  
26 treatment;

27 (c) Shall require that the owners of such animals, if  
28 known, be given reasonable notice of the capture and impoundment  
29 of such animals;

30 (d) May authorize the county to charge and collect from  
31 the owner or person to whom an animal is released the actual

32 expenses incurred by the county in capturing, impounding and  
33 keeping the animal;

34 (e) May authorize any such animal to be humanely  
35 destroyed if after not less than five (5) county work days from  
36 the giving of notice under paragraph (c) of this subsection, the  
37 animal has not been claimed by the owner or, if not claimed by the  
38 owner within such time, has not been released to some other person  
39 willing to assume responsibility for its care and custody; and

40 (f) May contain such other provisions as the board of  
41 supervisors deems necessary or desirable to effectuate the  
42 purposes of this section.

43 (3) Neither the Board of Supervisors of Union County, nor an  
44 agent or employee of Union County shall be liable for any injury  
45 to or death of any dog or animal if reasonable care is exercised  
46 in carrying out the powers authorized and duties required under  
47 this section.

48 **SECTION 2.** This act shall take effect and be in force from  
49 and after its passage.
