## HOUSE BILL NO. 845

AN ACT TO AMEND SECTIONS 63-1-9 AND 63-1-21, MISSISSIPPI CODE OF 1972, TO PROVIDE FOR THE ISSUANCE OF DRIVER TRAINING PERMITS TO PERSONS AT LEAST FOURTEEN AND ONE-HALF YEARS OF AGE; TO INCREASE THE MINIMUM AGE OF PERSONS WHO MAY BE ISSUED TEMPORARY DRIVING PERMITS, INTERMEDIATE LICENSES AND REGULAR DRIVERS' LICENSES; TO REQUIRE AN APPLICANT FOR A MISSISSIPPI DRIVER'S LICENSE WHO HOLDS AN OUT-OF-STATE DRIVER'S LICENSE TO VERIFY COMPLETION OF SIMILAR TRAINING IN THE LICENSING STATE; AND FOR RELATED PURPOSES.

- 9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 10 **SECTION 1.** Section 63-1-9, Mississippi Code of 1972, is
- 11 amended as follows:
- 12 63-1-9. (1) No driver's license, intermediate license or
- 13 temporary learning permit shall be issued pursuant to this
- 14 article:
- 15 (a) To any person under the age of eighteen (18) years
- 16 except as provided in this article.
- 17 (b) To any person whose license to operate a motor
- 18 vehicle on the highways of Mississippi has been previously revoked
- 19 or suspended by this state or any other state and/or territory of
- 20 the United States or the District of Columbia, and such revocation
- 21 or suspension period has not expired.
- 22 (c) To any person who is an habitual drunkard or who is
- 23 addicted to the use of other narcotic drugs.
- 24 (d) To any person who would not be able by reason of
- 25 physical or mental disability, in the opinion of the commissioner
- 26 or other person authorized to grant an operator's license, to
- 27 operate a motor vehicle on the highways with safety. However,
- 28 persons who have one (1) arm or leg, or have arms or legs
- 29 deformed, and have their car provided with mechanical devices
- 30 whereby they are able to drive in a safe manner over the highways,

- 31 if otherwise qualified, shall receive an operator's license the
- 32 same as other persons. Moreover, deafness shall not be a bar to
- 33 obtaining a license.
- 34 (e) To any person who is under the age of seventeen
- 35 (17) years to drive any motor vehicle while in use as a school bus
- 36 for the transportation of pupils to or from school, or to drive
- 37 any motor vehicle while in use as a public or common carrier of
- 38 persons or property.
- 39 (f) To any person as an operator who has previously
- 40 been adjudged to be afflicted with and suffering from any mental
- 41 disability and who has not at time of application been restored to
- 42 mental competency.
- 43 (g) To any unmarried person under the age of eighteen
- 44 (18) years who does not at the time of application present a
- 45 diploma or other certificate of high school graduation or a
- 46 general education development certificate issued to the person in
- 47 this state or any other state, or documentation that the person:
- 48 (i) Is enrolled and making satisfactory progress
- 49 in a course leading to a general education development
- 50 certificate;
- 51 (ii) Is enrolled in school in this state or any
- 52 other state;
- (iii) Is enrolled in a "nonpublic school," as such
- 54 term is defined in Section 37-13-91(2)(i); or
- (iv) Is unable to attend any school program due to
- 56 circumstances deemed acceptable as set out in Section 63-1-10.
- 57 (h) To any person under the age of eighteen (18) years
- 58 who has been convicted under Section 63-11-30.
- 59 (2) All permits and licenses issued on or before June 30,
- 60 2004, shall be valid according to the terms upon which issued.
- 61 From and after July 1, 2004:

62 A driver training permit may be issued to any 63 person who is at least fourteen and one-half (14 1/2) years of age 64 who otherwise meets the requirements of this article. 65 (b) A temporary driving permit may be issued to any 66 person who is at least sixteen (16) years of age who otherwise 67 meets the requirements of this article and who has held a driver training permit for at least twelve (12) months without any 68 69 conviction under Section 63-11-30, or of a moving violation. Any 70 conviction under Section 63-11-30, or of a moving violation shall restart the twelve-month requirement for the holding of a driver 71 72 training permit before an applicant can qualify for a temporary 73 driving permit. 74 (c) An intermediate license may be issued to any person 75 who is at least seventeen (17) years of age who otherwise meets the requirements of this article, who has completed an advanced 76 77 driver's education course of at least forty (40) hours as determined by the Department of Public Safety and who has held a 78 79 temporary driving permit for at least twelve (12) months without any conviction under Section 63-11-30 or of a moving violation. 80 81 Any conviction under Section 63-11-30 or of a moving violation 82 shall restart the twelve-month requirement for the holding of a 83 temporary driving permit before an applicant can qualify for an intermediate license. 84 85 (d) A driver's license may be issued to any person who is at least eighteen (18) years of age who otherwise meets the 86 requirements of this article and who has held an intermediate 87 88 license for at least twelve (12) months without any conviction under Section 63-11-30 or of a moving violation. Any conviction 89 under Section 63-11-30 or of a moving violation shall restart the 90 six-month requirement for the holding of an intermediate license 91 before an applicant can qualify for a driver's license. 92 93 a person who is at least <u>twenty-one (21)</u> years of age who has been 94 issued a temporary driving permit and who has never been convicted

- 95 under Section 63-11-30 or of a moving violation shall not be
- 96 required to have held an intermediate license.
- 97 (e) An applicant for a Mississippi driver's license
- 98 who, at the time of application, is at least eighteen (18) years
- 99 of age and who has held a valid motor vehicle driver's license
- 100 issued by another state for at least six (6) months shall not be
- 101 required to hold a temporary driving permit or an intermediate
- 102 license before being issued a driver's license if the applicant
- 103 verifies that he has completed similar training in the licensing
- 104 state, as determined by the Department of Public Safety.
- 105 (3) The commissioner shall ensure that the temporary driving
- 106 permit, intermediate license and driver's license issued under
- 107 this article are clear, distinct and easily distinguishable from
- 108 one another.
- 109 **SECTION 2.** Section 63-1-21, Mississippi Code of 1972, is
- 110 amended as follows:
- 111 63-1-21. (1) Every applicant for a new or original driver's
- 112 or operator's license, except persons holding an out-of-state
- 113 license, shall first obtain a temporary driving permit upon the
- 114 payment of a fee of One Dollar (\$1.00) to the Department of Public
- 115 Safety and upon the successful completion of the examination
- 116 provided for in Section 63-1-33 and the payment of the fee for
- 117 such examination provided for in Section 63-1-43.
- 118 (2) A driver training permit entitles the holder to drive a
- 119 motor vehicle other than a motorcycle on private property or other
- 120 areas as may be designated by the Department of Public Safety or
- 121 on training areas approved by the department when accompanied by a
- 122 parent, guardian or certified driver's education instructor.
- 123 (3) A temporary driving permit entitles the holder, provided
- 124 the permit is in his immediate possession, to drive a motor
- 125 vehicle other than a motorcycle on the highways of the State of
- 126 Mississippi only when accompanied by a licensed operator who is at
- 127 least thirty (30) years of age and who is actually occupying the

seat beside the driver. A temporary driving permit may be issued

- 129 to any applicant who is at least sixteen (16) years of age.
- 130 temporary driving permit shall be valid for a period of one (1)
- 131 year from the date of issue.
- 132 (4) An intermediate license allows unsupervised driving from
- 133 dawn to dusk. At all other times the intermediate licensee must
- 134 be supervised by a parent, guardian or other person age twenty-one
- (21) years or older who holds a valid driver's license under this 135
- 136 article and who is actually occupying the seat beside the driver.
- 137 (5) The fee for issuance of an intermediate license shall be
- 138 Five Dollars (\$5.00).
- Except as otherwise provided by Section 63-1-6, every 139
- 140 applicant for a restricted motorcycle operator's license or a
- motorcycle endorsement shall first obtain a temporary motorcycle 141
- driving permit upon the payment of a fee of One Dollar (\$1.00) to 142
- 143 the Department of Public Safety, and upon the successful
- 144 completion of the examination provided for in Section 63-1-33, and
- 145 payment of the fee for said examination provided for in Section
- 63-1-43. All applicants for such temporary permit shall (a) be at 146
- 147 least fifteen (15) years of age; (b) operate a motorcycle only
- 148 under the direct supervision of a person at least twenty-one (21)
- 149 years of age who possesses either a valid driver's or operator's
- 150 license with a motorcycle endorsement or a valid restricted
- 151 motorcycle operator's license; (c) be prohibited from transporting
- 152 a passenger on a motorcycle; (d) be prohibited from operating a
- motorcycle upon any controlled access highway; and (e) be 153
- 154 prohibited from operating a motorcycle during the hours of 6:00
- 155 p.m. through 6:00 a.m. Temporary motorcycle driving permits shall
- be valid for the same period of time and may be renewed upon the 156
- 157 same conditions as temporary driving permits issued for vehicles
- 158 other than motorcycles.
- 159 SECTION 3. This act shall take effect and be in force from
- 160 and after July 1, 2004.
