HOUSE BILL NO. 905

AN ACT TO AMEND SECTION 37-9-79, MISSISSIPPI CODE OF 1972, TO 1 2 PROVIDE THAT SCHOOL GUIDANCE COUNSELORS SHALL PROVIDE WRITTEN NOTIFICATION TO ALL STUDENTS ENTERING THE NINTH GRADE AND ALL TRANSFERRING STUDENTS IN GRADES 9 THROUGH 12 OF THE CURRICULUM 3 4 REQUIREMENTS FOR STUDENTS TO RECEIVE TUITION ASSISTANCE; AND FOR 5 6 RELATED PURPOSES. 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: SECTION 1. Section 37-9-79, Mississippi Code of 1972, is 8 9 amended as follows: 10 37-9-79. (1) Beginning with the 2002-2003 school year, the 11 assignment of K-12 School Guidance Counselors to the particular schools within the district shall be at the discretion of the 12 13 local school board with the following restrictions: (a) No individual shall be employed as a school 14 guidance counselor without a minimum of a Master's Degree in 15 Guidance and Counseling, or in an emergency situation, an 16 17 appropriate certification as determined by the Commission on 18 Teacher and Administrator Education, Certification and Licensure and Development; and 19 20 (b) School guidance counselors shall provide the following comprehensive counseling services: 21 22 (i) Academic and personal/social counseling; 23 (ii) Student assessment and assessment counseling; 24 (iii) Career and educational counseling; 25 (iv) Individual and group counseling (large/small); 26 27 (v) Crisis intervention and preventive counseling; 28 (vi) Referrals to community agencies;

(vii) Educational consultations and collaboration 29 30 with teachers, administrators, parents and community leaders; 31 (viii) Educational and career placement services; 32 (ix) Follow-up counseling services; 33 (x) Conflict resolution; and 34 (xi) Other counseling duties or other duties as assigned by the school principal. 35 (c) School guidance counselors shall provide written 36 notification to all students entering the ninth grade and to all 37 students transferring into the public school system in Grades 9 38 39 through 12 of the curriculum requirements for students to receive tuition assistance under Section 37-157-1. 40 School guidance counselors shall abide by the American 41 (2)School Counselor Association Code of Ethics. 42 The State Department of Education may adopt regulations 43 (3) regarding the activities of the school guidance counselor as are 44 not inconsistent with this section. 45

46 **SECTION 2.** This act shall take effect and be in force from 47 and after July 1, 2004.
