HOUSE BILL NO. 1111

- AN ACT TO AMEND SECTION 25-3-36, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT A JUSTICE COURT JUDGE'S SALARY SHALL BE BASED ON THE COUNTY'S POPULATION ACCORDING TO THE LATEST FEDERAL DECENNIAL CENSUS; AND FOR RELATED PURPOSES.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 6 **SECTION 1.** Section 25-3-36, Mississippi Code of 1972, is
- 7 amended as follows:
- 8 25-3-36. (1) From and after October 1, 1998, every justice
- 9 court judge shall receive as full compensation for his or her
- 10 services and in lieu of any and all other fees, costs or
- 11 compensation heretofore authorized for such justice court judge,
- 12 an annual salary based upon the population of his or her county
- 13 according to the latest federal decennial census; however, no
- 14 justice court judge's salary shall be reduced below the salary
- 15 that such justice court judge was receiving immediately before the
- 16 effective date of House Bill No. _____, 2004 Regular Session. The
- 17 amount of which salary shall be determined as follows:
- 18 (a) In counties with a population of more than two
- 19 hundred thousand (200,000), a salary of Forty-six Thousand Two
- 20 Hundred Ninety-nine Dollars (\$46,299.00).

- (3) From and after January 1, 1984, all fees, costs, fines 95 96 and penalties charged and collected in the justice court shall be paid to the clerk of the justice court for deposit, along with 97 98 monies from cash bonds and other monies which have been forfeited 99 in criminal cases, into the general fund of the county as provided 100 in Section 9-11-19; and the clerk of the board of supervisors 101 shall be authorized and empowered, upon approval by the board of 102 supervisors, to make disbursements and withdrawals from the 103 general fund of the county in order to pay any reasonable and 104 necessary expenses incurred in complying with this section, 105 including payment of the salaries of justice court judges as provided by subsection (1) of this section. The provisions of 106 107 this subsection shall not, except as to cash bonds and other 108 monies which have been forfeited in criminal cases, apply to 109 monies required to be deposited in the justice court clerk 110 clearing account as provided in Section 9-11-18, Mississippi Code of 1972. 111
- 112 The salaries provided for in subsection (1) of this section shall be payable monthly by warrant drawn by the clerk of 113 114 the board of supervisors on the general fund of the county; however, the board of supervisors, by resolution duly adopted and 115 116 entered on its minutes, may provide that such salaries shall be paid semimonthly on the first and fifteenth day of each month. Ιf 117 118 a pay date falls on a weekend or legal holiday, salary payments 119 shall be made on the workday immediately preceding the weekend or legal holiday. 120
- 121 (5) Provided, that the salary of any justice court judge 122 shall not be reduced during his term of office as a result of a 123 population change following a federal decennial census.
- (6) Any justice court judge who is unable to attend and hold court by reason of being under suspension by the Commission on Judicial Performance or the Mississippi Supreme Court shall not receive a salary while under such suspension.

128	SECTION 2. The Attorney General of the State of Mississippi
129	shall submit this act, immediately upon approval by the Governor,
130	or upon approval by the Legislature subsequent to a veto, to the
131	Attorney General of the United States or to the United States
132	District Court for the District of Columbia in accordance with the
133	provisions of the Voting Rights Act of 1965, as amended and
