HOUSE BILL NO. 1174

- AN ACT TO AMEND SECTION 37-101-27, MISSISSIPPI CODE OF 1972, TO EXTEND THE DATE BY WHICH THE AYERS SETTLEMENT AGREEMENT MUST BE FINALIZED IN ORDER FOR THE AYERS SETTLEMENT FUND TO BE CREATED IN
- 4 THE STATE TREASURY; AND FOR RELATED PURPOSES.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 6 **SECTION 1.** Section 37-101-27, Mississippi Code of 1972, is
- 7 amended as follows:
- 8 37-101-27. (1) There is created within the Working
- 9 Cash-Stabilization Reserve Fund in the State Treasury a trust to
- 10 be known as the Ayers Endowment Trust, which shall be used as
- 11 provided in this section. On July 1, 1997, Fifteen Million
- 12 Dollars (\$15,000,000.00) in the Working Cash-Stabilization Reserve
- 13 Fund shall be set aside and placed in the Ayers Endowment Trust.
- 14 (2) The principal of the Ayers Endowment Trust shall remain
- 15 inviolate within the Working Cash-Stabilization Reserve Fund, and
- 16 shall be invested in the same manner as the remainder of the
- 17 Working Cash-Stabilization Reserve Fund.
- 18 (3) The interest and income earned from the investment of
- 19 the principal of the Ayers Endowment Trust shall be appropriated
- 20 by the Legislature to the Board of Trustees of State Institutions
- 21 of Higher Learning for the benefit of Jackson State University,
- 22 Alcorn State University and Mississippi Valley State University,
- 23 the historically black institutions of higher learning in
- 24 Mississippi, with one-third (1/3) of the amount of the interest
- 25 and income earned being allocated for the benefit of each of those
- 26 universities. The money allotted for each university shall be
- 27 used for continuing educational enhancement and racial diversity,

- 28 including recruitment of white students and scholarships for white
- 29 applicants.
- 30 (4) The creation of the Ayers Endowment Trust and the
- 31 appropriation of the interest and income for the purposes
- 32 specified in this section shall be to comply with the order of the
- 33 United States District Court in the case of Ayers v. Fordice, 879
- 34 F.Supp. 1419 (N.D. Miss. 1995), with regard to Jackson State
- 35 University and Alcorn State University, and to provide Mississippi
- 36 Valley State University with an equal amount of funding for the
- 37 same purposes as for the other historically black institutions of
- 38 higher learning.
- 39 (5) If the United States District Court for the Northern
- 40 District of Mississippi approves and directs the implementation of
- 41 a settlement agreement in the case of Ayers v. Musgrove (Civil
- 42 Action No. 4:75CV9-B-D, in the United States District Court for
- 43 the Northern District of Mississippi), and if the agreement
- 44 becomes final and effective according to its terms (including, but
- 45 not limited to, the exhaustion of all rights of appeal) before the
- 46 first day of the 2005 Regular Session of the Legislature, there
- 47 shall be created in the State Treasury a fund to be known as the
- 48 Ayers Settlement Fund. Monies deposited into the Ayers Settlement
- 49 Fund under Section 27-103-203(2) shall be appropriated by the
- 50 Legislature to the Board of Trustees of State Institutions of
- 51 Higher Learning for the purpose of establishing a public endowment
- 52 for the benefit of Jackson State University, Alcorn State
- 53 University and Mississippi Valley State University in compliance
- 54 with the settlement agreement.
- 55 (6) If the Ayers Settlement Fund is created under subsection
- 56 (5) of this section, subsection (1) through (4) of this section
- 57 shall be repealed when the Ayers Endowment Trust reaches Zero
- 58 Dollars (\$0.00) in accordance with Section 27-103-203(3).
- 59 **SECTION 2.** This act shall take effect and be in force from
- and after July 1, 2004.
