7	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
8	SECTION 1. Section 65-39-1, Mississippi Code of 1972, is
9	amended as follows:
LO	65-39-1. (1) <u>(a)</u> The Mississippi Transportation Commission
L1	is authorized, subject to the availability of funds in the Gaming
L2	Counties State-Assisted Infrastructure Fund created in Section
L3	65-39-17, to conduct feasibility studies and, pursuant to
L4	information gathered in such studies, select routes and locations,
L5	perform preliminary engineering, acquire necessary right-of-way
L6	and property, construct and/or reconstruct and improve existing or
L7	new highways, roads, streets and bridges, including two-lane,
L8	four-lane and multilane roads (or segments thereof), perform
L9	intersection improvements, provide signal retiring, turnbay
20	extensions, additional interchanges and other traffic
21	modifications, within and approaching those counties in this state
22	where legal gaming is being conducted or is authorized. Any
23	highway, road, street or bridge that is authorized to be
24	constructed, reconstructed or improved shall meet design standards
25	established by the Mississippi Department of Transportation, shall
26	be constructed to bear a load limit of at least eighty thousand

- 32 (b) The Mississippi Transportation Commission is
- 33 authorized to match other federal programs to enhance, construct,
- 34 reconstruct and improve storm drainage systems connected to the
- 35 projects authorized in this section. Such drainage systems shall
- 36 not be a part of the state highway system and shall not be under
- 37 the jurisdiction of the Mississippi Transportation Commission or

- 85 (n) At various locations on and along U.S. Highway 61,
- 86 U.S. Highway 65 and Washington Street, and Canal Street from John
- 87 R. Junkin Drive to Madison Street that connects to D.A. Biglane
- 88 Street, Silver Street, Roth Hill Road and Learned Mill Road and
- 89 the surrounding area in the City of Natchez;
- 90 (o) At various locations on and along U.S. Highway 90

- 92 (p) Mississippi 43/603 beginning where the existing

- 99 (r) U.S. 49 from U.S. 61 west to the Mississippi River

- 101 (s) Subject to the conditions prescribed in subsection
