## HOUSE BILL NO. 1350

AN ACT TO AMEND SECTION 27-19-56.14, MISSISSIPPI CODE OF 1 1972, TO PROVIDE THAT THE DISTINCTIVE LICENSE TAG AUTHORIZED TO BE 2 ISSUED TO A MEMBER OF THE GRAND LODGE OF MISSISSIPPI MAY ALSO BE 3 ISSUED TO THE WIFE, WIDOW, UNMARRIED DAUGHTER OR UNMARRIED SISTER OF SUCH MEMBER; AND FOR RELATED PURPOSES. 4 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: б 7 SECTION 1. Section 27-19-56.14, Mississippi Code of 1972, is amended as follows: 8 9 27-19-56.14. (1) Any owner of a motor vehicle who is a member of the Grand Lodge of Mississippi, Free and Accepted 10 Masons, his wife, widow, unmarried daughter or unmarried sister, 11 upon complying with the motor vehicle laws relating to 12 13 registration and licensing of motor vehicles, and upon payment of 14 the road and bridge privilege taxes, ad valorem taxes and registration fees as prescribed by law for private carriers of 15 16 passengers, pickup trucks and other noncommercial motor vehicles, and upon payment of an additional annual fee in the amount of 17 Thirty Dollars (\$30.00), shall be entitled to a special license 18 19 tag which displays the Freemason emblem and displays the words 20 "Grand Lodge of Mississippi."

(2) The tags shall be of such color and design as the State
Tax Commission shall prescribe subject to the approval of the
Mississippi License Tag Commission.

(3) Application for the special license tags shall be made
to the county tax collector on forms prescribed by the State Tax
Commission. Applicants for such distinctive license tags shall
present to the issuing official documentation from the Grand Lodge
of Mississippi as prescribed by the State Tax Commission showing

29 their membership or relationship to a member in the Grand Lodge of 30 Mississippi. The application and the additional fee, less five 31 percent (5%) thereof to be retained by the tax collector, shall be 32 remitted to the State Tax Commission on a monthly basis as 33 prescribed by the commission. The portion of the additional fee 34 retained by the tax collector shall be deposited into the county 35 general fund.

(4) The special license tag shall be issued for a one-year
 period. The additional annual fee shall be due and payable at the
 time of renewal registration.

39 (5) The State Tax Commission shall deposit all fees into the 40 State Treasury on the day received. At the end of each month, the 41 State Tax Commission shall certify the total fees collected under 42 this section to the State Treasurer who shall distribute such 43 collections as follows:

44 (a) Twenty-five Dollars (\$25.00) of each additional fee
45 collected on special license tags shall be deposited in a special
46 fund hereby created in the State Treasury to the credit of the
47 Grand Lodge of Mississippi. The funds shall be available for
48 expenditure at the discretion of the Grand Lodge of Mississippi.

49 (b) The remainder of each such additional fee shall be
50 deposited to the credit of the State Highway Fund to be expended
51 solely for the repair, maintenance, construction or reconstruction
52 of highways.

53 SECTION 2. This act shall take effect and be in force from 54 and after July 1, 2004.
