## HOUSE CONCURRENT RESOLUTION NO. 98

1 A CONCURRENT RESOLUTION SUSPENDING THE DEADLINES FOR THE  
 2 PURPOSE OF REQUESTING THE DRAFTING, AND THE INTRODUCTION,  
 3 CONSIDERATION AND PASSAGE, OF A BILL ENTITLED "AN ACT TO AMEND  
 4 SECTIONS 23-15-541 AND 23-15-11, MISSISSIPPI CODE OF 1972, TO  
 5 REQUIRE A QUALIFIED ELECTOR TO PRESENT IDENTIFICATION BEFORE  
 6 CASTING A VOTE IN ANY ELECTION; TO AMEND SECTIONS 23-15-627,  
 7 23-15-631, 23-15-637, 23-15-687 AND 23-15-719, MISSISSIPPI CODE OF  
 8 1972, TO AUTHORIZE THE SECRETARY OF STATE TO CREATE RULES AND  
 9 REGULATIONS TO REQUIRE THE USE OF IDENTIFICATION FOR ABSENTEE  
 10 BALLOTS; TO AMEND SECTIONS 23-15-19, 23-15-39, 23-15-47,

20 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE

 23 other provisions imposed by Joint Rule No. 40, are suspended for  
 24 the purpose of requesting the drafting, and the introduction,
