HOUSE CONCURRENT RESOLUTION NO. 104

1 A CONCURRENT RESOLUTION SUSPENDING THE DEADLINES FOR THE
2 PURPOSE OF REQUESTING THE DRAFTING, AND THE INTRODUCTION,
3 CONSIDERATION AND PASSAGE, OF A BILL ENTITLED "AN ACT TO CREATE A
4 SPECIAL FUND IN THE STATE TREASURY TO THE CREDIT OF THE DEPARTMENT
5 OF MENTAL HEALTH FOR THE OPERATION AND MAINTENANCE OF MENTAL
6 HEALTH HOLDING CENTERS AND SPECIALIZED TREATMENT FACILITIES FOR
7 THE SEVERELY EMOTIONALLY DISTURBED ESTABLISHED BY THE DEPARTMENT;
8 TO AMEND SECTION 27-7-901, MISSISSIPPI CODE OF 1972, TO INCREASE
9 THE AMOUNT OF THE TAX UPON AMOUNTS PAID OR CREDITED BY GAMING
10 ESTABLISHMENTS TO THEIR PATRONS; TO REQUIRE THE TAX INCREASE
11 PROVIDED FOR IN THIS ACT TO BE DEPOSITED INTO THE SPECIAL FUND
12 CREATED BY THIS ACT; AND FOR RELATED PURPOSES."

13 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE
14 OF MISSISSIPPI, THE SENATE CONCURRING THEREIN, That the Joint
15 Rules of the House and the Senate, including all the deadlines and
16 other provisions imposed by Joint Rule No. 40, are suspended for
17 the purpose of requesting the drafting, and the introduction,
18 consideration and passage, of a bill entitled "AN ACT TO CREATE A
19 SPECIAL FUND IN THE STATE TREASURY TO THE CREDIT OF THE DEPARTMENT
20 OF MENTAL HEALTH FOR THE OPERATION AND MAINTENANCE OF MENTAL
21 HEALTH HOLDING CENTERS AND SPECIALIZED TREATMENT FACILITIES FOR
22 THE SEVERELY EMOTIONALLY DISTURBED ESTABLISHED BY THE DEPARTMENT;
23 TO AMEND SECTIONS 27-7-901, MISSISSIPPI CODE OF 1972, TO INCREASE
24 THE AMOUNT OF THE TAX UPON AMOUNTS PAID OR CREDITED BY GAMING
25 ESTABLISHMENTS TO THEIR PATRONS; TO REQUIRE THE TAX INCREASE
26 PROVIDED FOR IN THIS ACT TO BE DEPOSITED INTO THE SPECIAL FUND
27 CREATED BY THIS ACT; AND FOR RELATED PURPOSES."
