HOUSE CONCURRENT RESOLUTION NO. 112

1 A CONCURRENT RESOLUTION SUSPENDING THE DEADLINES FOR THE
2 PURPOSE OF REQUESTING THE DRAFTING, AND THE INTRODUCTION,
3 CONSIDERATION AND PASSAGE, OF A BILL ENTITLED "AN ACT TO REPEAL
4 SECTION 27-103-81, MISSISSIPPI CODE OF 1972, WHICH PROVIDES THAT
5 THE WORKING CASH-STABILIZATION RESERVE FUND MAY BE USED TO PROVIDE
6 STATE FUNDS TO PAY WARRANTS DRAWN FOR PAYMENT THAT WILL BE
7 REIMBURSED BY THE FEDERAL GOVERNMENT UNDER A DELAY-OF-DRAWDOWN
8 LETTER OF CREDIT; TO AMEND SECTION 27-103-203, MISSISSIPPI CODE OF
9 1972, TO DELETE THE REQUIREMENT THAT FOUR MILLION DOLLARS IN THE
10 WORKING CASH-STABILIZATION RESERVE FUND SHALL REMAIN AVAILABLE FOR
11 USE UNDER SECTION 27-103-81; AND FOR RELATED PURPOSES."

12 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE
13 OF MISSISSIPPI, THE SENATE CONCURRING THEREIN, That the Joint
14 Rules of the House and the Senate, including all the deadlines and
15 other provisions imposed by Joint Rule No. 40, are suspended for
16 the purpose of requesting the drafting, and the introduction,
17 consideration and passage, of a bill entitled "AN ACT TO REPEAL
18 SECTION 27-103-81, MISSISSIPPI CODE OF 1972, WHICH PROVIDES THAT
19 THE WORKING CASH-STABILIZATION RESERVE FUND MAY BE USED TO PROVIDE
20 STATE FUNDS TO PAY WARRANTS DRAWN FOR PAYMENT THAT WILL BE
21 REIMBURSED BY THE FEDERAL GOVERNMENT UNDER A DELAY-OF-DRAWDOWN
22 LETTER OF CREDIT; TO AMEND SECTION 27-103-203, MISSISSIPPI CODE OF
23 1972, TO DELETE THE REQUIREMENT THAT FOUR MILLION DOLLARS IN THE
