## HOUSE CONCURRENT RESOLUTION NO. 126

1 A CONCURRENT RESOLUTION SUSPENDING THE DEADLINES FOR THE  
 2 PURPOSE OF REQUESTING THE DRAFTING, AND THE INTRODUCTION,  
 3 CONSIDERATION AND PASSAGE, OF A BILL ENTITLED "AN ACT TO AMEND  
 4 SECTION 57-75-5, MISSISSIPPI CODE OF 1972, TO REVISE THE  
 5 DEFINITION OF THE TERM "PROJECT" UNDER THE MISSISSIPPI MAJOR  
 6 ECONOMIC IMPACT ACT; TO AMEND SECTION 57-75-11, MISSISSIPPI CODE  
 7 OF 1972, TO AUTHORIZE THE MISSISSIPPI MAJOR ECONOMIC IMPACT  
 8 AUTHORITY TO PROVIDE GRANT OR LOAN FUNDS TO ENTERPRISES OWNING OR  
 9 OPERATING CERTAIN PROJECTS AND TO GIVE THE AUTHORITY CERTAIN  
 10 POWERS WITH REGARD TO SUCH GRANTS OF LOANS; TO AMEND SECTION  
 11 57-75-15, MISSISSIPPI CODE OF 1972, TO AUTHORIZE THE ISSUANCE OF  
 12 ADDITIONAL STATE GENERAL OBLIGATION BONDS FOR CERTAIN PROJECTS  
 13 UNDER THE MISSISSIPPI MAJOR ECONOMIC IMPACT ACT; AND FOR RELATED  
 14 PURPOSES."

15 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE  
 16 OF MISSISSIPPI, THE SENATE CONCURRING THEREIN, That the Joint  
 17 Rules of the House and the Senate, including all the deadlines and  
 18 other provisions imposed by Joint Rule No. 40, are suspended for  
 19 the purpose of requesting the drafting, and the introduction,  
 20 consideration and passage, of a bill entitled "AN ACT TO AMEND  
 21 SECTION 1-75-5, MISSISSIPPI CODE OF 1972, TO REVISE THE DEFINITION  
 22 OF THE TERM "PROJECT" UNDER THE MISSISSIPPI MAJOR ECONOMIC IMPACT  
 23 ACT; TO AMEND SECTION 57-75-11, MISSISSIPPI CODE OF 1972, TO  
 24 AUTHORIZE THE MISSISSIPPI MAJOR ECONOMIC IMPACT AUTHORITY TO  
 25 PROVIDE GRANT OR LOAN FUNDS TO ENTERPRISES OWNING OR OPERATING  
 26 CERTAIN PROJECTS AND TO GIVE THE AUTHORITY CERTAIN POWERS WITH  
 27 REGARD TO SUCH GRANTS OF LOANS; TO AMEND SECTION 57-75-15,  
 28 MISSISSIPPI CODE OF 1972, TO AUTHORIZE THE ISSUANCE OF ADDITIONAL  
 29 STATE GENERAL OBLIGATION BONDS FOR CERTAIN PROJECTS UNDER THE  
 30 MISSISSIPPI MAJOR ECONOMIC IMPACT ACT; AND FOR RELATED PURPOSES."
