1 2	AN ACT TO CREATE AND EMPOWER THE MISSISSIPPI COMMISSION ON HUMAN RIGHTS; AND FOR RELATED PURPOSES.
3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
4	<b>SECTION 1.</b> (1) (a) There is hereby created the Mississippi
5	Commission on Human Rights. The commission shall be composed of
6	thirteen (13) members to be appointed as follows:

10	Lieutenant Governor.
