### SENATE BILL NO. 2302

AN ACT TO AMEND SECTION 37-19-7, MISSISSIPPI CODE OF 1972, TO 1 2 PROVIDE THAT SCHOOL COUNSELORS QUALIFYING FOR THE SALARY 3 SUPPLEMENT FOR ADVANCED CERTIFICATION AFTER JULY 1, 2004, SHALL BE REQUIRED TO COMPLETE THE MASTER TEACHER CERTIFICATION PROCESS BY 4 5 THE NATIONAL BOARD FOR PROFESSIONAL TEACHING STANDARDS; AND FOR 6 RELATED PURPOSES. 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: SECTION 1. Section 37-19-7, Mississippi Code of 1972, is 8 9 amended as follows: 10 37-19-7. (1) This section shall be known and may be cited as the Mississippi "Teacher Opportunity Program (TOP)." The 11 allowance in the minimum education program and the Mississippi 12 Adequate Education Program for teachers' salaries in each county 13 and separate school district shall be determined and paid in 14 accordance with the scale for teachers' salaries as provided in 15 this subsection. The State Board of Education shall revise the salary scale 104 prescribed above for the 2005-2006 school year to conform to any 105 106 adjustments made to the salary scale in prior fiscal years due to revenue growth over and above five percent (5%). For each one 107 108 percent (1%) that the Sine Die General Fund Revenue Estimate 109 Growth exceeds five percent (5%) for fiscal year 2006, as certified by the Legislative Budget Office to the State Board of 110 Education and subject to specific appropriation therefor by the 111 Legislature, the State Board of Education shall revise the salary 112 113 scale to provide an additional one percent (1%) across the board increase in the base salaries for each type of license. 114

115 It is the intent of the Legislature that any state funds made available for salaries of licensed personnel in excess of the 116 117 funds paid for such salaries for the 1986-1987 school year shall be paid to licensed personnel pursuant to a personnel appraisal 118 and compensation system implemented by the State Board of 119 120 Education. The State Board of Education shall have the authority to adopt and amend rules and regulations as are necessary to 121 122 establish, administer and maintain the system.

(ii) Any licensed school counselor who has met the 264 265 requirements and acquired a National Certified School Counselor 266 (NCSC) endorsement from the National Board of Certified Counselors 267 and who is employed by a local school board or the State Board of Education as a counselor and not as an administrator. 268 Such 269 licensed school counselor shall submit documentation to the State 270 Department of Education that the endorsement was received prior to 271 October 15 in order to be eligible for the full salary supplement in the current school year, or the licensed school counselor shall 272 273 submit such documentation to the State Department of Education 274 prior to February 15 in order to be eligible for a prorated salary 275 supplement beginning with the second term of the school year. 276 Beginning July 1, 2004, any school counselor applying for the salary supplement shall be required to meet the Master Teacher 277 278 certification process established by the National Board for Professional Teaching Standards for school counselors in order to 279 280 receive such salary supplement. Any school counselor receiving 281 the salary supplement prior to July 1, 2004, who maintains an endorsement from the National Board of Certified Counselors, shall 282 283 be allowed to continue receiving such supplement without completing the Master Teacher certification process. In addition, 284 285 any school counselor that has begun the process of meeting the 286 National Certified School Counselor certification process prior to July 1, 2004, shall be eligible to receive the salary supplement 287 288 if the process is completed successfully. 289 (iii) Any licensed speech-language pathologist and 290 audiologist who has met the requirements and acquired a 291 Certificate of Clinical Competence from the American \*SS02/R219. 2\* S. 325 the process of acquiring the certificate or endorsement for an 326 employee, the local school district may agree to directly 327 reimburse the individual or entity for such cost on behalf of the 328 employee.

329 (C) All salary supplements, fringe benefits and process reimbursement authorized under this subsection shall be paid 330 331 directly by the State Department of Education to the local school 332 district and shall be in addition to its minimum education program 333 allotments and not a part thereof in accordance with regulations promulgated by the State Board of Education, and subject to 334 335 appropriation by the Legislature. Local school districts shall not reduce the local supplement paid to any employee receiving 336 337 such salary supplement, and the employee shall receive any local 338 supplement to which employees with similar training and experience 339 otherwise are entitled.

340 The State Department of Education may not pay any (d) 341 process reimbursement to a school district for an employee who 342 does not complete the certification or endorsement process required to be eligible for the certificate or endorsement. 343 Tf an 344 employee for whom such cost has been paid in full or in part by a 345 local school district or private individual or entity fails to 346 complete the certification or endorsement process, the employee 347 shall be liable to the school district or individual or entity for all amounts paid by the school district or individual or entity on 348 349 behalf of that employee toward his or her certificate or 350 endorsement.

351 **SECTION 2.** This act shall take effect and be in force from 352 and after July 1, 2004.
