## SENATE BILL NO. 2344

AN ACT TO STUDY THE ESTABLISHMENT OF A REGIONAL CULTURAL HERITAGE TOURISM PROGRAM WHICH SHALL BE ADMINISTERED BY THE MISSISSIPPI DEVELOPMENT AUTHORITY; TO PROVIDE THAT THE MISSISSIPPI DEVELOPMENT AUTHORITY SHALL STUDY THE IMPLEMENTATION OF A REGIONAL 3 CULTURAL HERITAGE DISTRICT IN THE COUNTIES OF ADAMS, CLAIBORNE, 6 HINDS, JEFFERSON, MADISON, RANKIN, WARREN AND WILKINSON; TO 7 PROVIDE THAT THE DEPARTMENT OF ARCHIVES AND HISTORY SHALL SUBMIT A PLAN REGARDING THE IMPLEMENTATION OF SUCH DISTRICT TO THE LEGISLATURE WITHIN 12 MONTHS AFTER THE EFFECTIVE DATE OF THIS ACT; 8 9 TO PROVIDE FOR THE MEMBERSHIP OF A TASK FORCE TO REVIEW THE 10 DEVELOPMENT OF SUCH PLAN; TO GRANT THE MISSISSIPPI DEVELOPMENT 11 AUTHORITY CERTAIN POWERS WITH REGARD TO ITS DUTIES UNDER THIS ACT; 12 TO REQUIRE THE MISSISSIPPI DEVELOPMENT AUTHORITY TO MAKE 13 RECOMMENDATIONS WITH RESPECT TO OTHER AREAS IN THIS STATE WHERE 14 SUCH DISTRICTS WOULD BE APPROPRIATE AND VIABLE; AND FOR RELATED 15 16 PURPOSES.

- 17 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 18 **SECTION 1.** (1) The purpose of this act is to enact a pilot program to develop a regional cultural heritage tourism district 19 program which shall be administered and staffed by the Mississippi 20
- (2) The regional cultural heritage tourism district pilot 22 23 program shall include Adams, Claiborne, Hinds, Jefferson, Madison,
- Rankin, Warren and Wilkinson Counties. 24

- 25 SECTION 2. Within twelve (12) months after the effective date of this act, the Mississippi Development Authority shall 26 27 develop and submit to the Legislature a plan that:
- 28 (a) Determines the need for a regional cultural heritage tourism district that includes the counties listed in 29 30 Section 1(2) of this act;
- (b) Specifies the goals and objectives for such 31 32 regional cultural heritage tourism district;

- 33 (c) Provides an inventory of the significant cultural
- 34 and historic resources in such regional cultural heritage tourism
- 35 district;
- 36 (d) Identifies legal, regulatory and other constraints
- 37 which must be overcome before meaningful cultural and historic
- 38 development can occur;
- 39 (e) Describes current and potential educational,
- 40 interpretative and recreational programs and projects concerning
- 41 such regional cultural heritage tourism district;
- 42 (f) Provides market research to document the potential
- 43 regional tourism and economic development opportunities resulting
- 44 from the development of such regional cultural heritage tourism
- 45 district;
- 46 (g) Provides an economic assessment of the long- and
- 47 short-term costs and benefits related to the implementation of the
- 48 plan, including an identification of expected sources of funding;
- 49 (h) Describes the specific cost effective techniques or
- 50 methods for the long-term preservation and documentation of the
- 51 significant cultural and historic resources in such regional
- 52 cultural heritage tourism district;
- (i) Describes the public and private organizational
- 54 structure to be utilized for planning, development and management
- of such regional cultural heritage tourism district; and
- 56 (j) Provides strategies and a schedule for the
- 57 planning, development and management of such regional cultural
- 58 heritage tourism district.
- 59 **SECTION 3.** For the purpose of reviewing the development of
- 60 the plan for the regional cultural heritage tourism district,
- 61 there shall be a task force that includes one (1) representative
- 62 appointed by each of the following:
- (a) The boards of supervisors of Adams, Claiborne,
- 64 Hinds, Jefferson, Madison, Rankin, Warren and Wilkinson Counties;

The mayors of each municipality in the proposed 65 (b) 66 regional cultural heritage tourism district; 67 (C) The Executive Director of the Department of 68 Archives and History; 69 The Executive Director of the Mississippi 70 Development Authority; 71 The Executive Director of the Department of (e) 72 Transportation; (f) The Executive Director of the Department of 73 Wildlife, Fisheries and Parks; 74 75 (g)The President of Alcorn State University; 76 The President of Jackson State University; (h) 77 (i) The Director of the Mississippi Arts Commission; 78 The Chairman of the Mississippi River Parkway (j) 79 Commission; 80 (k) The Regional Superintendent of the U.S. Department of Interior, National Park Service; 81 82 Other representatives as the Mississippi Development Authority deems appropriate. 83 84 SECTION 4. For purposes of this act, the Mississippi Development Authority shall be authorized: 85 86 (a) To advocate, coordinate, develop, plan, promote and 87 research cultural and historical attractions, events, properties 88 and services in the proposed regional cultural heritage tourism 89 district; 90 To enter into such contracts and cooperative (b) 91 agreements with the local, state and federal government with agencies of such governments, with private individuals, and with 92 corporations, associations and other organizations, as the 93 94 authority may deem necessary or convenient; and 95 To provide grants to fund the cost of construction,
