5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
6	SECTION 1. Section 27-19-155, Mississippi Code of 1972, is
7	amended as follows:
8	27-19-155. The license or number tag herein provided for
9	shall be purchased by the License Tag Commission, composed of the
LO	Governor, Commissioner of Revenue, Attorney General, and the State
L1	Treasurer, upon competitive bids, after having given three (3)
L2	weeks' notice of the time and place of purchase, by publishing
L3	said notice in at least three (3) newspapers, at least one (1) of
L4	which shall be published in the State of Mississippi, for a period
L5	of three (3) weeks prior to the date of purchase. <u>If the</u>
L6	nonprofit corporation created under the Mississippi Prison
L7	Industries Act of 1990 submits a competitive bid that is not
L8	greater than five percent (5%) above the lowest and best bid, then
L9	the contract shall be awarded to that nonprofit corporation for an
20	initial term of three (3) years. The successful bidder shall
21	enter into a bond with some surety company, authorized to do
22	business in the state, as surety thereon, payable to the State of
23	Mississippi, in a sum equal to the amount of his contract,
24	conditioned for the faithful and prompt carrying out of $\underline{\text{the}}$ bid,
25	and, in the event of the failure to comply with the terms of $\underline{\text{the}}$
26	contract, the amount of $\underline{\text{the}}$ bond shall be forfeited as liquidated
27	damages and may be recovered by the Attorney General in any

29	authorized and empowered to renegotiate any contract entered into
30	for the purchase of license tags in order to obtain any other or
31	additional tags necessitated by the passage of this article.
32	All license tags and numbered plates purchased under the
33	provisions of this article, shall be paid for pursuant to an
34	appropriation to be made for such purposes. All monies received
35	by the State Tax Commission as registration or tag fees, either
36	from the tax collectors, or from licenses issued by the State Tax
37	Commission, shall be paid into the State Treasury on the same day
38	in which such funds are collected by the State Tax Commission.
39	SECTION 2. This act shall take effect and be in force from

and after its passage.
