- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 8 **SECTION 1.** (1) The Mississippi Department of Transportation
- 9 is hereby authorized and directed to cause to be constructed and
- 10 maintained an appropriate memorial in recognition of those who
- 11 have died in motor vehicle accidents when adequate funds for the
- 12 construction thereof are deposited in Motor Vehicle Accident
- 13 Victims Monument Trust Fund herein created.
- 14 (2) The Mississippi Department of Transportation shall:
- 15 (a) Plan and provide for the design, construction and
- 16 dedication of the motor vehicle accident victims monument. The
- 17 actual design and site of the monument shall be selected with the
- 18 approval of the Mississippi Department of Archives and History.
- 19 (b) Solicit private monetary donations for deposit into
- 20 the Motor Vehicle Accident Victims Monument Trust Fund.
- 21 (c) Report to the Legislature by November 15 of each
- 22 year on the progress of such monument. In addition to the report
- 23 required in the preceding sentence, the department shall submit an
- 24 annual report on its activities no later than November of each
- 25 year to the Transportation Committees of both the Mississippi
- 26 House of Representatives and the Mississippi Senate.

- 27 (3) The Mississippi Department of Transportation is hereby
- 28 authorized to accept gifts, grants and donations from individuals
- 29 and organizations, to be deposited in the Motor Vehicle Accident

- 30 Victims Monument Trust Fund which is hereby created in the State
- 31 Treasury. The State Treasurer shall invest all monies in the
- 32 Motor Vehicle Accident Victims Monument Trust Fund which is hereby
- 33 created in the State Treasury. The State Treasurer shall invest
- 34 all monies in the Motor Vehicle Accident Victims Monument Trust
- 35 Fund and any interest earned shall be deposited into the fund.
- 36 All appropriated funds and funds deposited in the Motor Vehicle
- 37 Accident Victims Monument Trust Fund shall be used exclusively for
- 38 the purpose of designing, erecting, maintaining and dedication of
- 39 the monument. Any monies remaining unexpended or unencumbered in
- 40 the fund upon completion of the monument shall be used for
- 41 maintenance of the monument.

- 43 and after July 1, 2004.
