## SENATE BILL NO. 3214

AN ACT TO AUTHORIZE THE CITY COUNCIL OF THE CITY OF GULFPORT, MISSISSIPPI, AND THE BOARD OF SUPERVISORS OF HARRISON COUNTY, MISSISSIPPI, TO INCREASE THE MEMBERSHIP OF THE BOARD OF TRUSTEES 3 4 OF MEMORIAL HOSPITAL AT GULFPORT FROM SEVEN TRUSTEES TO NINE TRUSTEES; TO PROVIDE THAT TWO OF THE NEW TRUSTEES SHALL BE EITHER 5 6 AN ACTIVE MEMBER OF THE MEDICAL STAFF OF THE HOSPITAL OR A FORMER 7 ACTIVE MEMBER ON THE HONORARY STAFF OF THE MEDICAL STAFF OF THE 8 HOSPITAL; AND FOR RELATED PURPOSES.

- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 9
- SECTION 1. (1) The City Council of the City of Gulfport, 10
- 11 Mississippi, and the Board of Supervisors of Harrison County,
- Mississippi, in their discretion, may increase the membership of 12
- the Board of Trustees of Memorial Hospital at Gulfport from seven 13
- (7) trustees to nine (9) trustees, and shall appoint the trustees 14
- as provided in this act. 15
- (2) If the City Council of the City of Gulfport and the 16
- Board of Supervisors of Harrison County increase the membership of 17
- the Board of Trustees of Memorial Hospital at Gulfport to nine (9) 18
- 19 trustees, three (3) of the trustees shall be appointed by the city
- council, three (3) of the trustees shall be appointed by the board 20
- of supervisors, acting for and on behalf of the Gulfport-West 21
- Harrison County Hospital District, and three (3) of the trustees 22
- 23 shall be appointed jointly by the city council and the board of
- supervisors, with two (2) of the jointly appointed trustees being 24
- either an active member of the Medical Staff of Memorial Hospital 25
- at Gulfport or a former active member on the Honorary Staff of the 26

- 31 the two (2) new trustees shall be set by resolutions of the city
- 32 council and the board of supervisors so that the terms of not more
- 33 than two (2) members of the board of trustees will expire in the
- 34 same year. After the expiration of the initial terms of the two
- 35 (2) new trustees, and after the expiration of the terms of the
- 36 current members of the board of trustees, all succeeding trustees
- 37 shall serve for terms of five (5) years.
