## SENATE CONCURRENT RESOLUTION NO. 536

1 A CONCURRENT RESOLUTION COMMENDING AND CONGRATULATING THE

14 Antonio Anderson were selected to play in the All-Star game; and

15 WHEREAS, the Wildcats were superbly coached and inspired this  
16 season by Head Coach Scott Bray and Assistant Coaches Dale Kimble,  
17 Dale Box, Andy Hollinghead and Shaun Walley, who have broadened  
18 the players' knowledge of the game and refined their skills in  
19 execution; and

20 WHEREAS, in addition, Head Coach Scott Bray was named Coach  
21 of the Year by *The Clarion-Ledger* and *The Mississippi Press*; and

22 WHEREAS, the Wildcats have developed a winning and  
23 cooperative spirit and a high degree of sportsmanship, and their  
24 activities and attitude reflect great credit upon the individual  
25 players and their coaches and bring honor to Greene County High  
26 School; and

28 accomplishment of this group of student athletes who have brought  
29 honor to their school, their community and to the State of  
30 Mississippi:
