- 11 of our state's troops; and
- WHEREAS, 170 members of the 1st Battalion, 204th Air Defense
- 13 Artillery, headquartered in Newton, Mississippi, with units in
- 14 Morton, Bay Springs, Forest and Decatur, were called to active
- 15 duty on May 1, 2003, for service in our Nation's Capitol; and
- 16 WHEREAS, upon mobilization, these soldiers trained admirably
- 17 at Ft. Bliss, Texas, exceeding all training standards on
- 18 active-component precision marksmanship ranges; and
- 19 WHEREAS, these soldiers were subsequently deployed to provide
- 20 air defense for our National Capitol Region; and
- 21 WHEREAS, the Battalion was the first National Guard Battalion
- 22 selected for such a critical mission; and
- 23 WHEREAS, they have been recognized repeatedly for excellence
- 24 during their deployment; and
- WHEREAS, the 1st Battalion, 204th Air Defense Artillery, was
- 26 the first Army National Guard unit in the nation to receive the

- 36 WHEREAS, the 1st Battalion, 204th Air Defense Artillery,
- 37 consistently surpasses all training requirements due to the
- 38 professionalism and dedication of its soldiers; and
- 39 WHEREAS, the 1st Battalion, 204th Air Defense Artillery,
- 40 remains one of the most critical combat multipliers in the
- 41 Mississippi Army National Guard; and
- WHEREAS, the 1st Battalion, 204th Air Defense Artillery, will
- 43 continue its heritage as one of the best trained fighting forces
- 44 in the Mississippi Army National Guard and will proudly protect
- 45 life and property in the State of Mississippi and defend our
- 46 nation's freedoms; and
- WHEREAS, the dedication of these soldiers of the 1st
- 48 Battalion, 204th Air Defense Artillery, in providing valuable
- 49 assistance to the United States Military, has helped instill
- 50 confidence in the general public that they are committed to this
- 51 nation's security; and
- 52 WHEREAS, the Mississippi Legislature finds it most
- 53 appropriate to recognize and commend the diligence of these
- 54 outstanding Mississippians for the devotion to their state and
- 55 nation to secure and insure peace for all:
