## **REPORT OF CONFERENCE COMMITTEE**

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

H. B. No. 1714: Appropriation; Oil and Gas Board.

We, therefore, respectfully submit the following report and recommendation:

- 1. That the Senate recede from its Amendment No. 1.
- 2. That the House and Senate adopt the following amendment:

31 With the funds herein appropriated, it is the intention of 32 the Legislature that it shall be the agency's responsibility to make certain that funds required to be appropriated for "Personal 33 34 Services" for Fiscal Year 2006 do not exceed Fiscal Year 2005 35 funds appropriated for that purpose, unless programs or positions are added to the agency's Fiscal Year 2006 budget by the 36 37 Mississippi Legislature. Based on data provided by the Legislative Budget Office, the State Personnel Board shall 38 39 determine and publish the projected annual cost to fully fund all 40 appropriated positions in compliance with the provisions of this 41 It shall be the responsibility of the agency head to insure act. 42 that no single personnel action increases this projected annual cost and/or the Fiscal Year 2005 appropriation for "Personal 43 44 Services" when annualized, with the exception of escalated funds. 45 If, at the time the agency takes any action to change "Personal 46 Services," the State Personnel Board determines that the agency has taken an action which would cause the agency to exceed this 47 projected annual cost or the Fiscal Year 2005 "Personal Services" 48 49 appropriated level, when annualized, then only those actions which 50 reduce the projected annual cost and/or the appropriation 51 requirement will be processed by the State Personnel Board until such time as the requirements of this provision are met. 52

Any transfers or escalations shall be made in accordance with the terms, conditions and procedures established by law or allowable under the terms set forth within this act. The State Personnel Board shall not escalate positions without written approval from the Department of Finance and Administration. The Department of Finance and Administration shall not provide written

(H)AP (S)AP A1/2 59 approval to escalate any funds for salaries and/or positions 60 without proof of availability of new or additional funds above the 61 appropriated level.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

66 SECTION 3. It is the intention of the Legislature that the 67 State Oil and Gas Board shall maintain complete accounting and personnel records related to the expenditure of all funds 68 69 appropriated under this act and that such records shall be in the 70 same format and level of detail as maintained for Fiscal Year 71 2004. It is further the intention of the Legislature that the 72 agency's budget request for Fiscal Year 2006 shall be submitted to the Joint Legislative Budget Committee in a format and level of 73 74 detail comparable to the format and level of detail provided during the Fiscal Year 2005 budget request process. 75

76 **SECTION 4.** With the funds provided herein, it is the 77 intention of the Legislature that the State Oil and Gas Board 78 purchase liability insurance.

79 SECTION 5. The money herein appropriated shall be paid by 80 the State Treasurer out of any money in the State Treasury to the 81 credit of the proper fund or funds as set forth in this act, upon 82 warrants issued by the State Fiscal Officer; and the State Fiscal 83 Officer shall issue his warrants upon requisitions signed by the

84 proper person, officer or officers, in the manner provided by law.

85 SECTION 6. This act shall take effect and be in force from

86 and after July 1, 2004.
