

## REPORT OF CONFERENCE COMMITTEE

MADAM PRESIDENT AND MR. SPEAKER:

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

S. B. No. 2623: Distinctive license tag; authorize for various organizations and revise certain existing tags.

We, therefore, respectfully submit the following report and recommendation:

1. That the House recede from its Amendment No. 1.
2. That the Senate and House adopt the following amendment:

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

129            **SECTION 1.** (1) Any owner of a motor vehicle, who is a  
130 resident of this state, upon complying with the motor vehicle laws  
131 relating to registration and licensing of motor vehicles, and upon  
132 payment of the road and bridge privilege taxes, ad valorem taxes  
133 and registration fees as prescribed by law for private carriers of  
134 passengers, pickup trucks and other noncommercial motor vehicles,  
135 and upon payment of an additional annual fee in the amount  
136 provided in subsection (3) of this section, shall be issued a  
137 special license tag for each motor vehicle registered in his name  
138 identifying such person as a supporter of the National Rifle  
139 Association of America. The distinctive license tags so issued  
140 shall be of such color and design as the State Tax Commission,  
141 with the advice of the National Rifle Association of America, may  
142 prescribe, and shall consist of such letters or numbers, or both,  
143 as may be necessary to distinguish each license tag.

144            (2) Application for the distinctive license tags authorized  
145 by this section shall be made to the county tax collector on forms  
146 prescribed by the State Tax Commission. The application and the  
147 additional fee imposed under subsection (3) of this section, less  
148 Two Dollars (\$2.00) thereof to be retained by the tax collector,  
149 shall be remitted to the State Tax Commission on a monthly basis

150 as prescribed by the commission. The portion of the additional  
151 fee retained by the tax collector shall be deposited into the  
152 county general fund.

153 (3) Beginning with any registration year commencing on or  
154 after July 1, 2004, any person applying for a distinctive license  
155 tag under this section shall pay an additional fee in the amount  
156 of Thirty Dollars (\$30.00) for each distinctive license tag  
157 applied for under this section, which shall be in addition to all  
158 other taxes and fees. The additional fee paid shall be for a  
159 period of time to run concurrent with the vehicle's established  
160 license tag year. The additional fee is due and payable at the  
161 time the original application is made for a distinctive license  
162 tag under this section and thereafter annually at the time of  
163 renewal registration as long as the owner retains the distinctive  
164 license tag. If the owner does not wish to retain the distinctive  
165 license tag, he must surrender it to the local county tax  
166 collector.

167 (4) The State Tax Commission shall deposit all fees into the  
168 State Treasury on the day collected. At the end of each month,  
169 the State Tax Commission shall certify to the State Treasurer the  
170 total fees collected under this section from the issuance of the  
171 distinctive license tags issued under this section. The State  
172 Treasurer shall distribute such collections as follows:

173 (a) Twenty-four Dollars (\$24.00) of each additional fee  
174 collected on distinctive license tags issued pursuant to this  
175 section shall be disbursed to the NRA Foundation State Fund  
176 Account for Mississippi to be used for projects that qualify under  
177 Section 501(c)(3) of the Internal Revenue Service Code, including,  
178 but not restricted to, hunter education, firearms safety courses,  
179 marksmanship training and wildlife conservation.

180 (b) One Dollar (\$1.00) of each additional fee collected  
181 on distinctive license tags issued pursuant to this section shall

182 be deposited into the Mississippi Fire Fighter's Memorial Burn  
183 Center Fund created pursuant to Section 7-9-70.

184 (c) Two Dollars (\$2.00) of each additional fee  
185 collected on distinctive license tags issued pursuant to this  
186 section shall be deposited to the credit of the State Highway Fund  
187 to be expended solely for the repair, maintenance, construction or  
188 reconstruction of highways.

189 (d) One Dollar (\$1.00) of each additional fee collected  
190 on distinctive license tags issued pursuant to this section shall  
191 be deposited to the credit of the special fund created in Section  
192 27-19-44.2.

193 (5) A regular license tag must be properly displayed as  
194 required by law until replaced by a distinctive license tag under  
195 this section. The regular license tag must be surrendered to the  
196 tax collector upon issuance of the distinctive license tag under  
197 this section. The tax collector shall issue month and year decals  
198 for each distinctive license tag issued under this section, which  
199 will expire the same month and year as the regular license tag.

200 (6) In the case of loss or theft of a distinctive license  
201 tag issued under this section, the owner may make application and  
202 affidavit for a replacement distinctive license tag as provided by  
203 Section 27-19-37. The fee for a replacement distinctive license  
204 tag shall be Ten Dollars (\$10.00). The tax collector receiving  
205 such application and affidavit shall be entitled to retain and  
206 deposit into the county general fund five percent (5%) of the fee  
207 for such replacement license tag and the remainder shall be  
208 distributed proportionately in the same manner as funds from the  
209 sale of regular distinctive license tags issued under this  
210 section.

211 **SECTION 2.** (1) Any owner of a motor vehicle who is a  
212 resident of this state, upon payment of the road and bridge  
213 privilege taxes, ad valorem taxes and registration fees as

214 prescribed by law for private carriers of passengers, pickup  
215 trucks and other noncommercial motor vehicles, and upon payment of  
216 an additional fee in the amount provided in subsection (3) of this  
217 section, shall be issued a distinctive license tag for each motor  
218 vehicle registered in his name identifying such person as a  
219 supporter of the Blair E. Batson Hospital for Children. The  
220 distinctive license tags so issued shall be of such color and  
221 design as the State Tax Commission, with the advice of the Friends  
222 of Children's Hospital, may prescribe and shall consist of such  
223 letters or numbers, or both, as may be necessary to distinguish  
224 each license tag.

225 (2) Application for the distinctive license tags authorized  
226 by this section shall be made to the county tax collector on forms  
227 prescribed by the State Tax Commission. The application and the  
228 additional fee imposed under subsection (3) of this section, less  
229 Two Dollars (\$2.00) to be retained by the tax collector, shall be  
230 remitted to the State Tax Commission on a monthly basis as  
231 prescribed by the commission. The portion of the additional fee  
232 retained by the tax collector shall be deposited into the county  
233 general fund.

234 (3) Beginning with any registration year commencing on or  
235 after July 1, 2004, any person applying for a distinctive license  
236 tag under this section shall pay an additional fee in the amount  
237 of Thirty Dollars (\$30.00) for each distinctive license tag  
238 applied for under this section, which shall be in addition to all  
239 other taxes and fees. The additional fee paid shall be for a  
240 period of time to run concurrent with the vehicle's established  
241 license tag year. The additional fee is due and payable at the  
242 time the original application is made for a distinctive license  
243 tag under this section and thereafter annually at the time of  
244 renewal registration as long as the owner retains the distinctive  
245 license tag. If the owner does not wish to retain the distinctive

246 license tag, he must surrender it to the local county tax  
247 collector.

248 (4) The State Tax Commission shall deposit all fees into the  
249 State Treasury on the day collected. At the end of each month,  
250 the State Tax Commission shall certify the total fees collected  
251 under this section to the State Treasurer who shall distribute  
252 such collections as follows:

253 (a) Twenty-four Dollars (\$24.00) of each additional fee  
254 collected on distinctive license tags issued pursuant to this  
255 section shall be distributed to the Friends of Children's  
256 Hospital.

257 (b) One Dollar (\$1.00) of each additional fee collected  
258 on distinctive license tags issued pursuant to this section shall  
259 be deposited into the Mississippi Fire Fighter's Memorial Burn  
260 Center Fund created pursuant to Section 7-9-70.

261 (c) Two Dollars (\$2.00) of each additional fee  
262 collected on distinctive license tags issued pursuant to this  
263 section shall be deposited to the credit of the State Highway Fund  
264 to be expended solely for the repair, maintenance, construction or  
265 reconstruction of highways.

266 (d) One Dollar (\$1.00) of each additional fee collected  
267 on distinctive license tags issued pursuant to this section shall  
268 be deposited to the credit of the special fund created in Section  
269 27-19-44.2.

270 (5) A regular license tag must be properly displayed as  
271 required by law until replaced by a distinctive license tag under  
272 this section. The regular license tag must be surrendered to the  
273 tax collector upon issuance of the distinctive license tag under  
274 this section. The tax collector shall issue up to two (2) license  
275 decals for each distinctive license tag issued under this section,  
276 which will expire the same month and year as the regular license  
277 tag.

278 (6) In the case of loss or theft of a distinctive license  
279 tag issued under this section, the owner may make application and  
280 affidavit for a replacement distinctive license tag as provided by  
281 Section 27-19-37. The fee for a replacement distinctive license  
282 tag shall be Ten Dollars (\$10.00). The tax collector receiving  
283 such application and affidavit shall be entitled to retain and  
284 deposit into the county general fund five percent (5%) of the fee  
285 for such replacement license tag and the remainder shall be  
286 distributed in the same manner as funds from the sale of regular  
287 distinctive license tags issued under this section.

288 **SECTION 3.** (1) Any owner of a motor vehicle, who is a  
289 resident of this state, upon complying with the motor vehicle laws  
290 relating to registration and licensing of motor vehicles, and upon  
291 payment of the road and bridge privilege taxes, ad valorem taxes  
292 and registration fees as prescribed by law for private carriers of  
293 passengers, pickup trucks and other noncommercial motor vehicles,  
294 and upon payment of an additional annual fee in the amount  
295 provided in subsection (3) of this section, shall be issued a  
296 special down syndrome awareness license tag for each motor vehicle  
297 registered in his name. The distinctive license tags so issued  
298 shall be of such color and design as the State Tax Commission,  
299 with the advice of the Central Mississippi Down Syndrome Society,  
300 may prescribe, and shall consist of, such letters or numbers, or  
301 both, as may be necessary to distinguish each license tag.

302 (2) Application for the distinctive license tags authorized  
303 by this section shall be made to the county tax collector on forms  
304 prescribed by the State Tax Commission. The application and the  
305 additional fee imposed under subsection (3) of this section, less  
306 Two Dollars (\$2.00) thereof to be retained by the tax collector,  
307 shall be remitted to the State Tax Commission on a monthly basis  
308 as prescribed by the commission. The portion of the additional

309 fee retained by the tax collector shall be deposited into the  
310 county general fund.

311 (3) Beginning with any registration year commencing on or  
312 after July 1, 2004, any person applying for a distinctive license  
313 tag under this section shall pay an additional fee in the amount  
314 of Thirty Dollars (\$30.00) for each distinctive license tag

334 Syndrome Society.

335 (b) One Dollar (\$1.00) of each additional fee collected  
336 on distinctive license tags issued pursuant to this section shall  
337 be deposited into the Mississippi Fire Fighter's Memorial Burn  
338 Center Fund created pursuant to Section 7-9-70.

339 (c) Two Dollars (\$2.00) of each additional fee  
340 collected on distinctive license tags issued pursuant to this

341 section shall be deposited to the credit of the State Highway Fund  
342 to be expended solely for the repair, maintenance, construction or  
343 reconstruction of highways.

344 (d) One Dollar (\$1.00) of each additional fee collected  
345 on distinctive license tags issued pursuant to this section shall  
346 be deposited to the credit of the special fund created in Section  
347 27-19-44.2.

348 (5) A regular license tag must be properly displayed as  
349 required by law until replaced by a distinctive license tag under

376 shall be of such color and design as the State Tax Commission,  
377 with the advice of the Central Mississippi Steel Magnolia  
378 Affiliate and the North Mississippi Affiliate of the Susan G.  
379 Komen Breast Cancer Foundation, may prescribe, and shall consist  
380 of, such letters or numbers, or both, as may be necessary to  
381 distinguish each license tag.

382 (2) Application for the distinctive license tags authorized  
383 by this section shall be made to the county tax collector on forms  
384 prescribed by the State Tax Commission. The application and the  
385 additional fee imposed under subsection (3) of this section, less  
386 Two Dollars (\$2.00) thereof to be retained by the tax collector,  
387 shall be remitted to the State Tax Commission on a monthly basis  
388 as prescribed by the commission. The portion of the additional  
389 fee retained by the tax collector shall be deposited into the  
390 county general fund.

391 (3) Beginning with any registration year commencing on or  
392 after July 1, 2004, any person applying for a distinctive license

415 (ii) Twelve Dollars (\$12.00) of each additional  
416 fee collected on distinctive license tags issued pursuant to this  
417 section shall be disbursed to the North Mississippi Affiliate of  
418 the Susan G. Komen Breast Cancer Foundation.

419 (b) One Dollar (\$1.00) of each additional fee collected  
420 on distinctive license tags issued pursuant to this section shall  
421 be deposited into the Mississippi Fire Fighter's Memorial Burn  
422 Center Fund created pursuant to Section 7-9-70.

423 (c) Two Dollars (\$2.00) of each additional fee  
424 collected on distinctive license tags issued pursuant to this  
425 section shall be deposited to the credit of the State Highway Fund  
426 to be expended solely for the repair, maintenance, construction or  
427 reconstruction of highways.

428 (d) One Dollar (\$1.00) of each additional fee collected  
429 on distinctive license tags issued pursuant to this section shall  
430 be deposited to the credit of the special fund created in Section  
431 27-19-44.2.

432 (5) A regular license tag must be properly displayed as  
433 required by law until replaced by a distinctive license tag under

451 the motor vehicle laws relating to registration and licensing of  
452 motor vehicles, and upon payment of the road and bridge privilege  
453 taxes, ad valorem taxes and registration fees as prescribed by law  
454 for private carriers of passengers, pickup trucks and other  
455 noncommercial motor vehicles, and upon payment of an additional  
456 annual fee in the amount provided in subsection (3) of this  
457 section, shall be entitled to a distinctive license tag that  
458 demonstrates their appreciation of blues music. The tags shall be  
459 of such color and design as the State Tax Commission prescribes  
460 subject to the approval of the Mississippi License Tag Commission;  
461 however, each tag shall display the words "Mississippi, Home of  
462 the Blues" and shall consist of such letters or numbers, or both,  
463 as may be necessary to distinguish each license tag.

464 (2) Application for the distinctive license tags shall be  
465 made to the county tax collector on forms prescribed by the State  
466 Tax Commission. The application and the additional fee imposed  
467 under subsection (3) of this section, less Two Dollars (\$2.00)  
468 thereof to be retained by the tax collector, shall be remitted to

469 the State Tax Commission on a monthly basis as prescribed by the  
470 commission. The portion of the additional fee retained by the tax  
471 collector shall be deposited into the county general fund.

472 (3) Beginning with any registration year commencing on or  
473 after July 1, 2004, any person applying for a distinctive license  
474 tag under this section shall pay an additional fee in the amount  
475 of Thirty Dollars (\$30.00) for each distinctive license tag  
476 applied for under this section, which shall be in addition to all  
477 other taxes and fees. The additional fee paid shall be for a  
478 period of time to run concurrent with the vehicle's established  
479 license tag year. The additional fee is due and payable at the  
480 time the original application is made for a distinctive license  
481 tag under this section and thereafter annually at the time of

496 on distinctive license tags issued pursuant to this section shall  
497 be deposited into the Mississippi Fire Fighter's Memorial Burn  
498 Center Fund created pursuant to Section 7-9-70.

499 (c) Two Dollars (\$2.00) of each additional fee  
500 collected on distinctive license tags issued pursuant to this

501 section shall be deposited to the credit of the State Highway Fund  
502 to be expended solely for the repair, maintenance, construction or  
503 reconstruction of highways.

504 (d) One Dollar (\$1.00) of each additional fee collected  
505 on distinctive license tags issued pursuant to this section shall  
506 be deposited to the credit of the special fund created in Section  
507 27-19-44.2.

508 (5) A regular license tag must be properly displayed as  
509 required by law until replaced by a distinctive license tag under  
510 this section. The regular license tag must be surrendered to the  
511 tax collector upon issuance of the distinctive license tag under  
512 this section. The tax collector shall issue up to two (2) license  
513 decals for each distinctive license tag issued under this section,  
514 which will expire the same month and year as the regular license  
515 tag.

516 (6) In the case of loss or theft of a distinctive license  
517 tag issued under this section, the owner may make application and  
518 affidavit for a replacement distinctive license tag as provided by  
519 Section 27-19-37. The fee for a replacement distinctive license  
520 tag shall be Ten Dollars (\$10.00). The tax collector receiving  
521 such application and affidavit shall be entitled to retain and  
522 deposit into the county general fund five percent (5%) of the fee  
523 for such replacement license tag and the remainder shall be  
524 distributed in the same manner as funds from the sale of regular  
525 distinctive license tags issued under this section.

526 (7) There is established in the State Treasury a special  
527 fund to be known as the Blues Heritage Fund which shall consist of  
528 monies required to be deposited therein under subsection (4) of  
529 this section. Monies in the special fund shall be appropriated by  
530 the Legislature for projects that preserve and promote  
531 Mississippi's blues music heritage. Unexpended amounts remaining  
532 in the special fund at the end of the fiscal year shall not lapse

533 into the State General Fund, and any interest earned or investment  
534 earnings on amounts in the special fund shall be deposited to the  
535 credit of the special fund.

536         **SECTION 6.** (1) Any owner of a motor vehicle who is a  
537 resident of this state, upon payment of the road and bridge  
538 privilege taxes, ad valorem taxes and registration fees as

546 State Tax Commission, with the advice of the Delta Waterfowl  
547 Foundation, may prescribe and shall consist of such letters or  
548 numbers, or both, as may be necessary to distinguish each license  
549 tag.

550         (2) Application for the distinctive license tags authorized  
551 by this section shall be made to the county tax collector on forms  
552 prescribed by the State Tax Commission. The application and the  
553 additional fee imposed under subsection (3) of this section, less  
554 Two Dollars (\$2.00) to be retained by the tax collector, shall be  
555 remitted to the State Tax Commission on a monthly basis as  
556 prescribed by the commission. The portion of the additional fee  
557 retained by the tax collector shall be deposited into the county  
558 general fund.

559         (3) Beginning with any registration year commencing on or  
560 after July 1, 2004, any person applying for a distinctive license  
561 tag under this section shall pay an additional fee in the amount

583 be deposited into the Mississippi Fire Fighter's Memorial Burn

1059 Center Fund created pursuant to Section 7-9-70.

1060 (c) Two Dollars (\$2.00) of each additional fee  
1061 collected on distinctive license tags issued pursuant to this  
1062 section shall be deposited to the credit of the State Highway Fund  
1063 to be expended solely for the repair, maintenance, construction or  
1064 reconstruction of highways.

1065 (d) One Dollar (\$1.00) of each additional fee collected  
1066 on distinctive license tags issued pursuant to this section shall  
1067 be deposited to the credit of the special fund created in Section  
1068 27-19-44.2.

1069 (5) A regular license tag must be properly displayed as  
1070 required by law until replaced by a distinctive license tag under  
1071 this section. The regular license tag must be surrendered to the  
1072 tax collector upon issuance of the distinctive license tag under  
1073 this section. The tax collector shall issue month and year decals

1074 for each distinctive license tag issued under this section, which  
1075 will expire the same month and year as the regular license tag.

1076 (6) In the case of loss or theft of a distinctive license  
1077 tag issued under this section, the owner may make application and  
1078 affidavit for a replacement distinctive license tag as provided by  
1079 Section 27-19-37. The fee for a replacement distinctive license

1181 as may be necessary to distinguish each license tag.

1182 (2) Application for the distinctive license tags authorized  
1183 by this section shall be made to the county tax collector on forms  
1184 prescribed by the State Tax Commission. The application and the  
1185 additional fee imposed under subsection (3) of this section, less  
1186 Two Dollars (\$2.00) thereof to be retained by the tax collector,  
1187 shall be remitted to the State Tax Commission on a monthly basis

1223 reconstruction of highways.

1224 (d) One Dollar (\$1.00) of each additional fee collected  
1225 on distinctive license tags issued pursuant to this section shall  
1226 be deposited to the credit of the special fund created in Section  
1227 27-19-44.2.

1228 (5) A regular license tag must be properly displayed as  
1229 required by law until replaced by a distinctive license tag under

1261 (2) Application for the distinctive license tags authorized  
1262 by this section shall be made to the county tax collector on forms  
1263 prescribed by the State Tax Commission. The application and the  
1264 additional fee imposed under subsection (3) of this section, less

1265 Two Dollars (\$2.00) thereof to be retained by the tax collector,  
1266 shall be remitted to the State Tax Commission on a monthly basis  
1267 as prescribed by the commission. The portion of the additional  
1268 fee retained by the tax collector shall be deposited into the  
1269 county general fund.

1270 (3) Beginning with any registration year commencing on or

1301 reconstruction of highways.

1302 (d) One Dollar (\$1.00) of each additional fee collected  
1303 on distinctive license tags issued pursuant to this section shall  
1304 be deposited to the credit of the special fund created in Section  
1305 27-19-44.2.

1306 (5) A regular license tag must be properly displayed as  
1307 required by law until replaced by a distinctive license tag under  
1308 this section. The regular license tag must be surrendered to the  
1309 tax collector upon issuance of the distinctive license tag under  
1310 this section. The tax collector shall issue month and year decals  
1311 for each distinctive license tag issued under this section, which  
1312 will expire the same month and year as the regular license tag.

1313 (6) In the case of loss or theft of a distinctive license  
1314 tag issued under this section, the owner may make application and  
1315 affidavit for a replacement distinctive license tag as provided by  
1316 Section 27-19-37. The fee for a replacement distinctive license  
1317 tag shall be Ten Dollars (\$10.00). The tax collector receiving  
1318 such application and affidavit shall be entitled to retain and

1324 **SECTION 16.** (1) Any owner of a motor vehicle who is a duly  
1325 sworn law enforcement officer employed by or in the service of the  
1326 state, a county, a municipality or other political subdivision of  
1327 the state, or who is a retired law enforcement officer who is a  
1328 resident of this state, and who was wounded in the line of duty,

1329 or any owner of a motor vehicle who is a fire fighter, including a  
1330 career fire fighter, a volunteer fire fighter or an industrial  
1331 fire fighter, employed by or in the service of the state, a  
1332 county, a municipality or other political subdivision of the  
1333 state, or who is a retired fire fighter who is a resident of this  
1334 state, and who was wounded in the line of duty, is privileged to  
1335 obtain not more than two (2) distinctive motor vehicle license  
1336 tags identifying him as a law enforcement officer or fire fighter,  
1337 or as a retired law enforcement officer or fire fighter, who was  
1338 wounded in the line of duty. The distinctive tag for law  
1339 enforcement officers shall be of a color and design as may be  
1340 agreed upon by the Executive Committee of the Mississippi Law  
1341 Enforcement Officer's Association, the Legislative Committee of  
1342 the Mississippi Sheriff's Association, the Executive Board of the  
1343 Police Chiefs Association and the State Tax Commission. The  
1344 distinctive tag for fire fighters shall be of a color and design  
1345 as may be agreed upon by the Executive Committee of the  
1346 Mississippi Fire Fighters Association and the State Tax  
1347 Commission. Both of such distinctive tags shall consist of such  
1348 letters or numbers, or both, as may be necessary to distinguish  
1349 each license tag and, in the discretion of the State Tax  
1350 Commission, may display the county name.

1351 (2) The distinctive license tags shall be prepared by the  
1352 State Tax Commission and shall be issued through the tax  
1353 collectors of the counties in the same manner as are other motor  
1354 vehicle license tags. The surviving spouse of a deceased person  
1355 who was issued a distinctive license tag under this section shall  
1356 be entitled to apply for or retain one (1) such license tag and  
1357 may continue annually to renew registration for such distinctive  
1358 motor vehicle license tag for as long as the spouse remains  
1359 unmarried. At the time of application or renewal registration, a  
1360 surviving spouse who desires to retain such distinctive tag shall

1361 file with the county tax collector a sworn statement that the  
1362 spouse is unmarried. An applicant for a distinctive license tag  
1363 under this section shall present to the issuing official written  
1364 proof that the applicant is a law enforcement officer or fire  
1365 fighter, or is a retired law enforcement officer or fire fighter,  
1366 who was wounded in the line of duty.

1367 (3) The distinctive license tags issued under this section  
1368 shall be used only upon a personally or jointly owned private  
1369 passenger vehicle (to include station wagons, recreational motor  
1370 vehicles and pickup trucks) registered in the name, or jointly in  
1371 the name, of the person applying, and when issued to such person  
1372 shall be used upon the vehicle for which issued in lieu of the  
1373 standard license tag normally issued for such vehicle.

1374 (4) The distinctive license tags shall not be transferable  
1375 between motor vehicle owners. If the owner of a vehicle bearing a  
1376 distinctive license tag sells, trades, exchanges or otherwise  
1377 disposes of the vehicle, the tag shall be retained by the owner  
1378 and returned to the tax collector.

1379 **SECTION 17.** Section 27-19-44.4, Mississippi Code of 1972, is  
1380 amended as follows:

1381 27-19-44.4. (1) Notwithstanding any other provision of law  
1382 to the contrary, beginning with any registration year commencing  
1383 on or after January 1, 2004, an additional fee of One Dollar  
1384 (\$1.00) is imposed for any distinctive or special license tag or  
1385 plate authorized under this chapter regardless of whether such a  
1386 distinctive or special license tag or plate was authorized before  
1387 or after the effective date of this act. The proceeds collected  
1388 from the additional fee imposed under this section shall be  
1389 deposited into the special fund created under Section  
1390 27-19-56.69(8).



1391           (2) The fee imposed under this section shall be in addition  
1392 to any other fee imposed under this chapter for a distinctive or  
1393 special license tag or plate.

1394           (3) The provisions of this section shall not apply to  
1395 distinctive or special license tags or plates:

1396           (a) Which are issued under Section 27-19-46, 27-19-51,  
1397 27-19-53, 27-19-54, 27-19-56.5, 27-19-56.12, 27-19-56.13,  
1398 27-19-56.33, 27-19-56.36, 27-19-56.38, 27-19-56.42, 27-19-56.48,  
1399 27-19-56.49, 27-19-56.50, 27-19-56.51, 27-19-56.62, 27-19-56.79,  
1400 27-19-56.85 or 27-19-169; or

1401           (b) For which no additional fee is required to be paid.

1402           **SECTION 18.** Section 27-19-53, Mississippi Code of 1972, is  
1403 amended as follows:

1404           27-19-53. (1) Any legal resident of the State of  
1405 Mississippi who is a veteran of service in the Armed Forces of the  
1406 United States, and who is rated as having one hundred percent  
1407 (100%) permanent service-connected disability by the Veterans'  
1408 Administration is privileged to purchase annually under this  
1409 subsection one (1) motor vehicle license plate or tag in his or  
1410 her county of legal residence, for the sum of One Dollar (\$1.00)  
1411 in total cost, regardless of make or model of motor vehicle. The  
1412 registration year of such motor vehicle shall commence the first  
1413 day of the month in which application for registration is made, as  
1414 provided in Section 27-19-31.

1415           (a) Not more than one (1) such motor vehicle license  
1416 plate or tag shall be issued under this subsection to each such  
1417 qualified veteran.

1418           (b) This section pertains only to taxes or plates for  
1419 private passenger motor vehicles or pickup trucks.

1420           (c) Proof of ownership of a particular motor vehicle  
1421 for which a license plate or tag is requested must be shown at  
1422 time of application for such plate or tag.

1423 (d) Vehicles owned by such veterans are \* \* \* exempt  
1424 under this subsection from all ad valorem and privilege taxes;  
1425 however, the surviving spouse of a deceased person who was issued  
1426 a license plate or tag under this subsection shall be entitled to  
1427 apply for or retain a license tag issued under this subsection and  
1428 may continue annually to renew registration for one (1) motor  
1429 vehicle license plate or tag under this subsection for as long as  
1430 the spouse remains unmarried. At the time of application or  
1431 renewal registration, a surviving spouse who desires to retain the  
1432 distinctive plate or tag issued under this subsection shall file  
1433 with the county tax collector a sworn statement that the spouse is  
1434 unmarried. Any such vehicle when so registered shall be exempt  
1435 from all ad valorem and privilege taxes.

1436 (2) Any person who is entitled to obtain a license tag under  
1437 subsection (1) of this section may be issued one (1) additional  
1438 such license tag for any other vehicle registered in his or her  
1439 name upon payment of the road and bridge privilege taxes, ad  
1440 valorem taxes and registration fees as otherwise prescribed by law  
1441 for the particular vehicle.

1442 (3) The State Tax Commission is directed to furnish each  
1443 veteran obtaining a license tag under this section an emblem,  
1444 which the veteran shall attach securely to the tag, showing that  
1445 the tag was issued to a disabled American veteran.

1446 (4) A license issued under this section shall not be  
1447 transferable to any other person.

1448 (5) Any person evading or violating any of the provisions of  
1449 this section, or attempting to secure benefits under this section  
1450 to which he is not entitled, shall be guilty of a misdemeanor and,  
1451 upon conviction, shall be fined not less than \* \* \* One Thousand  
1452 Dollars (\$1,000.00).

1453 **SECTION 19.** Section 27-19-54, Mississippi Code of 1972, is  
1454 amended as follows:

1455           27-19-54. (1) Any legal resident of the State of  
1456 Mississippi who was a prisoner of war or who is a recipient of the  
1457 Congressional Medal of Honor is privileged to obtain one (1) motor  
1458 vehicle license plate or tag on an annual basis in his county of  
1459 legal residence. The registration year of such motor vehicle  
1460 shall commence the first day of the month in which application for  
1461 registration is made, as provided in Section 27-19-31, Mississippi  
1462 Code of 1972.

1463           (2) This section pertains only to tags or plates for private  
1464 passenger motor vehicles or pickup trucks.

1465           (3) Proof of ownership of each particular motor vehicle for  
1466 which a license plate or tag is requested and proof that the owner  
1467 thereof is a former prisoner of war or a recipient of the  
1468 Congressional Medal of Honor must be shown at time of application  
1469 for such plate or tag. A certificate from the State Veterans  
1470 Affairs Board stating that said individual is a former prisoner of  
1471 war or a recipient of the Congressional Medal of Honor shall be  
1472 sufficient proof.

1473           (4) Vehicles owned by such former prisoners of war, a  
1474 recipient of the Congressional Medal of Honor or the unmarried  
1475 surviving spouse of any such person are hereby exempt from all  
1476 motor vehicle registration fees and privilege taxes.

1477           (5) The State Tax Commission is directed to furnish to the  
1478 tax collector of each county a sufficient number of distinctive  
1479 motor vehicle license plates or tags which shall be of such color  
1480 and design as the State Tax Commission shall prescribe subject to  
1481 the approval of the Mississippi License Tag Commission and in  
1482 accordance with the provisions of Section 27-19-41. However, such  
1483 distinctive plates or tags shall bear and include the words  
1484 "Ex-POW."

1485           (6) A license issued under this section shall not be  
1486 transferable to any other person; however, the surviving spouse of

1487 a deceased person who was issued a license plate or tag under this  
1488 section shall be entitled to apply for or retain a license issued  
1489 under this section and may continue annually to renew registration  
1490 for one (1) motor vehicle license plate or tag under this section  
1491 for as long as the spouse remains unmarried. At the time of  
1492 application or renewal registration, a surviving spouse who  
1493 desires to retain the distinctive plate or tag issued under this  
1494 section shall file with the county tax collector a sworn statement  
1495 that the spouse is unmarried.

1496 (7) Any person evading or violating any of the provisions of  
1497 this section, or attempting to secure benefits under this section  
1498 to which he is not entitled, shall be guilty of a misdemeanor and,  
1499 upon conviction, shall be fined not less than \* \* \* One Thousand  
1500 Dollars (\$1,000.00) or by imprisonment in the county jail for not  
1501 less than six (6) months, or both.

1502 (8) As used in this section, the term "prisoner of war"  
1503 means any regularly appointed, enrolled, enlisted or inducted  
1504 member of the military or naval forces of the United States who  
1505 was held as a prisoner of war for any period of time by any  
1506 government of any nation with which the United States has been at  
1507 war; and it also means any regularly appointed, enrolled, enlisted  
1508 or inducted member of the Armed Forces of the United States who  
1509 was held as a prisoner of war for any period of time subsequent to  
1510 June 25, 1950, by any hostile force with which the Armed Forces of  
1511 the United States were actually engaged in armed conflict  
1512 subsequent to such date and prior to August 21, 1954, or any  
1513 person (military or civilian) assigned to duty on the U.S.S.  
1514 Pueblo who was captured by the military forces of North Korea on  
1515 January 23, 1968, and thereafter held prisoner by the government  
1516 of North Korea for any period of time ending on or before December  
1517 23, 1968, except any person who, at any time, voluntarily,  
1518 knowingly and without duress, gave aid to or collaborated with or

1519 in any manner served any such hostile force; and it also means any  
1520 regularly appointed, enrolled, enlisted or inducted member of the  
1521 Armed Forces of the United States who was held as a prisoner of  
1522 war for any period of time during the Vietnam Conflict by any  
1523 force hostile to the United States, except any such member who, at  
1524 any time, voluntarily, knowingly and without duress, gave aid to  
1525 or collaborated with, or in any manner served, such hostile force.  
1526 The term "Vietnam Conflict" relates to the period beginning  
1527 February 28, 1961, and ending on such date as shall thereafter be  
1528 determined by presidential proclamation or concurrent resolution  
1529 of the Congress.

1530       **SECTION 20.** Section 27-19-56.5, Mississippi Code of 1972, is  
1531 amended as follows:

1532       27-19-56.5. (1) In recognition of the patriotic service  
1533 rendered by Mississippians who survived the attack on Pearl Harbor  
1534 and by Mississippians who are recipients of the Purple Heart  
1535 Medal, any such person is privileged to obtain one (1) distinctive  
1536 motor vehicle license plate or tag identifying him as a Pearl  
1537 Harbor survivor or not more than two (2) distinctive motor vehicle  
1538 license plates or tags identifying him as a Purple Heart Medal  
1539 recipient. The distinctive plates or tags shall be of a color and  
1540 design designated by the State Tax Commission.

1541       (2) The distinctive license plates shall be prepared by the  
1542 State Tax Commission and shall be issued through the tax  
1543 collectors of the counties in the same manner as are other motor  
1544 vehicle license plates or tags. A tag fee of Fifteen Dollars  
1545 (\$15.00), in addition to all other taxes and fees, shall be  
1546 collected by the tax collector for the Pearl Harbor distinctive  
1547 tag. The first distinctive tag issued to Purple Heart Medal  
1548 recipients under the provisions of this section shall be exempt  
1549 from ad valorem taxes, privilege taxes and all other taxes and  
1550 fees. There shall be no exemption from ad valorem taxes,

1551 privilege taxes or other taxes and fees for the issuance of a  
1552 second distinctive tag to Purple Heart Medal recipients. However,  
1553 the surviving spouse of a deceased person who was issued a Purple  
1554 Heart Medal distinctive license plate or tag under this section  
1555 shall be entitled to apply for or retain one (1) such license tag  
1556 and may continue annually to renew registration for such  
1557 distinctive motor vehicle license plate or tag for as long as the  
1558 spouse remains unmarried. At the time of application or renewal  
1559 registration, a surviving spouse who desires to retain such  
1560 distinctive plate or tag shall file with the county tax collector  
1561 a sworn statement that the spouse is unmarried, and any such  
1562 vehicle when so registered shall be exempt from ad valorem taxes,  
1563 privilege taxes and all other taxes and fees. The tax collector  
1564 shall monthly forward the additional fee of Fifteen Dollars  
1565 (\$15.00) charged for issuance of a Pearl Harbor distinctive tag to  
1566 the State Tax Commission which shall deposit such fee to the  
1567 credit of the State General Fund. An applicant for a distinctive  
1568 tag under this section shall present to the issuing official  
1569 either (a) written proof that the applicant is an honorably  
1570 discharged former member of one (1) of the Armed Forces of the  
1571 United States and, while serving in the Armed Forces of the United  
1572 States, was present during the attack on the island of Oahu,  
1573 Territory of Hawaii, on December 7, 1941, between the hours of  
1574 7:55 a.m. and 9:45 a.m., Hawaii time, or (b) written proof that  
1575 the applicant is a Purple Heart Medal recipient. The distinctive  
1576 license plates or tags so issued shall be used only upon a  
1577 personally or jointly owned private passenger vehicle (to include  
1578 station wagons, recreational motor vehicles and pickup trucks)  
1579 registered in the name, or jointly in the name, of the person  
1580 making application therefor, and when issued to such person shall  
1581 be used upon the vehicle for which issued in lieu of the standard  
1582 license plate or license tag normally issued for such vehicle.

1583       (3) The distinctive license plates shall not be transferable  
1584 between motor vehicle owners; and in the event the owner of a  
1585 vehicle bearing a distinctive plate shall sell, trade, exchange or  
1586 otherwise dispose of the vehicle, such plate shall be retained by  
1587 such owner and returned to the tax collector.

1588       (4) A vehicle that displays a distinctive license plate  
1589 issued under this section may park free of charge in any state  
1590 parking space or state parking facility when the person to whom  
1591 the license plate was issued is operating or occupying the  
1592 vehicle.

1593       (5) Any person evading or violating any of the provisions of  
1594 this section, or attempting to secure benefits under this section  
1595 to which he is not entitled, shall be guilty of a misdemeanor and,  
1596 upon conviction, shall be fined not less than One Thousand Dollars  
1597 (\$1,000.00) or imprisoned in the county jail for not less than six  
1598 (6) months, or both.

1599       **SECTION 21.** Section 27-19-56.7, Mississippi Code of 1972, is  
1600 amended as follows:

1601       27-19-56.7. (1) Beginning with any registration year  
1602 commencing on or after July 1, 2004, owners of motor vehicles upon  
1603 complying with the motor vehicle laws relating to registration and  
1604 licensing of motor vehicles, and upon payment of the road and  
1605 bridge privilege taxes, ad valorem taxes and registration fees as  
1606 prescribed by law for private carriers of passengers, pickup  
1607 trucks and other noncommercial motor vehicles, and upon payment of  
1608 an additional annual fee in the amount of Fifty Dollars (\$50.00),  
1609 shall be issued a special license tag which displays the emblem of  
1610 the public junior college or community college of his choice  
1611 located in this state.

1612       (2) Each junior college and community college shall design  
1613 the emblem which shall be displayed on the special license tag.

1614 The emblem shall be affixed during the production of the license  
1615 tag.

1616 (3) Application for the special license tags shall be made  
1617 to the county tax collector on forms prescribed by the State Tax  
1618 Commission. The application and the additional fee, less five  
1619 percent (5%) thereof to be retained by the tax collector, shall be  
1620 remitted to the State Tax Commission on a monthly basis as  
1621 prescribed by the commission. The portion of the additional fee  
1622 retained by the tax collector shall be deposited into the county  
1623 general fund.

1624 (4) The special license tag shall be issued for a one-year  
1625 period. The additional annual fee shall be due and payable at the  
1626 time of renewal registration.

1627 (5) The State Tax Commission shall deposit all fees into the  
1628 State Treasury on the day received. At the end of each month, the  
1629 State Tax Commission shall certify the total fees collected under  
1630 this section to the State Treasurer who shall distribute such  
1631 collections as follows:

1632 (a) Thirty-two Dollars and Fifty Cents (\$32.50) of each  
1633 additional fee collected on special license tags shall be  
1634 deposited in a special fund hereby created in the State Treasury  
1635 to the credit of the public junior college or community college  
1636 named on the special license tag. The funds shall be available  
1637 for expenditure at the discretion of the public junior college or  
1638 community college.

1639 (b) One Dollar (\$1.00) of each additional fee collected  
1640 on special license tags shall be deposited into the Mississippi  
1641 Fire Fighter's Memorial Burn Center Fund created pursuant to  
1642 Section 7-9-70.

1643 (c) The remainder of each such additional fee shall be  
1644 deposited to the credit of the State Highway Fund to be expended



1645 solely for the repair, maintenance, construction or reconstruction  
1646 of highways.

1647 (6) In order for a license tag for a community or junior  
1648 college to be prepared and issued by the State Tax Commission,  
1649 the provisions of Section 27-19-44(2) shall be satisfied prior to  
1650 July 1, 2007.

1651 **SECTION 22.** Section 27-19-56.14, Mississippi Code of 1972,  
1652 is amended as follows:

1653 27-19-56.14. (1) Any owner of a motor vehicle who is a  
1654 member of the Grand Lodge of Mississippi, Free and Accepted  
1655 Masons, his wife, widow, unmarried daughter or unmarried sister,  
1656 upon complying with the motor vehicle laws relating to  
1657 registration and licensing of motor vehicles, and upon payment of  
1658 the road and bridge privilege taxes, ad valorem taxes and  
1659 registration fees as prescribed by law for private carriers of  
1660 passengers, pickup trucks and other noncommercial motor vehicles,  
1661 and upon payment of an additional annual fee in the amount of  
1662 Thirty Dollars (\$30.00), shall be entitled to a special license  
1663 tag which displays the Freemason emblem and displays the words  
1664 "Grand Lodge of Mississippi."

1665 (2) The tags shall be of such color and design as the State  
1666 Tax Commission shall prescribe subject to the approval of the  
1667 Mississippi License Tag Commission.

1668 (3) Application for the special license tags shall be made  
1669 to the county tax collector on forms prescribed by the State Tax  
1670 Commission. Applicants for such distinctive license tags shall  
1671 present to the issuing official documentation from the Grand Lodge  
1672 of Mississippi as prescribed by the State Tax Commission showing  
1673 their membership or relationship to a member in the Grand Lodge of  
1674 Mississippi. The application and the additional fee, less five  
1675 percent (5%) thereof to be retained by the tax collector, shall be  
1676 remitted to the State Tax Commission on a monthly basis as

1677 prescribed by the commission. The portion of the additional fee  
1678 retained by the tax collector shall be deposited into the county  
1679 general fund.

1680 (4) The special license tag shall be issued for a one-year  
1681 period. The additional annual fee shall be due and payable at the  
1682 time of renewal registration.

1683 (5) The State Tax Commission shall deposit all fees into the  
1684 State Treasury on the day received. At the end of each month, the  
1685 State Tax Commission shall certify the total fees collected under  
1686 this section to the State Treasurer who shall distribute such  
1687 collections as follows:

1688 (a) Twenty-five Dollars (\$25.00) of each additional fee  
1689 collected on special license tags shall be deposited in a special  
1690 fund hereby created in the State Treasury to the credit of the  
1691 Grand Lodge of Mississippi. The funds shall be available for  
1692 expenditure at the discretion of the Grand Lodge of Mississippi.

1693 (b) The remainder of each such additional fee shall be  
1694 deposited to the credit of the State Highway Fund to be expended  
1695 solely for the repair, maintenance, construction or reconstruction  
1696 of highways.

1697 **SECTION 23.** Section 27-19-56.16, Mississippi Code of 1972,  
1698 is amended as follows:

1699 27-19-56.16. (1) From and after July 1, 2004, any owner of  
1700 a motor vehicle who is a resident of this state, upon payment of  
1701 the road and bridge privilege taxes, ad valorem taxes and  
1702 registration fees as prescribed by law for private carriers of  
1703 passengers, pickup trucks and other noncommercial motor vehicles,  
1704 and upon payment of an additional fee in the amount provided in  
1705 subsection (3) of this section, shall be issued a distinctive  
1706 license tag for each motor vehicle registered in his name  
1707 identifying such person as a supporter of the Mississippi  
1708 Commission for Volunteer Service. The distinctive license tags so

1709 issued shall be of such color and design as the State Tax  
1710 Commission, with the advice of the Mississippi Commission on  
1711 Volunteer Service, may prescribe and shall consist of such letters  
1712 or numbers, or both, as may be necessary to distinguish each  
1713 license tag.

1714 (2) Application for the distinctive license tags authorized  
1715 by this section shall be made to the county tax collector on forms  
1716 prescribed by the State Tax Commission. The application and the  
1717 additional fee imposed under subsection (3) of this section, less  
1718 Two Dollars (\$2.00) to be retained by the tax collector, shall be  
1719 remitted to the State Tax Commission on a monthly basis as  
1720 prescribed by the commission. The portion of the additional fee  
1721 retained by the tax collector shall be deposited into the county  
1722 general fund.

1723 (3) Beginning with any registration year commencing on or  
1724 after July 1, 2004, any person applying for a distinctive license  
1725 tag under this section shall pay an additional fee in the amount  
1726 of Thirty Dollars (\$30.00) for each distinctive license tag  
1727 applied for under this section, which shall be in addition to all  
1728 other taxes and fees. The additional fee paid shall be for a  
1729 period of time to run concurrent with the vehicle's established  
1730 license tag year. The additional fee is due and payable at the  
1731 time the original application is made for a distinctive license  
1732 tag under this section and thereafter annually at the time of  
1733 renewal registration as long as the owner retains the distinctive  
1734 license tag. If the owner does not wish to retain the distinctive  
1735 license tag, he must surrender it to the local county tax  
1736 collector.

1737 (4) The State Tax Commission shall deposit all fees into the  
1738 State Treasury on the day collected. At the end of each month,  
1739 the State Tax Commission shall certify the total fees collected

1740 under this section to the State Treasurer who shall distribute  
1741 such collections as follows:

1742           (a) Twenty-five Dollars (\$25.00) of each additional fee  
1743 collected on distinctive license tags issued pursuant to this  
1744 section shall be deposited into the Mississippi Commission for  
1745 Volunteer Service Fund created under Section 43-55-29.

1746           (b) One Dollar (\$1.00) of each additional fee collected  
1747 on distinctive license tags issued pursuant to this section shall  
1748 be deposited into the Mississippi Fire Fighter's Memorial Burn  
1749 Center Fund created pursuant to Section 7-9-70.

1750           (c) Two Dollars (\$2.00) of each additional fee  
1751 collected on distinctive license tags issued pursuant to this  
1752 section shall be deposited to the credit of the State Highway Fund  
1753 to be expended solely for the repair, maintenance, construction or  
1754 reconstruction of highways.

1755           (5) A regular license tag must be properly displayed as  
1756 required by law until replaced by a distinctive license tag under  
1757 this section. The regular license tag must be surrendered to the  
1758 tax collector upon issuance of the distinctive license tag under  
1759 this section. The tax collector shall issue up to two (2) license  
1760 decals for each distinctive license tag issued under this section,  
1761 which will expire the same month and year as the regular license  
1762 tag.

1763           (6) In the case of loss or theft of a distinctive license  
1764 tag issued under this section, the owner may make application and  
1765 affidavit for a replacement distinctive license tag as provided by  
1766 Section 27-19-37. The fee for a replacement distinctive license  
1767 tag shall be Ten Dollars (\$10.00). The tax collector receiving  
1768 such application and affidavit shall be entitled to retain and  
1769 deposit into the county general fund five percent (5%) of the fee  
1770 for such replacement license tag and the remainder shall be

1771 distributed in the same manner as funds from the sale of regular  
1772 distinctive license tags issued under this section.

1773 (7) In order for the license tag authorized under this  
1774 section to be prepared and issued by the State Tax Commission, the  
1775 provisions of Section 27-19-44(2) shall be satisfied prior to July  
1776 1, 2007.

1777 **SECTION 24.** Section 27-19-56.35, Mississippi Code of 1972,  
1778 is amended as follows:

1779 27-19-56.35. (1) Any owner of a motor vehicle who is a  
1780 resident of this state, upon payment of the road and bridge  
1781 privilege taxes, ad valorem taxes and registration fees as  
1782 prescribed by law for private carriers of passengers, pickup  
1783 trucks and other noncommercial motor vehicles, and upon payment of  
1784 an additional fee in the amount provided in subsection (3) of this  
1785 section, shall be issued a distinctive license tag of such color  
1786 and design as the State Tax Commission may prescribe commemorating  
1787 September 11, 2001, and containing the phrase "Mississippi  
1788 Remembers and Cares." The tag shall consist of such letters or  
1789 numbers, or both, as may be necessary to distinguish each license  
1790 tag.

1791 (2) Application for the distinctive license tags authorized  
1792 by this section shall be made to the county tax collector on forms  
1793 prescribed by the State Tax Commission. The application and the  
1794 additional fee imposed under subsection (3) of this section, less  
1795 Two Dollars (\$2.00) thereof to be retained by the tax collector,  
1796 shall be remitted to the State Tax Commission on a monthly basis  
1797 as prescribed by the commission. The portion of the additional  
1798 fee retained by the tax collector shall be deposited into the  
1799 county general fund.

1800 (3) Beginning with any registration year commencing on or  
1801 after July 1, 2002, any person applying for a distinctive license  
1802 tag under this section shall pay an additional fee in the amount

1803 of Thirty Dollars (\$30.00) for each distinctive license tag  
1804 applied for under this section, which shall be in addition to all  
1805 other taxes and fees. The additional fee paid shall be for a  
1806 period of time to run concurrent with the vehicle's established  
1807 license tag year. The additional fee is due and payable at the  
1808 time the original application is made for a distinctive license  
1809 tag under this section and thereafter annually at the time of

1821 collected on distinctive license tags issued pursuant to this  
1822 section shall be distributed to the Mississippi Association of  
1823 Conservation Districts, Inc.

1824 (b) One Dollar (\$1.00) of each additional fee collected  
1825 on distinctive license tags issued pursuant to this section shall  
1826 be deposited into the Mississippi Fire Fighter's Memorial Burn  
1827 Center Fund created pursuant to Section 7-9-70.

1828 (c) Two Dollars (\$2.00) of each additional fee  
1829 collected on distinctive license tags issued pursuant to this  
1830 section shall be deposited to the credit of the State Highway Fund  
1831 to be expended solely for the repair, maintenance, construction or  
1832 reconstruction of highways.

1833 (d) One Dollar (\$1.00) of each additional fee collected  
1834 on distinctive license tags issued pursuant to this section shall

1835 be deposited to the credit of the special fund created in Section  
1836 27-19-44.2.

1837 (5) A regular license tag must be properly displayed as  
1838 required by law until replaced by a distinctive license tag under  
1839 this section. The regular license tag must be surrendered to the  
1840 tax collector upon issuance of the distinctive license tag under  
1841 this section. The tax collector shall issue up to two (2) license  
1842 decals for each distinctive license tag issued under this section,  
1843 which will expire the same month and year as the regular license  
1844 tag.

1845 (6) In the case of loss or theft of a distinctive license  
1846 tag issued under this section, the owner may make application and  
1847 affidavit for a replacement distinctive license tag as provided by  
1848 Section 27-19-37. The fee for a replacement distinctive license  
1849 tag shall be Ten Dollars (\$10.00). The tax collector receiving  
1850 such application and affidavit shall be entitled to retain and

1856 **SECTION 25.** Section 27-19-56.55, Mississippi Code of 1972,  
1857 is amended as follows:

1858 27-19-56.55. (1) Any owner of a motor vehicle who is a  
1859 retired member of the Mississippi Highway Safety Patrol and who is  
1860 a resident of this state, upon payment of the road and bridge  
1861 privilege taxes, ad valorem taxes and registration fees as  
1862 prescribed by law for private carriers of passengers, pickup  
1863 trucks and other noncommercial motor vehicles, and upon payment of  
1864 an additional fee in the amount provided in subsection (3) of this  
1865 section, shall be issued a distinctive license tag for each motor  
1866 vehicle registered in his name identifying such person as a

1867 retired member of the Mississippi Highway Safety Patrol. The  
1868 distinctive license tags so issued shall be of such color and  
1869 design as the State Tax Commission may prescribe and shall consist  
1870 of such letters or numbers, or both, as may be necessary to  
1871 distinguish each license tag and may, in the discretion of the  
1872 State Tax Commission, display the county name.

1873 (2) Application for the distinctive license tags authorized  
1874 by this section shall be made to the county tax collector on forms  
1875 prescribed by the State Tax Commission. Applicants for such  
1876 distinctive license tags shall present proof that they are a  
1877 retired member of the Mississippi Highway Safety Patrol by  
1878 presentation of a signed and notarized affidavit from the  
1879 Commissioner of Public Safety. The application and the additional  
1880 fee imposed under subsection (3) of this section, less Two Dollars  
1881 (\$2.00) thereof to be retained by the tax collector, shall be  
1882 remitted to the State Tax Commission on a monthly basis as  
1883 prescribed by the commission. The portion of the additional fee  
1884 retained by the tax collector shall be deposited into the county  
1885 general fund.

1886 (3) Beginning with any registration year commencing on or  
1887 after July 1, 2002, any person applying for a distinctive license  
1888 tag under this section shall pay an additional fee in the amount  
1889 of Thirty Dollars (\$30.00) for each distinctive license tag  
1890 applied for under this section, which shall be in addition to all  
1891 other taxes and fees. The additional fee paid shall be for a  
1892 period of time to run concurrent with the vehicle's established  
1893 license tag year. The additional fee is due and payable at the  
1894 time the original application is made for a distinctive license

1910 on distinctive license tags issued pursuant to this section shall  
1911 be deposited into the Mississippi Fire Fighter's Memorial Burn  
1912 Center Fund created pursuant to Section 7-9-70.

1913 (c) Two Dollars (\$2.00) of each additional fee  
1914 collected on distinctive license tags issued pursuant to this  
1915 section shall be deposited to the credit of the State Highway Fund  
1916 to be expended solely for the repair, maintenance, construction or  
1917 reconstruction of highways.

1918 (d) One Dollar (\$1.00) of each additional fee collected

1920 be deposited to the credit of the special fund created in Section  
1921 27-19-44.2.

1922 (5) A regular license tag must be properly displayed as  
1923 required by law until replaced by a distinctive license tag under

1925 tax collector upon issuance of the distinctive license tag under  
1926 this section. The tax collector shall issue up to two (2) license  
1927 decals for each distinctive license tag issued under this section,

1930           (6) In the case of loss or theft of a distinctive license  
1931 tag issued under this section, the owner may make application and
