## **REPORT OF CONFERENCE COMMITTEE**

## MADAM PRESIDENT AND MR. SPEAKER:

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

S. B. No. 3104: Appropriation; Judicial Performance Comm.

We, therefore, respectfully submit the following report and recommendation:

1. That the House recede from its Amendment No. 1.

2. That the Senate and House adopt the following amendment:

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is hereby appropriated out of any money in the State
7	General Fund not otherwise appropriated, for the purpose of
8	defraying the expenses of the Commission on Judicial Performance
9	of the State of Mississippi for the fiscal year beginning

11	SECTION 2. The following sum, or so much thereof as may be
12	necessary, is hereby appropriated out of any money in the State
13	Treasury to the credit of the Criminal Justice Fund No. 3086, for
14	the purpose of defraying the expenses of the Commission on
15	Judicial Performance of the State of Mississippi for the fiscal
16	year beginning July 1, 2004, and ending June 30, 2005
17	\$ 62,800.00.
18	SECTION 3. With the funds appropriated under the provisions
19	of Sections 1 and 2, the following positions are authorized:

25	Any transfers or escalations shall be made in accordance with
26	the terms, conditions, and procedures established by law.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

SECTION 4. The money herein appropriated shall be paid by 31 32 the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon 33 warrants issued by the State Fiscal Officer; and the State Fiscal 34 35 Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers, in the manner provided by law. 36 SECTION 5. This act shall take effect and be in force from 37 and after July 1, 2004. 38
