AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

It is the intention of the Legislature that the 31 agency's budget request for Fiscal Year 2006 shall be submitted to 32 the Joint Legislative Budget Committee in a format and level of 33 detail comparable to the format and level of detail provided 34 during the Fiscal Year 2005 budget request process.

35 SECTION 7. Of the funds appropriated in Sections 1 and 2, an 36 amount of Three Hundred Fifty-five Thousand One Hundred Eighty 37 Dollars (\$355,180.00) shall be used for Mississippi Natural 38 Products.

SECTION 8. The money herein appropriated shall be paid by 39 40 the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon 41 warrants issued by the State Fiscal Officer; and the State Fiscal 42 Officer shall issue his warrants upon requisitions signed by the 43 proper person, officer or officers in the manner provided by law. 44 45 SECTION 9. This act shall take effect and be in force from and after July 1, 2004. 46
