House Amendments to Senate Bill No. 3113

TO THE SECRETARY OF THE SENATE:

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is hereby appropriated out of any money in the State
7	General Fund not otherwise appropriated, for the support and
8	maintenance of the Mississippi Agricultural and Forestry
9	Experiment Station for the fiscal year beginning July 1, 2004, and

L1	SECTION 2. The following sum, or so much thereof as may be
L2	necessary, is hereby authorized for expenditure out of any special
L3	source funds which are collected by or otherwise become available
L4	for the purpose of defraying the expenses of the Mississippi
L5	Agricultural and Forestry Experiment Station for the fiscal year
L6	beginning July 1, 2004, and ending June 30, 2005
L7	\$ 9,468,651.00.
L8	SECTION 3. No general funds authorized to be expended herein
L9	shall be used to replace federal funds and/or other special funds
20	which are being used for salaries authorized under the provisions
21	of this act and which are withdrawn and no longer available.
22	SECTION 4. It is the intention of the Legislature that if
23	the funds appropriated in Section 1 of this act are used directly
24	or indirectly to match or otherwise secure any federal grants,
25	research grants or donations, such special source funds not
26	classified as current restricted funds shall be added and
27	accounted for under Section 2 of this act. Further, it is the
28	intention of the Legislature that all such aforementioned special
29	source funds be included in all reports and requests for the 2005
30	Regular Session of the Mississippi Legislature.

31	SECTION 5. It is the intention of the Legislature that the		
32	agency's budget request for Fiscal Year 2006 shall be submitted to		
33	the Joint Legislative Budget Committee in a format and level of		
34	detail comparable to the format and level of detail provided		
35	during the Fiscal Year 2005 budget request process.		
36	SECTION 6. Of the funds appropriated in Section 2, One		
37	Million Two Hundred Seventy-two Thousand Six Hundred Seventy-seven		
38	Dollars (\$1,272,677.00) shall be derived from the Education		
39	Enhancement Fund from funds deposited pursuant to Sections		
40	27-65-75 and 27-67-31, Mississippi Code of 1972.		
41	SECTION 7. In compliance with the "Mississippi Performance		
42	Budget and Strategic Planning Act of 1994," it is the intent of		
43	the Legislature that the funds provided herein shall be utilized		
44	in the most efficient and effective manner possible to achieve the		
45	intended mission of this agency. Based on the funding authorized,		
46	this agency shall make every effort to attain the targeted

the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers in the manner provided by law.

SECTION 10. This act shall take effect and be in force from and after July 1, 2004.
