

House Amendments to Senate Bill No. 3146

TO THE SECRETARY OF THE SENATE:

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

4 **SECTION 1.** The following sum, or so much thereof as may be
5 necessary, is hereby appropriated out of any money in the State
6 Treasury to the credit of the Mississippi State Board of
7 Chiropractic Examiners, for the support of said Board for the
8 fiscal year beginning July 1, 2004, and ending June 30, 2005.....
9 \$ 42,540.00.

10 Any transfers or escalations shall be made in accordance with
11 the terms, conditions, and procedures established by law.

12 No general funds authorized to be expended herein shall be
13 used to replace federal funds and/or other special funds which are
14 being used for salaries authorized under the provisions of this
15 act and which are withdrawn and no longer available.

16 **SECTION 2.** The funds authorized herein shall be used to fund
17 all operations of the agency with the following prohibitions:

18 (1) The agency shall not fill any current or future vacant
19 positions;

20 (2) The agency shall not take any action to promote or
21 otherwise award salary increases through reallocation,
22 reclassification, realignment, education benchmark, career ladder,
23 or any other means to increase salaries of employees or positions
24 except as allowed under the provisions set forth in House Bill No.
25 1279, 2004 Regular Session;

26 (3) The agency shall not expend funds for out-of-state
27 travel except as allowed under the provisions set forth in House
28 Bill No. 1279, 2004 Regular Session;

29 (4) The agency shall not expend funds for the purchase of or
30 contract for cellular phones, two-way radios or pagers, except for
31 support of employees in the Department of Public Safety and the
32 Bureau of Narcotics as recommended by Information Technology
33 Services or as allowed under the provisions set forth in House
34 Bill No. 1279, 2004 Regular Session;

35 (5) The agency shall not expend funds to publish or
36 distribute any annual reports or other publications;

37 (6) The agency shall not expend funds for public relation
38 activities regarding the functions, programs or services of the
39 agency except as allowed under the provisions set forth in House
40 Bill No. 1279, 2004 Regular Session;

41 (7) The agency shall not advertise the functions, programs
42 or services of the agency except that the Mississippi Development
43 Authority is authorized to expend funds for advertising to carry
44 out the purposes of key programs administered by the authority;

45 (8) The agency shall not expend funds for staff development
46 or training services;

47 (9) The agency shall not expend funds for the purchase of
48 new or replacement equipment or furniture, excluding lease
49 purchase payments on agreements in effect upon passage of this
50 appropriation bill, except as allowed under the provisions set
51 forth in House Bill No. 1279, 2004 Regular Session.

52 **SECTION 3.** It is the intention of the Legislature that none
53 of the funds appropriated above shall be expended unless members
54 of the Mississippi House of Representatives and Mississippi Senate
55 are notified at least five (5) days prior to a public ceremony
56 announcing the award of any grant in their district or any public
57 announcement or ceremony regarding the groundbreaking or opening
58 of a facility, roadway or bridge for which the Legislature has
59 made funds available. Any signage regarding any public event or
60 any new facility, roadway or bridge shall include the following
61 language: "Funds were made available for this project by the
62 Mississippi State Legislature."

63 **SECTION 4.** It is the intention of the Legislature that the
64 Mississippi State Board of Chiropractic Examiners shall maintain
65 complete accounting and personnel records related to the
66 expenditure of all funds appropriated under this act and that such
67 records shall be in the same format and level of detail as
68 maintained for Fiscal Year 2004. It is further the intention of
69 the Legislature that the agency's budget request for Fiscal Year
70 2006 shall be submitted to the Joint Legislative Budget Committee
71 in a format and level of detail comparable to the format and level
72 of detail provided during the Fiscal Year 2005 budget request
73 process.

74 **SECTION 5.** The money herein appropriated shall be paid by
75 the State Treasurer out of any money in the State Treasury to the
76 credit of the proper fund or funds as set forth in this act, upon
77 warrants issued by the State Fiscal Officer; and the State Fiscal
78 Officer shall issue his warrants upon requisitions signed by the
79 proper person, officer or officers in the manner provided by law.

80 **SECTION 6.** This act shall take effect and be in force from
81 and after July 1, 2004.
