

**Adopted  
COMMITTEE AMENDMENT NO 1 PROPOSED TO**

**Senate Bill No. 3130**

**BY: Committee**

**Amend by striking all after the enacting clause and inserting  
in lieu thereof the following:**

5           **SECTION 1.** The following sum of money, or so much thereof as  
6 may be necessary, is hereby appropriated, out of any money in the  
7 Special Fund in the State Treasury to the credit of the  
8 Mississippi Egg Marketing Board, to defray the expenses of said  
9 board for the fiscal year beginning July 1, 2004, and ending  
10 June 30, 2005.....\$                   73,017.00.

11           **SECTION 2.** Any transfers or escalations shall be made in  
12 accordance with the terms, conditions, and procedures established  
13 by law.

14           No general funds authorized to be expended herein shall be  
15 used to replace federal funds and/or other special funds which are  
16 being used for salaries authorized under the provisions of this  
17 act and which are withdrawn and no longer available.

18           **SECTION 3.** The funds authorized herein shall be used to fund  
19 all operations of the agency with the following prohibitions:

20           (1) The agency shall not fill any current or future vacant  
21 positions;

22           (2) The agency shall not take any action to promote or  
23 otherwise award salary increases through reallocation,

24 reclassification, realignment, education benchmark, career ladder,  
25 or any other means to increase salaries of employees or positions  
26 except as allowed under the provisions set forth in House Bill No.  
27 1279, 2004 Regular Session;

28 (3) The agency shall not expend funds for out-of-state  
29 travel except as allowed under the provisions set forth in House  
30 Bill No. 1279, 2004 Regular Session;

31 (4) The agency shall not expend funds for the purchase of or  
32 contract for cellular phones, two-way radios or pagers, except for  
33 support of employees in the Department of Public Safety and the  
34 Bureau of Narcotics as recommended by Information Technology  
35 Services or as allowed under the provisions set forth in House  
36 Bill No. 1279, 2004 Regular Session;

37 (5) The agency shall not expend funds to publish or  
38 distribute any annual reports or other publications;

39 (6) The agency shall not expend funds for public relation  
40 activities regarding the functions, programs or services of the  
41 agency except as allowed under the provisions set forth in House  
42 Bill No. 1279, 2004 Regular Session;

43 (7) The agency shall not advertise the functions, programs  
44 or services of the agency except that the Mississippi Development  
45 Authority is authorized to expend funds for advertising to carry  
46 out the purposes of key programs administered by the authority;

47 (8) The agency shall not expend funds for staff development  
48 or training services;

49 (9) The agency shall not expend funds for the purchase of  
50 new or replacement equipment or furniture, excluding lease  
51 purchase payments on agreements in effect upon passage of this  
52 appropriation bill, except as allowed under the provisions set  
53 forth in House Bill No. 1279, 2004 Regular Session.

54 **SECTION 4.** It is the intention of the Legislature that none  
55 of the funds appropriated above shall be expended unless members

56 of the Mississippi House of Representatives and Mississippi Senate  
57 are notified at least five (5) days prior to a public ceremony  
58 announcing the award of any grant in their district or any public  
59 announcement or ceremony regarding the groundbreaking or opening  
60 of a facility, roadway or bridge for which the Legislature has  
61 made funds available. Any signage regarding any public event or  
62 any new facility, roadway or bridge shall include the following  
63 language: "Funds were made available for this project by the  
64 Mississippi State Legislature."

65         **SECTION 5.** It is the intention of the Legislature that the  
66 Mississippi Egg Marketing Board shall maintain complete accounting  
67 and personnel records related to the expenditure of all funds  
68 appropriated under this act and that such records shall be in the  
69 same format and level of detail as maintained for Fiscal Year  
70 2004. It is further the intention of the Legislature that the  
71 agency's budget request for Fiscal Year 2006 shall be submitted to  
72 the Joint Legislative Budget Committee in a format and level of  
73 detail comparable to the format and level of detail provided  
74 during the Fiscal Year 2005 budget request process.

75         **SECTION 6.** The money herein appropriated shall be paid by  
76 the State Treasurer out of any money in the State Treasury to the  
77 credit of the proper fund or funds as set forth in this act, upon  
78 warrants issued by the State Fiscal Officer; and the State Fiscal  
79 Officer shall issue his warrants upon requisitions signed by the  
80 proper person, officer or officers in the manner provided by law.

81         **SECTION 7.** This act shall take effect and be in force from  
82 and after July 1, 2004.
