COMMITTEE AMENDMENT NO 1 PROPOSED TO**

Senate Bill No. 3182

**Amend by striking all after the enacting clause and inserting
in lieu thereof the following:**

8 **SECTION 1.** In addition to all other sums heretofore
9 appropriated, the following sum, or so much thereof as may be
10 necessary, is hereby appropriated out of any money in the State
11 Treasury to the credit of the Working Cash-Stabilization Reserve
12 Fund, not otherwise appropriated, for the purpose of defraying the
13 expenses of the Office of the Attorney General for the fiscal year
14 ending June 30, 2004..... \$ 267,379.00.

15 This additional appropriation is made for the purpose of
16 defraying the costs of certain outside legal assistance, expert
17 witness fees and court fees incurred by the Office of the Attorney
18 General.

19 **SECTION 2.** In addition to all other sums heretofore
20 appropriated, the following sum, or so much thereof as may be
21 necessary, is hereby appropriated out of any money in the State
22 Treasury to the credit of the Working Cash-Stabilization Reserve
23 Fund, Section 27-103-301, Mississippi Code of 1972, not otherwise
24 appropriated, for the purpose of paying a judgment rendered
25 against the State of Mississippi for the fiscal year ending June
26 30, 2004..... \$ 114,004.00.

27 This additional appropriation is made for the purpose of
28 paying a court ordered judgment as required in Civil Action No.
29 1:02CV20-B-0, Bertha Earnest vs Mississippi Department of Human
30 Services, the United States District Court, Northern District of
31 Mississippi.

32 **SECTION 3.** In addition to all other sums heretofore
33 appropriated, the following sum, or so much thereof as may be
34 necessary, is hereby appropriated out of any money in the Working
35 Cash-Stabilization Reserve Fund, not otherwise appropriated, for
36 the purpose of paying a settlement against the State of
37 Mississippi for the fiscal year ending June 30, 2004.....
38 \$ 22,672.00.

39 This additional appropriation is made for the purpose of
40 paying a settlement in Civil Action No. 2:01CV62PG, Stacey Walkers
41 Cooley vs Harrison County Board of Supervisors, in the United
42 States District Court, Southern District of Mississippi.

43 **SECTION 4.** In addition to all other sums heretofore
44 appropriated, the following sum, or so much thereof as may be
45 necessary, is hereby appropriated out of any money in the State
46 Treasury to the credit of the Working Cash-Stabilization Reserve
47 Fund, not otherwise appropriated, for the purpose of paying a
48 settlement against the State of Mississippi for the fiscal year
49 ending June 30, 2004..... \$ 500.00.

50 This additional appropriation is made for the purpose of
51 paying a settlement in Civil Action No. 3:99CV32-W-S; Sheryl
52 Bridges vs Mississippi Department of Corrections, et al, in the
53 United States District Court, Southern District of Mississippi.

54 **SECTION 5.** In addition to all other sums heretofore
55 appropriated, the following sum, or so much thereof as may be
56 necessary, is hereby appropriated out of any money in the State
57 Treasury to the credit of the Working Cash-Stabilization Reserve
58 Fund, not otherwise appropriated, for the purpose of paying a

59 settlement against the State of Mississippi for the fiscal year
60 ending June 30, 2004..... \$ 60,000.00.

61 This additional appropriation is made for the purpose of
62 paying a settlement in Cause No. BC 75-31-S; Mattie T. vs Henry
63 Johnson in the United States District Court for the Northern
64 District of Mississippi.

65 **SECTION 6.** The money herein appropriated shall be paid by
66 the State Treasurer out of any money in the proper fund or funds
67 as set forth in this act, upon warrants issued by the State Fiscal
68 Officer; and the State Fiscal Officer shall issue his warrants
69 upon requisitions signed by the proper person, officer or officers
70 in the manner provided by law.

71 **SECTION 7.** This act shall take effect and be in force from
72 and after its passage.
