

Senate Amendments to House Bill No. 1215

TO THE CLERK OF THE HOUSE:

THIS IS TO INFORM YOU THAT THE SENATE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

11 **SECTION 1.** (1) That portion of Mississippi Highway 43
12 located in Hancock County beginning at its intersection with
13 Mississippi Highway 603 and extending northerly and westerly to
14 the Hancock/Pearl River county line is designated and shall be
15 known as the "Alton A. (Dolph) Kellar Memorial Highway."

16 (2) The Mississippi Department of Transportation shall erect
17 and maintain appropriate signs along and approaching the segment
18 of highway described in subsection (1) of this section.

19 **SECTION 2.** (1) That portion of Interstate Highway 59
20 located in Forrest and Jones Counties is designated and shall be
21 known as the "Lance Corporal Roy M. Wheat Memorial Highway."

22 (2) The Mississippi Department of Transportation shall erect
23 and maintain appropriate signs along and approaching the segment
24 of highway described in subsection (1) of this section.

25 **SECTION 3.** (1) Mississippi Highway 773 located in Tippah
26 County is designated and shall be known as the "Joe Mitch McElwain
27 Memorial Highway."

28 (2) The Mississippi Department of Transportation shall erect
29 and maintain appropriate signs along and approaching the highway
30 described in subsection (1) of this section.

31 **SECTION 4.** (1) That portion of Mississippi Highway 25
32 located in Tishomingo County is designated and shall be known as
33 the "David Bonds Memorial Highway."

34 (2) The Mississippi Department of Transportation shall erect
35 and maintain appropriate signs along and approaching the segment
36 of highway described in subsection (1) of this section.

37 **SECTION 5.** This act shall take effect and be in force from
38 and after its passage.

**Further, amend by striking the title in its entirety and
inserting in lieu thereof the following:**

1 AN ACT TO DESIGNATE A CERTAIN PORTION OF MISSISSIPPI HIGHWAY
2 43 LOCATED IN HANCOCK COUNTY AS THE "ALTON A. (DOLPH) KELLAR
3 MEMORIAL HIGHWAY"; TO DESIGNATE THAT PORTION OF INTERSTATE HIGHWAY
4 59 LOCATED IN FORREST AND JONES COUNTIES AS THE "LANCE CORPORAL
5 ROY M. WHEAT MEMORIAL HIGHWAY"; TO DESIGNATE MISSISSIPPI HIGHWAY
6 773 LOCATED IN TIPPAH COUNTY AS THE "JOE MITCH MCELWAIN MEMORIAL
7 HIGHWAY"; TO DESIGNATE THAT PORTION OF MISSISSIPPI HIGHWAY 25
8 LOCATED IN TISHOMINGO COUNTY AS THE "DAVID BONDS MEMORIAL
9 HIGHWAY"; AND FOR RELATED PURPOSES.
