## Adopted COMMITTEE AMENDMENT NO 1 PROPOSED TO

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

28 47-7-3, for a conviction of robbery or attempted robbery through

29 the display of a deadly weapon, carjacking through the display of

31 (e) The offender was convicted of violating Section

32 <u>41-29-139(a)</u> and sentenced under Section 41-29-139(b) or

- 34 (f) The offender was convicted of trafficking in
  35 controlled substances under Section 41-29-139.
- 55 <u>controlled substances under Section 41-29-159.</u>

36 **SECTION 2.** This act shall take effect and be in force from

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

1 AN ACT TO AMEND SECTION 47-5-138.1, MISSISSIPPI CODE OF 1972, 2 TO INCREASE THE REDUCTION OF SENTENCE THAT MAY BE AWARDED AS A 3 TRUSTY TIME ALLOWANCE FOR A TRUSTY WHO PARTICIPATES DURING ANY 4 CALENDAR MONTH IN AN APPROVED PROGRAM; TO PROVIDE THAT CERTAIN 5 OFFENDERS WHO ARE IN TRUSTY STATUS SHALL NOT BE ELIGIBLE TO 6 RECEIVE A TRUSTY TIME ALLOWANCE FOR A REDUCTION OF SENTENCE; AND 7 FOR RELATED PURPOSES.
