- AMEND by deleting lines 311 through 320 and inserting in lieu
- 2 thereof the following:
- 3 "SECTION 4. (1) Except as provided in subsection (2) of
- 4 this section, any compound, mixture or preparation containing any
- 5 detectable quantity of pseudoephedrine, its salts or optical
- 6 isomers ("pseudoephedrine product") shall only be dispensed, sold
- 7 or distributed in a pharmacy, and shall be subject to the
- 8 following requirements:
- 9 (a) A pseudoephedrine product shall be dispensed, sold
- 10 or distributed only by a licensed pharmacist or registered
- 11 pharmacy technician.
- 12 (b) A person purchasing, receiving or otherwise
- 13 acquiring a pseudoephedrine product shall produce a photo
- 14 identification showing the date of birth of the person and shall
- 15 sign a written log or receipt showing the date of the transaction, the
- 16 name of the person and the amount of the pseudoephedrine product.
- 17 (c) No person shall purchase, receive or otherwise
- 18 acquire more than nive (9) grams of a pseudoephedrine product
- 19 within any thirty-day period. However, this limit shall not apply
- 20 to any quantity of a pseudoephedrine product that is dispensed
- 21 under a valid prescription.
- 22 (2) Subsection (1) of this section does not apply to any
- 23 compound, mixture or preparation containing pseudoephedrine that

- is in liquid, liquid capsule or gel capsule form if 24
- pseudoephedrine is not the only active ingredient. 25
- (3) A person who violates any provision of this section is 26
- guilty of a felony and, upon conviction, shall be punished by a 27
- 28 fine of not more than Five Thousand Dollars (\$5,000.00), or by
- imprisonment in the State Penitentiary for not more than three (3) 29
- 30 years, or by both a fine and imprisonment."
