HOUSE BILL NO. 295

- AN ACT TO AMEND SECTION 41-89-1, MISSISSIPPI CODE OF 1972, WHICH PROVIDES THE INFANT MORTALITY TASK FORCE, TO EXTEND THE DATE OF REPEAL ON THIS SECTION FROM JULY 1, 2005, TO JULY 1, 2007; TO AMEND SECTION 41-89-3, MISSISSIPPI CODE OF 1972, WHICH PROVIDES THE BYLAWS AND RULES OF SUCH TASK FORCE, TO EXTEND THE DATE OF REPEAL ON THIS SECTION FROM JULY 1, 2005, TO JULY 1, 2007; AND FOR RELATED PURPOSES.
- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 9 **SECTION 1.** Section 41-89-1, Mississippi Code of 1972, is
- 10 amended as follows:
- 11 41-89-1. (1) There is created the Infant Mortality Task
- 12 Force, the purpose of which is to foster the reduction of infant
- 13 mortality and morbidity in Mississippi and to improve the health
- 14 status of mothers and infants.
- 15 (2) The Infant Mortality Task Force is continued and
- 16 reconstituted as follows: The task force shall be composed of
- 17 eleven (11) voting members appointed as follows:
- 18 (a) The Governor shall appoint seven (7) members, with
- 19 two (2) from each Mississippi Supreme Court district and one (1)
- 20 from the state at large.
- 21 (b) The Lieutenant Governor shall appoint two (2)
- 22 members from the state at large.
- 23 (c) The Speaker of the House of Representatives shall
- 24 appoint two (2) members from the state at large.
- 25 (d) The task force shall be comprised of persons with a
- 26 professional association with or special interest in maternal and
- 27 infant health and well-being.

- (e) Any member of the Infant Mortality Task Force
 appointed and serving prior to July 1, 1995, shall be eligible for
 reappointment to the task force.
- 31 (3) The Governor shall appoint two (2) members for initial
- 32 terms that expire on June 30, 1996, two (2) members for initial
- 33 terms that expire on June 30, 1997, and three (3) members for
- 34 initial terms that expire on June 30, 1998. The Lieutenant
- 35 Governor and Speaker of the House of Representatives shall appoint
- 36 one (1) member for an initial term that expires on June 30, 1997,
- 37 and one (1) member for an initial term that expires on June 30,
- 38 1998. Thereafter, all members shall be appointed for terms of
- 39 three (3) years from the expiration of the previous term. No
- 40 member shall serve more than two (2) successive full terms. Any
- 41 vacancy occurring other than by expiration of a term shall be
- 42 filled for the unexpired term by the appropriate appointing
- 43 authority. An appointment to fill an unexpired term shall not be
- 44 considered as a full term.
- 45 (4) The administrative head of the following state agencies
- 46 shall designate one (1) employee to serve in an advisory capacity
- 47 as an ex officio, nonvoting member of the Infant Mortality Task
- 48 Force: (a) Mississippi Department of Health; (b) State Department
- 49 of Education; (c) Department of Human Services; (d) Mississippi
- 50 Department of Mental Health; (e) Division of Medicaid; and (f) the
- 51 University Medical Center. In addition there shall be one (1)
- 52 member of the Mississippi Primary Health Care Association who
- 53 shall serve in an advisory capacity as an ex officio nonvoting
- 54 member.
- 55 (5) The Chairman of the Senate Public Health and Welfare
- 56 Committee and one (1) member of the committee to be designated by
- 57 the chairman, and the Chairman of the House Public Health and
- 58 Welfare Committee and one (1) member of the committee to be
- 59 designated by the chairman shall serve in an advisory capacity as
- 60 ex officio nonvoting members of the Infant Mortality Task Force.

- 61 (6) This section shall stand repealed on July 1, 2007.
- 62 **SECTION 2.** Section 41-89-3, Mississippi Code of 1972, is
- 63 amended as follows:
- 64 41-89-3. (1) The Chairman of the Infant Mortality Task
- 65 Force shall be elected annually by the task force membership. The
- 66 task force shall adopt bylaws and rules for its efficient
- 67 operation, which may include designation of its organizational
- 68 structure including other officers and committees, duties of
- 69 officers and committees, a process for selecting officers, quorum
- 70 requirements for committees, provisions for special or ad hoc
- 71 committees, staff policies and other such procedures as may be
- 72 necessary. The task force may establish committees responsible
- 73 for conducting specific task force programs or activities.
- 74 (2) The task force shall be assigned to the State Department
- 75 of Health for administrative purposes only, and the department
- 76 shall designate staff to assist the task force. The task force
- 77 shall have a line item in the budget of the State Department of
- 78 Health and shall be financed through the department's annual
- 79 appropriation. Members of the task force may receive, within the
- 80 funds appropriated, reimbursement for travel expenses incurred
- 81 while engaged in official business of the task force.
- 82 (3) The task force shall meet and conduct business at least
- 83 quarterly. All meetings of the task force and any committees of
- 84 the task force shall be open to the public, with opportunities for
- 85 public comment provided on a regular basis. Notice of all
- 86 meetings shall be given as provided in the Open Meetings Act
- 87 (Section 25-41-1 et seq.) and appropriate notice also shall be
- 88 given to all persons so requesting of the date, time and place of
- 89 each meeting.
- 90 (4) The Infant Mortality Task Force, in conjunction with the
- 91 State Department of Health, the Department of Human Services, the
- 92 State Department of Education and the Division of Medicaid, shall
- 93 develop and implement a campaign for intensive outreach to high

- 94 risk populations in Mississippi to encourage them to avail
- 95 themselves of family planning, prenatal care and infant health
- 96 services.
- 97 (5) The Infant Mortality Task Force may apply for and expend
- 98 grants or other contributions for the purpose of promoting
- 99 maternal and infant health in Mississippi.
- 100 (6) This section shall stand repealed on July 1, 2007.
- 101 SECTION 3. This act shall take effect and be in force from
- 102 and after July 1, 2005.
