HOUSE BILL NO. 309

1	AN ACT TO AMEND SECTION 31-9-5, MISSISSIPPI CODE OF 1972, TO
2	EXTEND THE DATE OF REPEAL ON THE SECTION OF LAW THAT AUTHORIZES
3	AND EMPOWERS A STATE AGENCY, WITH THE APPROVAL OF THE OFFICE OF
4	GENERAL SERVICES, TO DONATE GOODS OR SERVICES TO THE AMERICAN RED
5	CROSS; AND FOR RELATED PURPOSES.

- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 **SECTION 1.** Section 31-9-5, Mississippi Code of 1972, is
- 8 amended as follows:
- 9 31-9-5. (1) The Office of General Services with the
- 10 approval of the Public Procurement Review Board shall negotiate
- 11 and contract with any appropriate agency or commission of the
- 12 United States government or of the State of Mississippi for the
- 13 purpose of purchasing or otherwise securing surplus material or
- 14 property in bulk lots or quantities, and for the purpose of
- 15 assisting all agencies, departments, institutions and
- 16 instrumentalities of the State of Mississippi, the boards of
- 17 supervisors of the various counties, and the governing authorities
- 18 of the various municipalities, drainage districts and other taxing
- 19 units in purchasing, leasing or otherwise securing surplus
- 20 material or property. After ascertaining the needs of the various
- 21 state departments and institutions, counties, municipalities,
- 22 drainage districts and other taxing units, the Office of General
- 23 Services may enter into contracts with the governing authorities
- 24 of such governmental entities as will enable them to carry out the
- 25 provisions of this section.
- 26 (2) The Office of General Services also may acquire state or
- 27 federal government surplus property for nonprofit and tax exempt
- 28 health and educational institutions, Boy Scouts, Girl Scouts, Camp

- 29 Fire Girls, military academies, volunteer fire departments,
- 30 nonprofit cooperative water associations, Boys Clubs of America
- 31 and Girls Clubs of America; however, deliveries to these
- 32 institutions shall be made only after they have established their
- 33 eligibility by meeting the requirements of the federal government,
- 34 have requested the Office of General Services to act for them in
- 35 acquiring government surplus property, and have agreed to comply
- 36 with both the state and federal laws pertaining to acquisition and
- 37 utilization of the property.
- 38 (3) Any state agency, with the approval of the Office of
- 39 General Services, is authorized and empowered, in the discretion
- 40 of the governing board or authority of the state agency, to donate
- 41 goods or services for the support of any local chapter of the
- 42 American Red Cross. This subsection (3) shall stand repealed from
- 43 and after July 1, 2007.
- 44 (4) The Office of General Services may do all other things
- 45 which may be necessary to effectuate the purposes of this section.
- 46 **SECTION 2.** This act shall take effect and be in force from
- 47 and after July 1, 2005.
