## HOUSE BILL NO. 340

1	AN ACT TO AMEND SECTION 57-69-5, MISSISSIPPI CODE OF 1972, TO
2	PROVIDE THAT THE OFFICE OF MINORITY BUSINESS ENTERPRISES OF THE
3	MISSISSIPPI DEVELOPMENT AUTHORITY SHALL SERVE AS THE OFFICIAL
4	STATE COORDINATING OFFICE FOR ALL STATE AGENCIES THAT RECEIVE
5	FEDERAL MONIES AND FOR ALL STATE PROCUREMENTS AND CONSTRUCTION
6	PROJECTS FOR THE PURPOSE OF ENSURING THAT MINORITY BUSINESS
7	ENTERPRISES ARE PROVIDED AN ADEQUATE OPPORTUNITY TO PARTICIPATE
8	FAIRLY IN THE DISTRIBUTION OF SUCH FEDERAL MONIES AND IN THE
9	AWARDING OF SUCH PROCUREMENT AND CONSTRUCTION CONTRACTS.

- 10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 11 **SECTION 1.** Section 57-69-5, Mississippi Code of 1972, is
- 12 amended as follows:
- 13 57-69-5. (1) There is hereby created the Office of Minority
- 14 Business Enterprises of the Mississippi Development Authority
- 15 under the Mississippi Development Authority. The Executive
- 16 Director of the Mississippi Development Authority shall appoint an
- 17 executive director for the office. The executive director may
- 18 employ a staff subject to approval of the Executive Director of
- 19 the Mississippi Development Authority as necessary to carry out
- 20 the purposes of this office.
- 21 (2) The office shall perform the following:
- 22 (a) Develop, plan and implement programs to provide an
- 23 opportunity for participation by qualified minority owned
- 24 businesses in public works and the process by which goods and
- 25 services are procured by state agencies and educational
- 26 institutions from the private sector;
- 27 (b) Develop a comprehensive plan encouraging that
- 28 qualified minority owned businesses are provided an opportunity to
- 29 participate in public contracts for public works and commodities
- 30 and services;

- 31 (c) Identify barriers to equal participation by
- 32 qualified minority owned businesses in all state agency and
- 33 educational institution contracts;
- 34 (d) Develop and maintain a central minority business
- 35 enterprise certification list for all state agencies and
- 36 educational institutions;
- 37 (e) Adopt rules for the implementation of this chapter;
- 38 (f) Develop and maintain a central minority business
- 39 enterprise certification program;
- 40 (g) Submit an annual report to the Governor and the
- 41 Legislature outlining the progress and economic impact on the
- 42 public and private sectors of implementing this chapter;
- 43 (h) Increase efforts to inform minority businesses of
- 44 state government procurement procedures and policies;
- 45 (i) Serve as the principal advocate in the state on
- 46 behalf of minority business enterprises and provide advice in the
- 47 consideration of administrative requirements and legislation that
- 48 affect minority business enterprises;
- 49 (j) Evaluate the effectiveness of efforts of state
- 50 agencies and other entities to assist minority business
- 51 enterprises and make appropriate recommendations to assist the
- 52 development and strengthening of minority business enterprises;
- 53 (k) Determine the availability of financial and other
- 54 resources to minority business enterprises and recommend methods
- 55 for:
- 56 (i) Increasing the availability of equity capital
- 57 and other forms of financial assistance to minority business
- 58 enterprises;
- 59 (ii) Generating markets for the goods and services
- 60 of minority business enterprises;
- 61 (iii) Providing more effective education, training
- 62 and management and technical assistance to minority business
- 63 enterprises; and

- 64 (iv) Providing assistance to minority business
- 65 enterprises in complying with federal, state and local laws;
- 66 (1) Serve as a focal point for receiving complaints and
- 67 suggestions concerning state government policies and activities
- 68 that affect minority business enterprises;
- (m) Develop and advocate proposals for changes in state
- 70 policies and activities that adversely affect minority business
- 71 enterprises;
- 72 (n) Provide to legislative committees and state
- 73 agencies information on the effects of proposed policies or
- 74 actions that affect minority business enterprises;
- 75 (o) Enlist the assistance of public and private
- 76 agencies, businesses and other organizations in disseminating
- 77 information about state programs and services that benefit
- 78 minority business enterprises and information regarding means by
- 79 which minority business enterprises can use those programs and
- 80 services;
- 81 (p) Identify sources of financial assistance for
- 82 minority business enterprises, match minority business enterprises
- 83 with sources of financial assistance, and assist minority business
- 84 enterprises with the preparation of applications for loans from
- 85 governmental or private sources;
- 86 (q) Sponsor meetings, to the extent practicable in
- 87 cooperation with public and private educational institutions, to
- 88 provide training and disseminate information beneficial to
- 89 minority business enterprises;
- 90 (r) Assist minority business enterprises in their
- 91 dealings with federal, state and local governmental agencies and
- 92 provide information regarding governmental requirements affecting
- 93 minority business enterprises;
- 94 (s) Develop and implement programs to encourage
- 95 governmental agencies, public sector business associations and

- 98 (t) Use available resources within the state, such as
- 99 minority business enterprise development centers, educational
- 100 institutions and nonprofit associations, to coordinate the
- 101 provision of management and technical assistance to minority
- 102 business enterprises in a systematic manner;
- 103 (u) Publish newsletters, brochures and other documents
- 104 containing information useful to minority business enterprises;
- 105 (v) Identify successful minority business enterprise
- 106 assistance programs provided by other states and determine the
- 107 feasibility of adapting those programs for implementation in
- 108 Mississippi;
- 109 (w) Establish an outreach program to make the existence
- 110 of the office known to minority business enterprises and potential
- 111 clients throughout the state; and
- 112 (x) Identify potential business opportunities for
- 113 minority business enterprises and develop programs to maximize
- 114 those opportunities.
- 115 (3) The Office of Minority Business Enterprises of the
- 116 Mississippi Development Authority shall serve as the official
- 117 state coordinating office for all state agencies that receive
- 118 federal monies and for all state procurements and construction
- 119 projects for the purpose of ensuring that minority business
- 120 enterprises are provided an adequate opportunity to participate
- 121 fairly in the distribution of such federal monies and in the
- 122 awarding of such procurement and construction contracts.
- 123 SECTION 2. This act shall take effect and be in force from
- 124 and after July 1, 2005.
