## HOUSE BILL NO. 513

1 2 3 4	AN ACT TO AMEND SECTION 37-106-31, MISSISSIPPI CODE OF 1972, TO DECREASE FROM 29 TO 26 THE MINIMUM ACT SCORE REQUIRED FOR STUDENTS TO BE ELIGIBLE FOR A SCHOLARSHIP UNDER THE MISSISSIPPI EMINENT SCHOLARS PROGRAM; AND FOR RELATED PURPOSES.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI
6	SECTION 1. Section 37-106-31, Mississippi Code of 1972, is
7	amended as follows:
8	37-106-31. (1) There is created a Mississippi Eminent
9	Scholars Fund, to be administered by the Mississippi Postsecondary
10	Education Financial Assistance Board established under Section
11	37-106-9. The board shall set the date that will serve as the
12	deadline for applying for an award under this section and award
13	scholarships to each Mississippi student who:
14	(a) (i) Is recognized by the merit or achievement
15	programs of the National Merit Scholarship Corporation or the
16	National Achievement Scholarship as a semifinalist or finalist,
17	and has obtained a minimum cumulative grade point average of 3.5
18	calculated on a 4.0 scale in high school subjects acceptable for
19	credit toward a diploma, after seven (7) semesters certified by
20	the high school counselor or other authorized school official on
21	the application, and graduation from high school verified by the
22	institution before disbursement of award; or
23	(ii) Has scored twenty-six (26) on the American
24	College Testing Program or its equivalent, and has obtained a
25	minimum cumulative grade point average of 3.5 calculated on a 4.0
26	scale after seven (7) semesters certified by the high school
27	counselor or other authorized school official on the application,

and graduation from high school verified by the institution before

- 29 disbursement of award, or the equivalent in high school subjects
- 30 acceptable for credit toward a diploma; or
- 31 (iii) Has attended a home education program during
- 32 grade levels 9 through 12 and has scored twenty-six (26) on the
- 33 American College Testing Program or its equivalent; and
- 34 (iv) Has been certified by the college or
- 35 university to the Mississippi Postsecondary Education Financial
- 36 Assistance Board as a Mississippi Eminent Scholar.
- 37 (b) Meets the general requirements for student
- 38 eligibility, except as otherwise provided in this section.
- 39 (c) Dependents of Mississippi residents who are on
- 40 military or public service assignments away from Mississippi when
- 41 such dependents live with such Mississippi residents and receive
- 42 high school diplomas from non-Mississippi schools shall be
- 43 exempted from certain requirements by the board.
- (d) Files, before the deadline, an application for an
- 45 award during his last year in high school, or before the
- 46 expiration of the third school year succeeding the year of his
- 47 high school graduation.
- (e) Attends, on a full-time basis, any state
- 49 institution of higher learning or public community or junior
- 50 college, or any regionally accredited, state-approved, nonprofit
- 51 four- or two-year college or university located in the State of
- 52 Mississippi as listed in subsection (4)(d) of Section 37-106-29.
- (f) Enrolls for the first time as a college student in
- 54 Mississippi. Any student who earns postsecondary academic credit
- 55 prior to or during the summer immediately subsequent to receiving
- 56 a high school diploma, who is dually enrolled in secondary and
- 57 postsecondary educational institutions, or who is enrolled in the
- 58 early admission program of a postsecondary institution shall be
- 59 exempt from this requirement.
- 60 (g) Is a resident of the State of Mississippi.
- 61 Residency status for purposes of receiving grants under this

- 62 section shall be determined in the same manner as resident status
- 63 for tuition purposes as set forth in Sections 37-103-1 through
- 37-103-29, with the exception of Section 37-103-17.
- (2) (a) Students who apply for awards but do not accept
- 66 their initial awards may reapply to receive awards during
- 67 subsequent application periods occurring before the expiration of
- 68 the third school year succeeding the year of their high school
- 69 graduation. Similarly, students who receive initial awards and
- 70 who later do not accept renewal awards may reapply to receive
- 71 awards during subsequent application periods occurring before the
- 72 expiration of the third school year succeeding the year of their
- 73 high school graduation. The institution shall accept
- 74 reinstatement applications according to dates set by the
- 75 Mississippi Postsecondary Education Financial Assistance Board and
- 76 shall determine the eligibility of such applicants in the same
- 77 manner as first-time applicants, except that students who apply
- 78 pursuant to this paragraph shall be required to have maintained
- 79 the equivalent of a 3.5 cumulative grade point average on a 4.0
- 80 scale for all college work attempted. The board shall not make
- 81 awards to reinstatement applicants who submit applications that
- 82 are received after the deadline set by the Mississippi
- 83 Postsecondary Education Financial Assistance Board.
- 84 (b) The board shall create a renewal application for
- 85 each student who received the award for one or more terms during
- 86 the immediately preceding academic year.
- 87 (3) (a) The annual award to a student shall be up to Two
- 88 Thousand Five Hundred Dollars (\$2,500.00) for tuition and fees.
- 89 Payment of the Mississippi Eminent Scholars Grant shall be made
- 90 payable to the recipient and the educational institution and
- 91 mailed directly to the institution, to be applied first to
- 92 tuition.
- 93 (b) Within six (6) weeks of the end of regular
- 94 registration, inclusive of a drop-add period, institutions shall

95 certify to the board the eligibility status of each awarded 96 student. The eligibility status of each student to receive a 97 disbursement shall be determined by each institution as of this 98 Institutions shall not be required to reevaluate a 99 student's eligibility status after this date for purposes of 100 amending eligibility determinations previously made. However, an 101 institution shall be requested to make refunds for students who 102 receive award disbursements and terminate enrollment for any 103 reason during the academic term when an institution's refund 104 policies permit a student to receive a refund under the 105 circumstances.

- 106 Institutions shall certify to the board the amount 107 of funds disbursed to each student and shall remit to the board 108 any undisbursed advances within sixty (60) days of the end of 109 regular registration.
- A recipient shall maintain the equivalent of a 3.5 110 111 cumulative grade point average on a 4.0 scale, or shall maintain 112 an approved equivalent student progress evaluation plan, on at least twelve (12) hours per quarter, trimester or semester in 113 114 order to be eligible for a continuation of the award. No student may receive a Mississippi Eminent Scholars Fund award for more 115 116 than the equivalent semesters or quarters required to complete one (1) degree or certificate program per institution. 117 The award may 118 be renewed annually upon certification of eligibility by the 119 eligible institutions that the recipient meets the necessary qualifications. If any recipient transfers from one university, 120 121 community college or junior college to another, his award will be 122 transferable, provided he is otherwise eligible for the award. a student fails to maintain continuous enrollment, and is not 123 granted an exception for cause by the administering agency, the 124 125 student is ineligible to receive the Mississippi Eminent Scholars 126 Grant during the following semester or trimester or term of the 127

regular academic year.

128	(5) The board may conduct its own annual audits of any
129	institution participating in the Mississippi Eminent Scholars
130	Grant Program. The board may suspend or revoke an institution's
131	eligibility to receive future monies under the program if it finds
132	that the institution has not complied with the provisions of this

- 134 (6) For purposes of this section, certificated shall mean,
  135 but not be limited to, all postsecondary vocational programs in
  136 eligible institutions as identified in subsection (4)(d) of
  137 Section 37-106-29.
- 138 **SECTION 2.** This act shall take effect and be in force from and after July 1, 2005.
