- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 9 **SECTION 1.** Section 19-31-51, Mississippi Code of 1972, is
- 10 amended as follows:
- 11 19-31-51. (1) No public improvement district established
- 12 under this chapter shall provide any utility service described in
- 13 Section 77-3-3(d) to or for the public for compensation without
- 14 first obtaining a certificate of public convenience and necessity
- 15 from the Public Service Commission.
- 16 (2) Nothing contained in this section shall prohibit the
- 17 Public Service Commission from issuing a certificate of public
- 18 convenience and necessity to any person for service in
- 19 uncertificated areas within public improvement district
- 20 boundaries.
- 21 (3) Notwithstanding any law to the contrary, water and/or
- 22 sewer districts that petition the Public Service Commission for a
- 23 certificate of public convenience and necessity for any
- 24 uncertificated area shall give written notice. Such notice may be
- 25 given by publication of a display advertisement that is two (2)
- 26 columns wide by five (5) inches deep one (1) time in a newspaper
- 27 of general circulation within the county or counties wherein the
- 28 described district is located or by regular mail to all property
- 29 owners located in such area, as reflected on the tax rolls of the

- 30 county or counties at the time of filing the petition, at the
- 31 address listed on the tax rolls of the county or counties within
- 32 such area, and to public improvement districts and other public
- 33 entities located in such area. Such notice shall give the
- 34 property owners and the governmental entities instructions on how
- 35 they may appear before the Public Service Commission and make any
- 36 objections or otherwise participate as an interested party.
- 37 **SECTION 2.** This act shall take effect and be in force from
- 38 and after July 1, 2005.
