HOUSE BILL NO. 626

AN ACT TO AMEND SECTION 27-104-13, MISSISSIPPI CODE OF 1972, TO CLARIFY THAT THE STATE FISCAL OFFICER HAS THE DISCRETION TO 3 REDUCE AND REVISE THE ESTIMATES OF FUNDS FOR ANY AGENCY IF AT ANY TIME HE FINDS THAT FUNDS WILL NOT BE AVAILABLE WITHIN THE PERIOD FOR WHICH THE BUDGET IS DRAWN; TO MOVE INTO THIS CODE SECTION THE 6 LANGUAGE FROM SECTION 31-17-123, MISSISSIPPI CODE OF 1972, THAT 7 REQUIRES THE STATE FISCAL OFFICER TO REDUCE ALLOCATIONS OF FUNDS 8 TO AGENCIES AT THE END OF OCTOBER IF THE REVENUES FALL BELOW 98% OF THE SINE DIE GENERAL FUND REVENUE ESTIMATE; TO AMEND SECTION 9 31-17-123, MISSISSIPPI CODE OF 1972, TO DELETE THE LANGUAGE THAT 10 IS MOVED TO THE PRECEDING SECTION; AND FOR RELATED PURPOSES. 11

- 12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 13 **SECTION 1.** Section 27-104-13, Mississippi Code of 1972, is
- 14 amended as follows:
- 15 27-104-13. (1) The State Fiscal Officer may disapprove or
- 16 reduce and revise the estimates of general funds and state-source
- 17 special funds for any general fund or special fund agency and for
- 18 the "administration and other expenses" budget of the Mississippi
- 19 Department of Transportation, in an amount not to exceed five
- 20 percent (5%), if at any time he finds that funds will not be
- 21 available within the period for which the budget is drawn, or if
- 22 at any time he finds that the requested expenditures, or any part
- 23 thereof, are not authorized by law, and that action shall be
- 24 reported to the Legislative Budget Office.
- 25 The State Fiscal Officer may, upon his determination of need
- 26 based upon a finding that funds will not be available within the
- 27 period for which the budget is drawn, transfer funds as provided
- 28 in Section 27-103-203, from the Working Cash-Stabilization Reserve
- 29 Fund to the General Fund to supplement the general fund revenue.
- If the estimates of general funds and state-source special
- 31 funds of all general fund and special fund agencies and of the
