- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 5 **SECTION 1.** Section 93-1-5, Mississippi Code of 1972, is
- 6 amended as follows:
- 7 93-1-5. It shall be unlawful for the circuit court clerk to
- 8 issue a marriage license until the following conditions precedent
- 9 have been complied with:
- 10 (a) Parties desiring a marriage license shall make
- 11 application therefor in writing to the clerk of the circuit court
- 12 of any county in the state of Mississippi; provided, however, that
- if the female applicant shall be under the age of twenty-one (21)
- 14 years and shall be a resident of the State of Mississippi, said
- 15 application shall be made to the circuit court clerk of the county
- 16 of residence of such female applicant. Said application shall be
- 17 forthwith filed with the circuit court clerk and shall include the
- 18 names, ages and addresses of the parties applying; the names and
- 19 addresses of the parents of the parties applying, and if no
- 20 parents, then names and addresses of the guardian or next of kin;
- 21 the signatures of witnesses; and any other data which may be
- 22 required by law or the Mississippi State Board of Health. The
- 23 application shall be sworn to by both applicants.
- 24 (b) The application shall remain on file, open to the
- 25 public, in the office of the circuit court clerk for a period of
- 26 three (3) days before the clerk is authorized to issue the
- 27 marriage license. Provided, however, that if satisfactory proof

is furnished to the judge of any circuit, chancery or county court 28 29 that sufficient reasons exist, then the judge of any such court in 30 the judicial district where either of such parties resides if they be over the age of twenty-one (21) years, or where the female 31 32 resides if she be under the age of twenty-one (21), may waive the 33 three-day waiting period and by written instrument authorize the 34 clerk of the court to issue the marriage license to the parties if they are otherwise qualified by law. Authorization shall be a 35 part of the confidential files of the clerk of the court, subject 36 37 to inspection only by written permission of the judge. If either 38 of the applying parties appears from the evidence to be under twenty-one (21) years of age, the circuit court clerk, immediately 39 40 upon filing the application, shall cause notice of the filing of 41 said application to be sent by prepaid certified mail to the father, mother, guardian or next of kin of both applying parties 42 at the address named in said application. 43 44 An affidavit showing the age of both applying parties shall be made by either the father, mother, guardian or 45 next of kin of each of the contracting parties and filed with the

46 47 clerk of the circuit court along with the application; or in lieu 48 thereof, said both applying parties shall appear in person before 49 the circuit court clerk and make and subscribe an oath in person, which said affidavit shall be attached to and noted on the 50 51 application for the marriage license. In addition to either of 52 the previous conditions stated, further proof of age shall be presented to the circuit court clerk in the form of either a birth 53 54 certificate, baptismal record, armed service discharge, armed 55 service identification card, life insurance policy, insurance certificate, school record, driver's license, or other official 56 document evidencing age. Said document substantiating age and 57 58 date of birth shall be examined by the circuit court clerk before 59 whom application is made, and the circuit court clerk shall retain

- 60 in his file with the application such document or a certified or
- 61 photostatic copy thereof.
- (d) The clerk shall not issue a marriage license under
- 63 the provisions of this section unless the male applicant is at
- 64 least seventeen (17) years of age, and the female is at least
- 65 fifteen (15) years of age; provided, however, that if satisfactory
- 66 proof is furnished to the judge of any circuit, chancery or county
- 67 court that sufficient reasons exist and that said parties desire
- 68 to be married to each other and that the parents or other person
- 69 in loco parentis of the person or persons so under age consent
- 70 thereto, then the judge of any such court in the county where
- 71 either of such parties resides may waive the minimum age
- 72 requirement and by written instrument authorize the clerk of the
- 73 court to issue the marriage license to the parties if they are
- 74 otherwise qualified by law. Authorization shall be a part of the
- 75 confidential files of the clerk of the court, subject to
- 76 inspection only by written permission of the judge.
- 77 (e) A medical certificate dated within thirty (30) days
- 78 prior to the application shall be presented to the circuit court
- 79 clerk showing that the applicant is free from syphilis, as nearly
- 80 as can be determined by a blood test performed in a laboratory
- 81 approved by the State Board of Health. The medical certificate
- 82 may be obtained through the local health department by the
- 83 applicant or applicants, or it may be obtained through any private
- 84 laboratory approved by the State Board of Health. Said medical
- 85 certificate shall be examined by the circuit court clerk and filed
- 86 in a permanent file kept by the clerk for this purpose.
- 87 (f) In no event shall a license be issued by the
- 88 circuit court clerk when it appears to the circuit court clerk
- 89 that the applicants are, or either of them is, drunk, insane or an
- 90 imbecile.
- 91 (g) Every license issued by the circuit court clerk
- 92 shall be accompanied by a family life guide designed by a licensed

- 94 include the responsibilities of the partners to each other and to
- 95 their offspring.
- 96 Any circuit clerk shall be liable under his official bond
- 97 because of noncompliance with the provisions of this section.
- 98 Any circuit court clerk who issues a marriage license without
- 99 complying with the provisions of this section shall be guilty of a
- 100 misdemeanor, and upon conviction shall be punished by a fine of
- 101 not less than Fifty Dollars (\$50.00) and not more than Five
- 102 Hundred Dollars (\$500.00).
- 103 SECTION 2. This act shall take effect and be in force from
- 104 and after July 1, 2005.
