## HOUSE BILL NO. 954 (As Passed the House)

1	AN ACT TO AUTHORIZE THE DEPARTMENT OF FINANCE AND
2	ADMINISTRATION, ACTING ON BEHALF OF THE DEPARTMENT OF WILDLIFE,
3	FISHERIES AND PARKS, TO SELL AND CONVEY CERTAIN STATE-OWNED REAL
4	PROPERTY LOCATED IN ALCORN COUNTY, MISSISSIPPI; TO AUTHORIZE THE
5	MISSISSIPPI DEPARTMENT OF TRANSPORTATION TO CONVEY CERTAIN REAL
5	PROPERTY TO THE CITY OF BROOKHAVEN, LINCOLN COUNTY, MISSISSIPPI;
7	AND FOR RELATED PURPOSES.

- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 9 **SECTION 1.** (1) The Department of Finance and
- 10 Administration, acting on behalf of the Department of Wildlife,
- 11 Fisheries and Parks, upon meeting the requirements of Section
- 12 29-1-1, may sell and convey to any interested person, group,
- 13 organization, company, corporation or other entity certain
- 14 state-owned real property, and the improvements thereon, located
- 15 in Alcorn County, Mississippi, and being more particularly
- 16 described as follows:
- 17 A parcel not to exceed one and one-half (1-1/2) acres in
- 18 the NW 1/4 of the NW 1/4 of the SW 1/4 of the SW 1/4 of
- 19 Section 32, Township 1S, Range 7E, Alcorn County,
- Mississippi.
- 21 The Department of Finance and Administration may have the parcel
- 22 of property surveyed.
- 23 (2) The real property, and the improvements thereon,
- 24 described in subsection (1) of this section shall be sold for not
- 25 less than the current fair market value as determined by the
- 26 averaging of at least two (2) appraisals by qualified appraisers
- 27 who shall be selected by the Department of Finance and
- 28 Administration and shall be certified and licensed by the

- 29 Mississippi Real Estate Appraiser Licensing and Certification
- 30 Board.
- 31 (3) Any funds received by the State of Mississippi for the
- 32 conveyance of the real property, and the improvements thereon,
- 33 described in subsection (1) of this section shall be deposited to
- 34 the credit of the Mississippi Department of Wildlife, Fisheries
- 35 and Parks, and such funds shall be used for the benefit of the
- 36 Tuscumbia Wildlife Management Area.
- 37 (4) The State of Mississippi shall retain all mineral rights
- 38 to the real property sold pursuant to this section.
- 39 **SECTION 2.** (1) The Mississippi Department of
- 40 Transportation, upon meeting the requirements of Section 29-1-1,
- 41 may convey to the City of Brookhaven the Mississippi Department of
- 42 Transportation maintenance facility and the property on which it
- 43 sits located on Hartman Street in Brookhaven, Mississippi,
- 44 described more specifically as follows:
- 45 2.63 acres, more or less, situated in Lot 7 of the Price
- 46 Estate, City of Brookhaven, said lands are situated in
- 47 the Southwest 1/4 of the Southeast 1/4 of Section 12,
- Township 7 North, Range 7 East, Lincoln County,
- 49 Mississippi and described in particular as follows:
- 50 Commencing at a nail in the center of Hartman Street
- 51 marking the Northeast corner of the Southwest 1/4 of the

- 64 (2) The conveyance authorized in this section may be made on
- 65 such terms and conditions agreed upon by the Mississippi
- 66 Department of Transportation and the City of Brookhaven, Lincoln
- 67 County.
- 68 (3) Any funds received by the State of Mississippi for the
- 69 conveyance of the real property described in subsection (1) of
- 70 this section shall be deposited into the State General Fund.
- 71 (4) The State of Mississippi shall retain all mineral rights
- 72 to the real property conveyed pursuant to this section.
- 73 **SECTION 3.** This act shall take effect and be in force from
- 74 and after its passage.
