- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5
- SECTION 1. Section 63-1-43, Mississippi Code of 1972, is 6
- amended as follows: 7
- 63-1-43. (1) The fee for receiving the application and 8
- 9 issuing the regular driver's or operator's license and the fee for
- 10 renewing the license shall be:
- (a) Nineteen Dollars (\$19.00) plus the applicable 11
- photograph fee for each applicant for a four-year license. One 12
- Dollar (\$1.00) of this fee shall be deposited into the statewide 13
- Litter Prevention Fund created by Section 65-1-167; 14
- Four Dollars (\$4.00) plus the applicable photograph fee 15
- for each applicant for a one-year license, except as provided in 16
- paragraph (c) of this subsection. One Dollars (\$1.00) of this fee 17
- shall be deposited into the statewide Litter Prevention Fund 18
- 19 created by Section 65-1-167; and
- Nine Dollars (\$9.00) plus the applicable photograph 20
- 21 fee for a one-year license for each applicant who is not a United
- States citizen and who does not possess a social security number 22
- issued by the United States government. One Dollar (\$1.00) of 23
- 24 this fee shall be deposited into the Statewide Litter Prevention
- Fund created by Section 65-1-167. 25
- 26 All originals and renewals of regular operators' licenses
- shall be in compliance with Section 63-1-47. 27

- The fee for receiving the application and issuing a 28 29 motorcycle endorsement shall be Six Dollars (\$6.00). One dollar (\$1.00) of this fee shall be deposited into the Statewide Litter 30 Prevention Fund created by Section 65-1-167. Motorcycle 31 endorsements shall be valid for the same period of time as the 32 33 applicant's operator's license. 34 The fee for receiving the application and issuing a restricted motorcycle operator's license and the fee for renewing 35 such license shall be: 36 Twelve Dollars (\$12.00) plus the applicable 37 (a) 38 photograph fee for a four-year license. One Dollar (\$1.00) of this fee shall be deposited into the Statewide Litter Prevention 39 40 Fund created by Section 65-1-167; and Nine Dollars (\$9.00) plus the applicable photograph 41 (b) fee for a one (1) year license. One Dollar (\$1.00) of this fee 42 shall be deposited into the Statewide Litter Prevention Fund 43 44 created by Section 65-1-167. 45 All originals and renewals of restricted motorcycle licenses shall be valid for the same period of time that an original 46 47 regular driver's license may be issued to such person in compliance with Section 63-1-47. 48 (4) From and after January 1, 1990, every person who makes 49 50 application for an original license or a renewal license to 51 operate a vehicle as a common carrier by motor vehicle, taxicab, 52 passenger coach, dray, contract carrier or private commercial carrier as such terms are defined in Section 27-19-3, except for 53 54 those vehicles for which a Class A, B or C license is required under Article 2 of this chapter, shall, in lieu of the regular 55 driver's license above provided for, apply for and obtain a Class 56
- Class D commercial driver's license shall be Twenty-four Dollars

- 80 period of one (1) year for a fee of Nine Dollars (\$9.00) plus the
- 81 applicable photograph fee and shall expire one (1) year from the
- 82 date of issuance. One Dollar (\$1.00) of this fee shall be
- 83 deposited into the Statewide Litter Prevention Fund created by
- 84 Section 65-1-167. Such person may renew a commercial license
- 85 issued under this section within thirty (30) days of expiration of
- 86 the license.
- 87 (6) The Commissioner of Public Safety, by rule or
- 88 regulation, shall establish a driver's license photograph fee
- 89 which shall be the actual cost of the photograph rounded off to
- 90 the next highest dollar. Monies collected for the photograph fee
- 91 shall be deposited into a special photograph fee account which the
- 92 Department of Public Safety shall use to pay the actual cost of
- 93 producing the photographs. Any monies collected in excess of the

- 94 actual costs of the photography shall be deposited to the General
- 95 Fund of the State of Mississippi.
- 96 **SECTION 2.** Section 63-1-81, Mississippi Code of 1972, is
- 97 amended as follows:
- 98 63-1-81. (1) Each application for a commercial driver's
- 99 license or commercial driver instruction permit shall include the
- 100 following:
- 101 (a) The full name and the current mailing and
- 102 residential address of the applicant;
- 103 (b) A physical description of the applicant, including
- 104 sex, height, weight, eye and hair color;
- 105 (c) The applicant's date of birth;
- 106 (d) The applicant's social security number unless the
- 107 application is for a nonresident commercial driver's license;
- 108 (e) The applicant's signature;
- 109 (f) The applicant's color photograph;
- 110 (g) All certifications required by applicable federal
- 111 regulations;
- (h) Any other information which the Commissioner of
- 113 Public Safety, by rule or regulation, determines necessary and
- 114 essential; and
- (i) The consent of the applicant to release driving
- 116 record information.
- 117 (2) The fee for accepting and processing an application for
- 118 a commercial driver instruction permit shall be Eleven Dollars
- 119 (\$11.00). One Dollar (\$1.00) of this fee shall be deposited into
- 120 the Statewide Litter Prevention Fund created by Section 65-1-167.
- 121 (3) The fee for accepting and processing an application for
- 122 a Class A, B or C commercial driver's license shall be Twenty-six
- Dollars (\$26.00). One Dollar (\$1.00) of this fee shall be
- 124 deposited into the Statewide Litter Prevention Fund created by
- 125 <u>Section 65-1-167</u>.

- (4) No person who has been a resident of this state for thirty (30) days may drive a commercial motor vehicle under the authority of a commercial driver's license issued by another jurisdiction. Any violation of this subsection shall be punishable as provided by Section 63-1-69, Mississippi Code of
- (5) Any person who knowingly falsifies information or
 certifications required under subsection (1) of this section shall
 be subject to the penalties prescribed in Section 63-1-59,
 Mississippi Code of 1972, and shall be subject to suspension of
 his commercial driver instruction permit or commercial driver's
 license in accordance with Section 63-1-51, Mississippi Code of
- 139 (6) Each application or filing made under this section shall 140 include the social security number(s) of the applicant in 141 accordance with Section 93-11-64, Mississippi Code of 1972.
 - (7) (a) Any male who is at least eighteen (18) years of age but less than twenty-six (26) years of age and who applies for a commercial license or renewal of a commercial license under this article shall be registered in compliance with the requirements of Section 3 of the Military Selective Service Act, 50 USCS Appx 451 et seq., as amended.
- The department shall forward in an electronic 148 (b) 149 format the necessary personal information of the applicant to the 150 Selective Service System. The applicant's submission of the application shall serve as an indication that the applicant either 151 152 has already registered with the Selective Service System or that 153 he is authorizing the department to forward to the Selective Service System the necessary information for registration. 154 155 commissioner shall notify the applicant on, or as a part of, the 156 application that his submission of the application will serve as 157 his consent to registration with the Selective Service System, if 158 The commissioner also shall notify any male so required.
