1 2 3 4	AN ACT TO AMEND SECTION 45-11-101, MISSISSIPPI CODE OF 1972, TO ALLOW THE STATE FIRE MARSHAL'S OFFICE TO INSPECT ALL SORORITY AND FRATERNITY HOUSES LOCATED ON STATE PROPERTY; AND FOR RELATED PURPOSES.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
6	SECTION 1. Section 45-11-101, Mississippi Code of 1972, is
7	amended as follows:
8	45-11-101. (1) The State Fire Marshal shall promulgate the
9	Mississippi Fire Prevention Code which shall apply to:
10	(a) All buildings owned by the state or state agencies;
11	(b) All buildings utilized for public assembly, except
12	in any county or municipality which has adopted a fire prevention
13	code with standards not less stringent than the Mississippi Fire
14	Prevention Code; however, the State Fire Marshal or his authorized
15	representative shall perform investigations or inspections of such
16	buildings only when advised by interested persons of a danger or
17	hazardous inflammable condition existing in any building that
18	would tend to impair the safety of persons or property, or when
19	the State Fire Marshal or his authorized representative believes
20	the investigation or inspection is in the interest of public
21	safety. The investigation or inspection shall be made in
22	accordance with Section 45-11-3;
23	(c) All buildings, the permits for the construction of
24	which are issued subsequent to the effective date of Sections
25	45-11-101 through 45-11-111 and which are not less than

seventy-five (75) feet in height; provided, however, that in any

county or municipality which has adopted a fire prevention code

with standards not less stringent than the Mississippi Fire

- 30 shall apply and not the Mississippi Fire Prevention Code;
- 31 (d) All buildings, the permits for construction of
- 32 which are issued subsequent to July 1, 2004, constructed as
- 33 private correctional facilities that house state inmates. Before
- 34 such construction, construction plans must be submitted for review
- 35 and approval to the State Fire Marshal's Office to ensure
- 36 compliance with the Mississippi Fire Prevention Code; however, in
- 37 any county or municipality that has adopted a fire prevention code
- 38 with standards not less stringent than the Mississippi Fire
- 39 Prevention Code, the provisions and enforcement mechanism thereof
- 40 shall apply instead of the Mississippi Fire Prevention Code. All
- 41 private correctional facilities may be inspected as required by
- 42 the State Fire Marshal or his duly authorized representative.
- 43 Inspection fees and expenses authorized by Section 45-11-105(2)
- 44 shall be assessed for each inspection conducted by the State Fire
- 45 Marshal's Office and shall be paid to the State Fire Marshal's
- 46 Office;
- 47 (e) Any buildings, the permits for construction of
- 48 which are issued subsequent to July 1, 2004, upon the request of
- 49 any interested person. The interested person may submit the
- 50 construction plans to the State Fire Marshal's Office for review
- 51 and approval before construction to ensure compliance with the
- 52 Mississippi Fire Prevention Code; however, in any county or
- 53 municipality that has adopted a fire prevention code with
- 54 standards not less stringent than the Mississippi Fire Prevention
- 55 Code, the provisions and enforcement mechanism thereof shall apply
- 56 instead of the Mississippi Fire Prevention Code. Inspection fees
- 57 and expenses authorized by Section 45-11-105(2) shall be assessed
- 58 for each inspection conducted by the State Fire Marshal's Office
- 59 and shall be paid to the State Fire Marshal's Office.
- (f) All buildings, the permits for construction of
- 61 which are issued subsequent to July 1, 2005, constructed as

- 62 private fraternity and sorority houses located on state property.
- 63 Before such construction, construction plans shall be submitted
- 64 for review and approval to the State Fire Marshal's office to
- 65 ensure compliance with the Mississippi Fire Prevention Code. All
- 66 private fraternity and sorority houses located on state property
- 67 may be inspected as required by the State Fire Marshal or his duly
- 68 authorized representative. All fraternity and sorority houses
- 69 located on state property shall be equipped with an approved fire
- 70 alarm and smoke detector system to be in compliance with the
- 71 National Fire Code (NFPA) Standard 72 as published by the National
- 72 Fire Protection Association and as same may be revised or amended.
- 73 Within five (5) years from July 1, 2005, all fraternity and
- 74 sorority houses located on state property shall be equipped with
- 75 an approved automatic fire sprinkler system to be in compliance
- 76 with the National Fire Code (NFPA) Standard 13 as published by the
- 77 National Fire Protection Association and as same may be revised or
- amended.
- 79 (2) The State Fire Marshal shall annually examine the fire
- 80 prevention codes adopted by counties and municipalities within the
- 81 State of Mississippi and prepare a list thereof specifying which
- 82 codes have provisions not less stringent than those of the
- 83 Mississippi Fire Prevention Code.
- 84 **SECTION 2.** This act shall take effect and be in force from
- 85 and after July 1, 2005.
