## HOUSE BILL NO. 1212

- AN ACT TO AMEND SECTION 39-5-5, MISSISSIPPI CODE OF 1972, TO 2 PROVIDE AN ADDITIONAL DUTY OF THE BOARD OF TRUSTEES OF THE
- 2 PROVIDE AN ADDITIONAL DUTY OF THE BOARD OF TRUSTEES OF THE 3 DEPARTMENT OF ARCHIVES AND HISTORY; TO REQUIRE THE BOARD TO
- 4 INVENTORY CERTAIN BUILDINGS IN THE MISSISSIPPI-YAZOO DELTA; AND
- 5 FOR RELATED PURPOSES.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 **SECTION 1.** Section 39-5-5, Mississippi Code of 1972, is
- 8 amended as follows:
- 9 39-5-5. The duties and powers of the Board of Trustees of
- 10 the Department of Archives and History shall include, in addition
- 11 to other duties and powers granted or prescribed by law, the
- 12 following:
- 13 (a) To determine the location of places of historical
- 14 interest within the state;
- 15 (b) To make a survey of buildings of all types
- 16 throughout the state which are in danger of destruction, without
- 17 proper care, and which in the opinion of the board of trustees
- 18 should be preserved for historical purposes;
- 19 (c) To contact the proper authorities of the United
- 20 States national cemeteries and military parks to determine whether
- 21 or not the record of Mississippi troops is adequately
- 22 commemorated;
- 23 (d) To acquire, preserve, restore or operate any real
- 24 or personal property deemed significant for historical,
- 25 architectural, archaeological or cultural reasons, to expend funds
- 26 for such purposes, to enter into contracts or agreements with any
- 27 agency of the United States or any person, firm, corporation or

- 28 association for such purposes and to do any and all things which
- 29 may be necessary or desirable to carry out such purposes;
- 30 (e) To participate with any agency of the United
- 31 States, any other governmental agency or any person, firm,
- 32 corporation, association or group in mutual or cooperative
- 33 programs or projects within the duties and powers of the board of
- 34 trustees;
- 35 (f) To accept grants or donations of money or property,
- 36 real or personal, from any agency of the United States, any other
- 37 governmental agency or any person, firm, corporation, association
- 38 or group. However, the board of trustees shall not be required,
- 39 except by specific act of the Legislature, to accept any property
- 40 without its consent; \* \* \*
- 41 (g) To provide suitable markers with adequate
- 42 descriptions of the historical sites to which they refer, for
- 43 places of historical interest and to provide suitable markers on
- 44 the highways and roads of this state showing the direction and
- 45 distance to the historical sites; and
- 46 (h) To inventory and assess all houses and buildings of
- 47 historical and architectural significance, located in the
- 48 Mississippi-Yazoo Delta, that are in danger of destruction or
- 49 <u>neglect.</u>
- 50 **SECTION 2.** This act shall take effect and be in force from
- 51 and after July 1, 2005.
