HOUSE BILL NO. 1405

AN ACT TO AMEND SECTIONS 37-140-1 THROUGH 37-140-15, 1 MISSISSIPPI CODE OF 1972, TO TRANSFER THE RESPONSIBILITIES OF THE 2 STATE BOARD OF EDUCATION RELATING TO THE ADMINISTRATION OF THE MISSISSIPPI SCHOOL OF THE ARTS TO THE BOARD OF TRUSTEES OF STATE 3 4 INSTITUTIONS OF HIGHER LEARNING ACTING THROUGH THE UNIVERSITY OF 5 6 SOUTHERN MISSISSIPPI; AND FOR RELATED PURPOSES. 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: SECTION 1. Section 37-140-1, Mississippi Code of 1972, is 8 amended as follows: 9 10 37-140-1. As used in this chapter, the following words and phrases shall have the meanings ascribed in this section unless 11 the context clearly indicates otherwise: 12 "Board" means the Board of Trustees of State 13 (a) Institutions of Higher Learning acting through the University of 14 Southern Mississippi. 15 "School" means the Mississippi School of the Arts. 16 (b) 17 SECTION 2. Section 37-140-3, Mississippi Code of 1972, is amended as follows: 18 37-140-3. (1) There is created the Mississippi School of 19 20 the Arts, which shall be a residential school for eleventh and twelfth grade high school students located on the campus of 21 22 Whitworth College in Brookhaven, Mississippi. The purpose of the school shall be to provide a more challenging educational 23 24 experience for artistically talented and gifted students of the state to develop their full potential, including the teaching of 25 humanities, creative writing, literature, theater, music, dance 26 27 and visual arts, and the school's curriculum and admissions policies shall reflect that purpose. 28

(2) The 2001-2002 school year shall be the first year that
the school shall admit students for enrollment, which shall be
limited to students in the eleventh grade during the school's
first year. Beginning with the 2002-2003 school year, the school
shall enroll students in the eleventh and twelfth grades.
(3) From and after July 1, 2005, all powers and duties
granted hereunder to the State Board of Education for the

36 <u>administration of the Mississippi School of the Arts shall be</u> 37 <u>transferred to the Board of Trustees of State Institutions of</u> 38 <u>Higher Learning. The board shall contract with the University of</u> 39 <u>Southern Mississippi for the administration of the Mississippi</u> 40 School of the Arts.

41 **SECTION 3.** Section 37-140-5, Mississippi Code of 1972, is 42 amended as follows:

43 37-140-5. (1) The school shall be governed by the <u>Board of</u> 44 <u>Trustees of State Institutions of Higher Learning acting through</u> 45 <u>the University of Southern Mississippi</u>. The board shall develop a 46 plan relating to the opening, operation and funding of the school 47 to be presented to the Legislature during the 2000 Regular 48 Session. The plan shall include an equitable and reasonable plan 49 for student recruitment without regard to race, creed or color.

50 (2) The <u>President of the University of Southern Mississippi</u> 51 shall appoint an advisory panel to assist the board in developing 52 the plan relating to the school. The advisory panel shall consist 53 of the following twelve (12) appointed or designated members, and 54 <u>may consist of the same members appointed by the State</u>

57 (a) Three (3) licensed school teachers or
58 administrators, one (1) to be appointed from each of the three (3)

62 arts or visual arts, one (1) to be appointed from each of the 63 three (3) Mississippi Supreme Court Districts;

(c) Three (3) citizens knowledgeable in business,
personnel management or public administration, with at least three
(3) years' actual experience therein, one (1) to be appointed from
each of the three (3) Mississippi Supreme Court Districts.

One (1) member shall be a representative of the 68 (d) Mississippi Arts Commission to be designated by the commission, 69 70 one (1) member shall be a representative of the Mississippi 71 Humanities Council to be designated by the council, and one (1) 72 member shall be a representative of the state institutions of higher learning in Mississippi which offer degrees in visual, fine 73 74 and performing arts, to be designated by the Board of Trustees of 75 State Institutions of Higher Learning.

76 Appointments to the advisory panel by the President of the 77 University of Southern Mississippi shall be made within ninety 78 (90) days of passage of this act. The advisory panel shall meet 79 upon the call of the President of the University of Southern Mississippi and shall organize for business by selecting a 80 81 chairman and vice chairman/secretary for keeping records of the panel. Members of the advisory panel shall receive no 82 83 compensation but may be reimbursed for necessary expenses and mileage for attending meetings and necessary business of the 84 85 panel, in the amount authorized for state employees under Section 86 25-3-41.

The board may utilize the staff of the Board of Trustees 87 (3) 88 of State Institutions of Higher Learning, the staff of the State 89 Department of Education and other state agencies as may be required for the implementation of this chapter. The board may 90 employ any personnel deemed necessary by the board for assisting 91 92 in the development and implementation of the plan relating to the 93 opening, operation and funding of the school. 95 entities which it deems necessary to carry out its duties and 96 functions relating to the opening and operation of the school.

97 (4) To the extent possible, the board shall enter into 98 agreements with the Board of Trustees of the Brookhaven Municipal 99 Separate School District for the dual enrollment of students for 100 the purpose of teaching academic courses to students attending the school, and the local school board shall be fully authorized to 101 offer any such courses to students attending the school. 102 The 103 Board of Trustees of State Institutions of Higher Learning acting through the University of Southern Mississippi may develop and 104 105 issue necessary regulations for the coordination of such courses 106 for these students, the preparation and transfer of transcripts, 107 and the reimbursement of any costs incurred by the school district for providing such services. 108

(5) The board may enter into agreements with public school districts to authorize students enrolled in such school districts to participate in the fine arts programs at the school to the extent that adequate space is available. The parent or guardian of any student participating in fine arts programs at the school under this subsection shall be responsible for transporting the student to and from the school.

SECTION 4. Section 37-140-7, Mississippi Code of 1972, is amended as follows:

Subject to the availability of funding 118 37-140-7. 119 appropriated therefor, the President of the University of Southern Mississippi, with the approval of the Board of Trustees of State 120 121 Institutions of Higher Learning, may hire a director of the 122 school, who shall serve at the will and pleasure of the Board of Trustees of State Institutions of Higher Learning acting through 123 the University of Southern Mississippi. The director shall be the 124 125 chief administrative officer of the school and shall administer 126 the school in accordance with the policies established by the 127 board. 128 duties and functions prescribed by the board, and the board, in 129 its discretion, may delegate to the director such powers and 130 duties as it deems appropriate.

131 SECTION 5. Section 37-140-9, Mississippi Code of 1972, is 132 amended as follows:

The Board of Trustees of State Institutions of 133 37-140-9. 134 Higher Learning acting through the University of Southern Mississippi shall be the exclusive governing body of the school 135 136 and shall promulgate rules and regulations required for the administration and operation of the school. The emphasis of the 137 138 school shall be on the education and training of students in the performing, visual and literary arts and in the humanities, but 139 140 this emphasis shall not preclude the teaching of those liberal 141 arts and science courses, math and science deemed necessary by the 142 board to provide students with a well-rounded education.

143 SECTION 6. Section 37-140-11, Mississippi Code of 1972, is 144 amended as follows:

145 37-140-11. The Board of Trustees of State Institutions of Higher Learning acting through the University of Southern 146 147 Mississippi shall prepare the annual budget for the school. For the operation and support of the school, the board may receive 148 149 contributions, donations, gifts, bequests of money, other forms of 150 financial assistance and property, equipment, materials or manpower from persons, foundations, trust funds, corporations, 151 152 organizations and other sources, public or private, to be expended and utilized by the board in carrying out this chapter. 153

154 SECTION 7. Section 37-140-13, Mississippi Code of 1972, is 155 brought forward as follows:

156 37-140-13. All expenditures for the school shall be paid by 157 the State Treasurer on warrants issued by the State Fiscal 158 Officer, and the State Fiscal Officer shall issue his warrants 159 upon requisition signed by the proper person, officer or officers.

160 SECTION 8. Section 37-140-15, Mississippi Code of 1972, is 161 amended as follows:

The Board of Trustees of State Institutions 162 37 - 140 - 15. (1) 163 of Higher Learning acting through the University of Southern 164 Mississippi may enter into agreements with the Mississippi 165 Symphony Orchestra for providing classical music educational 166 services to students in Grades Kindergarten through 12 at the Mississippi School of the Arts or at any other public school 167 168 facility in Mississippi, subject to specific appropriation therefor by the Legislature. Such educational services shall 169 170 include: (a) music history, music instrument and music performance instruction in the classroom; (b) symphony concerts 171 172 for the students, programmed to support and enhance the teaching of history, literature and science; (c) chamber ensemble and 173 chamber orchestra performances where members serve as educators as 174 well as performers; (d) organizing and developing student 175 176 performing ensembles, where members serve as music instrument 177 instructors, conductors and performers; (e) symphony concerts for students, parents and other residents to enhance the position of 178 179 the school as center of the local community; and (f) other services to be determined by agreement. 180

181 (2) The Board of Trustees of State Institutions of Higher 182 Learning acting through the University of Southern Mississippi is 183 encouraged to enter into contractual agreements with professional 184 arts organizations, including the Mississippi Museum of Art, New Stage Theatre and the Mississippi Symphony Orchestra, for 185 186 providing instruction, concerts, exhibits, performances and other 187 outreach programs at the Mississippi School of the Arts or at any other public school facility in Mississippi. 188

189 SECTION 9. This act shall take effect and be in force from 190 and after July 1, 2005.
