HOUSE BILL NO. 1413

1 AN ACT TO AUTHORIZE THE DEPARTMENT OF MENTAL HEALTH TO SELL 2 AND CONVEY CERTAIN PROPERTY IN SIMPSON COUNTY, MISSISSIPPI; AND 3 FOR RELATED PURPOSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: **SECTION 1.** (1) The Department of Finance and Administration may sell and convey certain real property and any improvements thereon, in Simpson County, Mississippi, the property being more particularly described as follows:

9 Begin at the SE Corner of the SW 1/4 of SE 1/4 of Section 3, Township 10 North, Range 18 West, and run 10 West 2174 feet; thence run North 1528.8 feet to the 11 North line of the SE 1/4 of SW 1/4; thence run East 12 13 1165.8 feet; thence run North 1528.8 feet; thence run West 293.8 feet; thence run North 1537 feet; thence run 14 East 726 feet; thence run North 585 feet; thence run 15 East 652 feet to the center of an old road; thence run 16 South 34 degrees East 279 feet along the center of said 17 old road; thence run South 51 degrees East 161 feet 18 along the center of said old road; thence run South 25 19 20 degrees East 216 feet along the center of said old road; 21 thence run South 7 degrees East 340 feet along the center of said old road; thence run South 46 degrees 22 East 30.3 feet along the center of said old road; thence 23 run South 13 degrees East 334 feet along the center of 24 said old road; thence run South 79 degrees East 232 feet 25 26 along the center of said old road; thence run South 80 27 degrees East 367 feet along the center of said old road

to a point where same intersects the East line of the SE 28 1/4 of NE 1/4; thence run South 527 feet along said East 29 line of SE 1/4 of NE 1/4 to the SE Corner of same; 30 thence run West 660 feet; thence run South 514 feet; 31 32 thence run West 660 feet to the East line of the NW 1/4of SE 1/4; thence run South 2570 feet back to the point 33 of beginning, containing 206.47 acres, more or less, and 34 being in the NE 1/4; the SE 1/4; and also in the SE 1/435 of SW 1/4 of Section 3, Township 10 North, Range 18 36 West, Simpson County, Mississippi. 37

38 (2) The sale and conveyance authorized in this section may be made on such terms and conditions established by the Department 39 of Mental Health to be in the best interests of the state. 40 The real property described in subsection (1) of this section shall be 41 sold for not less than the current fair market value as determined 42 by the averaging of at least two (2) appraisals by professional 43 appraisers who are licensed by the Mississippi Real Estate 44 45 Appraiser Licensing and Certification Board.

46 (3) Any funds received by the State of Mississippi for the
47 conveyance of the real property described in subsection (1) of
48 this section shall be deposited into the State General Fund.

49 (4) The State of Mississippi shall retain all mineral rights50 to the real property sold pursuant to this section.

51 **SECTION 2.** This act shall take effect and be in force from 52 and after its passage.
