40 With the funds herein appropriated, it is the intention of the Legislature that it shall be the agency's responsibility to 41 make certain that funds required to be appropriated for "Personal 42 Services" for Fiscal Year 2007 do not exceed Fiscal Year 2006 43 44 funds appropriated for that purpose, unless programs or positions 45 are added to the agency's Fiscal Year 2007 budget by the Mississippi Legislature. Based on data provided by the 46 47 Legislative Budget Office, the State Personnel Board shall 48 determine and publish the projected annual cost to fully fund all 49 appropriated positions in compliance with the provisions of this It shall be the responsibility of the agency head to insure 50 act. 51 that no single personnel action increases this projected annual 52 cost and/or the Fiscal Year 2006 appropriation for "Personal Services" when annualized, with the exception of escalated funds. 53 54 If, at the time the agency takes any action to change "Personal Services," the State Personnel Board determines that the agency 55 56 has taken an action which would cause the agency to exceed this projected annual cost or the Fiscal Year 2006 "Personal Services" 57 58 appropriated level, when annualized, then only those actions which 59 reduce the projected annual cost and/or the appropriation

62 Any transfers or escalations shall be made in accordance with 63 the terms, conditions and procedures established by law or 64 allowable under the terms set forth within this act. The State 65 Personnel Board shall not escalate positions without written approval from the Department of Finance and Administration. 66 The Department of Finance and Administration shall not provide written 67 approval to escalate any funds for salaries and/or positions 68 69 without proof of availability of new or additional funds above the 70 appropriated level.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

75 SECTION 3. It is the intention of the Legislature that the 76 Mississippi Veterans Memorial Stadium Commission shall maintain 77 complete accounting and personnel records related to the expenditure of all funds appropriated under this act and that such 78 79 records shall be in the same format and level of detail as maintained for Fiscal Year 2005. It is further the intention of 80 81 the Legislature that the agency's budget request for Fiscal Year 2007 shall be submitted to the Joint Legislative Budget Committee 82 83 in a format and level of detail comparable to the format and level of detail provided during the Fiscal Year 2006 budget request 84 85 process.

SECTION 4. The money herein appropriated shall be paid by the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers, in the manner provided by law.
