Of the funds appropriated in Section 1, office expenses and such funds for salaries shall be provided as authorized in Section 25-3-35(6), Mississippi Code of 1972, to fund the salary for one (1) full-time legal assistant in the Sixth Circuit Court District as authorized in Section 25-31-5(2)(f), Mississippi Code of 1972.

SECTION 4. The money herein appropriated shall be paid by 34 the State Treasurer out of any money in the State Treasury to the 35 credit of the proper fund or funds as set forth in this act, upon 36 warrants issued by the State Fiscal Officer; and the State Fiscal 37 38 Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers, in the manner provided by law. 39 SECTION 5. This act shall take effect and be in force from 40 and after July 1, 2005. 41
