accounting and personnel records related to the expenditure of all 29 30 funds appropriated under this act and that such records shall be in the same format and level of detail as maintained for Fiscal 31 32 Year 2005. It is further the intention of the Legislature that 33 the agency's budget request for Fiscal Year 2007 shall be 34 submitted to the Joint Legislative Budget Committee in a format and level of detail comparable to the format and level of detail 35 provided during the Fiscal Year 2006 budget request process. 36 SECTION 4. The money herein appropriated shall be paid by 37 the State Treasurer out of any money in the State Treasury to the 38 39 credit of the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal 40 Officer shall issue his warrants upon requisitions signed by the 41 proper person, officer or officers, in the manner provided by law. 42 SECTION 5.
