## HOUSE CONCURRENT RESOLUTION NO. 83

A CONCURRENT RESOLUTION SUSPENDING THE DEADLINES FOR THE PURPOSE OF REQUESTING THE DRAFTING, AND THE INTRODUCTION, 3 CONSIDERATION AND PASSAGE, OF A BILL ENTITLED "AN ACT TO IMPOSE AND LEVY AN EXCISE TAX UPON THE POSSESSION OF UNAUTHORIZED SUBSTANCES; TO PRESCRIBE THE RATE OF TAX THAT SHALL BE IMPOSED UPON UNAUTHORIZED SUBSTANCES; TO PROVIDE THAT THE TAX SHALL NOT 7 APPLY TO ANY MATERIAL, COMPOUND, MIXTURE OR PREPARATION THAT CONTAINS ANY QUANTITY OF A CONTROLLED SUBSTANCE THAT IS LISTED AS EXEMPT UNDER THE UNIFORM CONTROLLED SUBSTANCES LAW OR TO ANY 8 9 10 GOVERNMENTAL ENTITY POSSESSING A CONTROLLED SUBSTANCE FOR THE 11 PURPOSE OF RESEARCH; TO PROVIDE THAT THE STATE TAX COMMISSION SHALL ISSUE STAMPS TO AFFIX TO UNAUTHORIZED SUBSTANCES TO INDICATE 12 PAYMENT OF THE TAX IMPOSED UNDER THIS ACT; TO REQUIRE LAW ENFORCEMENT AGENCIES TO REPORT TO THE STATE TAX COMMISSION THE 13 14 SEIZURE OF AN UNAUTHORIZED SUBSTANCE OR THE MAKING OF AN ARREST OF 15 A PERSON IN POSSESSION OF AN UNAUTHORIZED SUBSTANCE UPON WHICH A 16 STAMP HAS NOT BEEN AFFIXED AS REQUIRED BY THIS ACT; TO PRESCRIBE 17 THE MANNER AND PROCEDURE BY WHICH THE TAXES IMPOSED UNDER THIS ACT 18 SHALL BE COLLECTED AND PAID; TO PROVIDE FOR THE IMPOSITION OF 19 20 PENALTIES AND INTERESTS UPON PERSONS WHO FAIL TIMELY TO PAY THE TAXES IMPOSED UNDER THIS ACT; TO PROHIBIT DISCLOSURE OF THE 21 IDENTITY OF PERSONS WHO PAY SUCH TAXES AND PURCHASE THE STAMPS AND TO PROHIBIT USE OF SUCH INFORMATION TO CRIMINALLY PROSECUTE SUCH 22 23 PERSONS FOR THE UNLAWFUL POSSESSION OF UNAUTHORIZED SUBSTANCES; TO 24 25 PROVIDE FOR THE DEPOSIT OF UNENCUMBERED PROCEEDS FROM THE TAXES LEVIED UNDER THIS ACT INTO THE STATE GENERAL FUND; TO AUTHORIZE 26 THE STATE TAX COMMISSION TO PROMULGATE AND ADOPT RULES AND REGULATIONS TO IMPLEMENT, ADMINISTER AND ENFORCE THE PROVISIONS OF 27 28 THIS ACT; TO BRING FORWARD SECTIONS 27-3-29, 27-3-31, 27-3-69, 29 30 27-3-80, 27-3-81, 41-29-105, 41-29-122, 41-29-139 AND 41-29-153, 31 MISSISSIPPI CODE OF 1972; AND FOR RELATED PURPOSES." 32 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF MISSISSIPPI, THE SENATE CONCURRING THEREIN, That the Joint 33 34 Rules of the House and the Senate, including all the deadlines and 35 other provisions imposed by Joint Rule No. 40, are suspended for 36 the purpose of requesting the drafting, and the introduction, consideration and passage, of a bill entitled "AN ACT TO IMPOSE 37 AND LEVY AN EXCISE TAX UPON THE POSSESSION OF UNAUTHORIZED 38 SUBSTANCES; TO PRESCRIBE THE RATE OF TAX THAT SHALL BE IMPOSED 39 40 UPON UNAUTHORIZED SUBSTANCES; TO PROVIDE THAT THE TAX SHALL NOT 41 APPLY TO ANY MATERIAL, COMPOUND, MIXTURE OR PREPARATION THAT

- 55 TAXES IMPOSED UNDER THIS ACT; TO PROHIBIT DISCLOSURE OF THE
- 56 IDENTITY OF PERSONS WHO PAY SUCH TAXES AND PURCHASE THE STAMPS AND
- 57 TO PROHIBIT USE OF SUCH INFORMATION TO CRIMINALLY PROSECUTE SUCH
- 58 PERSONS FOR THE UNLAWFUL POSSESSION OF UNAUTHORIZED SUBSTANCES; TO
- 59 PROVIDE FOR THE DEPOSIT OF UNENCUMBERED PROCEEDS FROM THE TAXES
