HOUSE CONCURRENT RESOLUTION NO. 92

1 A CONCURRENT RESOLUTION SUSPENDING THE DEADLINES FOR THE
2 PURPOSE OF REQUESTING THE DRAFTING, AND THE INTRODUCTION,
3 CONSIDERATION AND PASSAGE, OF A BILL ENTITLED "AN ACT TO AMEND
4 SECTION 71-5-503, MISSISSIPPI CODE OF 1972, TO INCREASE
5 UNEMPLOYMENT COMPENSATION BENEFITS; TO AMEND SECTION 71-5-511,
6 MISSISSIPPI CODE OF 1972, TO DELETE THE REQUIREMENT THAT AN
7 UNEMPLOYED INDIVIDUAL BE UNEMPLOYED FOR A WAITING PERIOD OF ONE
8 WEEK BEFORE HE IS ELIGIBLE FOR UNEMPLOYMENT COMPENSATION BENEFITS;

32 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE
33 OF MISSISSIPPI, THE SENATE CONCURRING THEREIN, That the Joint
34 Rules of the House and the Senate, including all the deadlines and
35 other provisions imposed by Joint Rule No. 40, are suspended for
36 the purpose of requesting the drafting, and the introduction,
37 consideration and passage, of a bill entitled "AN ACT TO AMEND
38 SECTION 71-5-503, MISSISSIPPI CODE OF 1972, TO INCREASE
39 UNEMPLOYMENT COMPENSATION BENEFITS; TO AMEND SECTION 71-5-511,
