SENATE BILL NO. 2140

- AN ACT TO AMEND SECTION 55-3-33, MISSISSIPPI CODE OF 1972, TO WAIVE THE PARK ENTRANCE FEE FOR PERSONS OVER 65 YEARS OF AGE OR DISABLED; AND FOR RELATED PURPOSES.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 5 **SECTION 1.** Section 55-3-33, Mississippi Code of 1972, is
- 6 amended as follows:
- 7 55-3-33. (1) The Mississippi Department of Wildlife,
- 8 Fisheries and Parks shall have the power and authority, and it
- 9 shall be its duty to:
- 10 (a) Take charge and have full jurisdiction and control
- 11 over all state parks, which * * * shall be operated for the
- 12 purpose of providing outdoor recreational activities and enjoyment
- 13 for the citizens of the State of Mississippi and for the purpose
- 14 of attracting visitors to the state.
- 15 (b) Set up a uniform accounting procedure for the state
- 16 parks and prescribe the manner in which books, records and
- 17 accounts shall be kept. The procedure shall account for all
- 18 monies taken in and expended by the various parks and shall
- 19 provide for periodic audits of such books.
- 20 (c) Accept gifts, bequests of money or other property,
- 21 real or personal, to be used for the purpose of advancing the
- 22 recreation and conservation interests in state parks. The
- 23 department is authorized, subject to approval by the State
- 24 Legislature, to purchase property, real or personal, to be used
- 25 for state park purposes.
- 26 (d) Contract with the Mississippi Transportation
- 27 Commission, any municipality or board of supervisors of the state

- 28 for locating, constructing and maintaining roads and other
- 29 improvements in state parks and for payment of a part of the costs
- 30 thereof; however, no county or municipality more than twenty-five
- 31 (25) miles distant from a state park may contract for, or do, or
- 32 pay for any such work for a state park other than the
- 33 International Gardens of Mississippi. Any county or municipality
- 34 authorized to assist financially under * * * Sections 55-3-31
- 35 through 55-3-51 is authorized, in the discretion of its respective
- 36 governing authority, to set aside, appropriate and expend monies
- 37 from the General Fund for the purpose of defraying such expense
- 38 after a mandatory election is held on the question within the
- 39 county or municipality.
- 40 (e) Designate employees as peace officers with power to
- 41 make arrests for infraction of the rules and regulations of the
- 42 department. Such officers are authorized to carry weapons and to
- 43 enforce the laws of the State of Mississippi within the confines
- 44 of a state park.
- 45 (f) Enforce and delegate the responsibility to enforce
- 46 all reasonable rules and regulations governing the occupancy and
- 47 use of lands and waters in state parks under its jurisdiction,
- 48 supply recreational and conservation facilities and charge fees
- 49 for the use of same; review all rates and charges for facilities
- 50 and accommodations furnished at the various state parks annually,
- 51 making such charges as are justified; and establish fees for
- 52 entrance to state parks. Persons sixty-five (65) years of age or
- older and disabled persons shall be exempt from entrance fees.
- 54 The park entrance fee for a car shall be waived if every person in
- 55 the car is sixty-five (65) years of age or older, or is disabled.
- 56 Each park shall retain from revenues generated therein, a sum
- 57 sufficient to pay necessary expenses of operation, but in no event
- 58 to be less than seventy-five percent (75%) of such revenues.
- 59 (2) The department shall have the authority to lease to any
- 60 entity, sell and convey or otherwise transfer to any county or

- 61 municipality, or close any state park or historical site within
- 62 its jurisdiction which received a General Fund subsidy in fiscal
- 63 year 1985 in excess of Two Dollars (\$2.00) per visitor to such
- 64 state park or historical site; provided, however, that this
- 65 authority shall not include the authority to sell, lease or convey
- 66 any park that was not in operation under the jurisdiction of the
- 67 department for a full fiscal year prior to fiscal year 1986.
- 68 (3) The department may execute agreements with
- 69 rails-to-trails and recreational districts by which the department
- 70 will assume responsibility for the operation and maintenance of
- 71 trails developed under Sections 55-25-1 through 55-25-15.
- 72 **SECTION 2.** This act shall take effect and be in force from
- 73 and after its passage.
