## SENATE BILL NO. 2276

- AN ACT TO AMEND SECTIONS 37-29-63 AND 37-29-67, MISSISSIPPI CODE OF 1972, TO CLARIFY THE APPLICATION OF THE AUTOMATIC REPEALER ON CERTAIN EMPLOYMENT PROCEDURES IN COMMUNITY/JUNIOR COLLEGE DISTRICTS; AND FOR RELATED PURPOSES.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 6 **SECTION 1.** Section 37-29-63, Mississippi Code of 1972, is
- 7 amended as follows:
- 8 37-29-63. (1) The president of any community/junior
- 9 college, or such other person designated or authorized by the
- 10 board of trustees, shall have the power to recommend to the board
- 11 of trustees all teachers to be employed in the district. This
- 12 subsection (1) shall stand repealed on July 1, 2006.
- 13  $\underline{(2)}$  The president may remove or suspend any member of the
- 14 faculty subject to the approval of the trustees. He shall be the
- 15 general manager of all fiscal and administrative affairs of the
- 16 district with full authority to select, direct, employ and
- 17 discharge any and all employees other than teachers; however, the
- 18 board may make provisions and establish policies for leave for
- 19 faculty members and other key personnel.
- 20 (3) The president shall have the authority, subject to the
- 21 provisions of Sections 37-29-1 through 37-29-273 and the approval
- 22 of the trustees, to arrange and survey courses of study, fix
- 23 schedules, and establish and enforce rules and discipline for the
- 24 governing of teachers and students. He shall be the general
- 25 custodian of the property of the district.

- SECTION 2. Section 37-29-67, Mississippi Code of 1972, is
- 28 amended as follows:

- 29 37-29-67. (1) The duties of the board of trustees shall be
- 30 the general government of the community/junior college and
- 31 directive of the administration thereof. Subject to the
- 32 provisions of Sections 37-29-1 through 37-29-273, the board shall
- 33 have full power to do all things necessary to the successful
- 34 operation of the district and the college or colleges or
- 35 attendance centers located therein to insure educational
- 36 advantages and opportunities to all the enrollees within the
- 37 district.
- 38 (2) The board of trustees shall be authorized to designate a
- 39 personnel supervisor or other person employed by the district to
- 40 recommend teachers and to transmit such recommendations to the
- 41 board of trustees; however, this authorization shall be restricted
- 42 to no more than two (2) positions for each employment period in
- 43 the district.
- This subsection (2) shall be repealed on July 1, 2006.
- 45 (3) The delineation and enumeration of the powers and
- 46 purposes set out in Sections 37-29-1 through 37-29-273 shall be
- 47 deemed to be supplemental and additional, and shall not be
- 48 construed to restrict the powers of the board of trustees of the
- 49 district or of any college located therein so as to deny to the
- 50 said district and the college or colleges therein the rights,
- 51 privileges, and powers previously authorized by statute.
- 52 (4) The board of trustees shall have the power to contract,
- on a shared-savings, lease or lease-purchase basis, for energy
- 54 efficiency services and/or equipment as prescribed in Section
- 55 31-7-14, not to exceed ten (10) years.
- 56 (5) The board of trustees shall be authorized with the
- 57 approval of the State Board for Community and Junior Colleges, to
- 58 change the name of the junior college to community college. The
- 59 State Board for Community and Junior Colleges shall establish
- 60 guidelines for the implementation of any junior college name
- 61 change. Any reference to junior college district in this chapter

- 62 shall hereinafter refer to the junior college district or its
- 63 successor in name as changed by the board of trustees.
- SECTION 3. This act shall take effect and be in force from
- 65 and after July 1, 2005.
